## 1. Public Hearing

Ordinance 2023-30 An Ordinance Authorizing the Manager to Advocate for and Provide Public Information Regarding the Need for a New City Hall, Including the Dissemination of Information That May Influence the Outcome of a Future Ballot Initiative.

This ordinance enables the Manager to advocate for a new City Hall project if the Assembly decides to put a ballot question before the voters this fall. \$50,000 for this purpose has been included in the FY24 budget. While CBJ regularly provides the public with nonpartisan information about upcoming ballot provisions, Alaska law requires the Assembly adopt an ordinance specifically authorizing the expenditure of funds if those funds are to be used to influence the outcome of an election. Threading the needle of delivering nonpartisan information versus information that might influence the outcome of an election is particularly challenging in this case; people may reasonably debate about the difference of facts and arguments in favor of a City Hall facility.

These funds would be used to produce and disseminate materials via direct mail, media, presentations to the community, and online.

The City Manager recommends the Assembly adopt this ordinance.

Layne 3 ORDINANCE OF THE CITY AND BOROUGH OF JUNEAU, ALASKA 4 Serial No. 2023-30 5 An Ordinance Authorizing the Manager to Advocate for and Provide Public 6 Information Regarding the Need for a New City Hall, Including the Dissemination of Information That May Influence the Outcome of a Future 7 Ballot Initiative. 8 WHEREAS, a new City Hall for the City and Borough of Juneau, Alaska (the "CBJ") is 9 needed to meet the current and future needs of the City and Borough of Juneau; and 10 WHEREAS, the Assembly has determined that the construction and equipping of a new City Hall is necessary in order to consolidate staff into a single facility; and 11 WHEREAS, under the Alaska Public Offices Commission disclosure and filing requirements. 12 AS 15.13.145(c)(2) permits the CBJ to provide the public with nonpartisan information about a 13 ballot proposition, however, AS 15.13.145(b) prohibits the CBJ from using funds to influence the outcome of an election concerning a ballot proposition unless the CBJ specially appropriates 14 the funds for that purpose by ordinance; and 15 WHEREAS, the Assembly appropriated \$50,000.00 of general funds for this purpose in the FY24 CBJ Operations budget ordinance, Ord. 2023-14, at its meeting on June 12, 2023. 16 THEREFORE BE IT ENACTED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, 17 ALASKA: 18 **Classification.** This ordinance is a noncode ordinance. Section 1. 19 Section 2. The Assembly authorizes the Manager to advocate for and provide public 20 information regarding the need for a new City Hall, including the dissemination of information that may influence the outcome of a future ballot initiative. 21 Section 3.
