Ms. Pemberton asked about the language used regarding 'Officer-Involved', noting that during her time as a journalist, when reporting out they shifted away from the term 'Officer-Involved' and instead used 'Officer'. Chief Bos responded that 'Officer Involved' is a legal term and staff would want to check with Law to see if it's ok to change the language.

Ms. Wright joined the meeting to answer some of the SRRC's questions.

Ms. Pemberton restated to Ms. Wright her question regarding the term officer-involved' vs. 'officer' and her suggestion to fellow SRRC members is to recommend the change to the Assembly to 'officer' in the ordinance.

Ms. Wright responded there's' not a legal reason for the wording noting that JPD policy uses the title Officer Involved Traumatic Incidents and was also a suggestion from the State because they use that wording. However, there is no legal requirement so the SRRC could make the word change suggestion.

April 29, 2025 Systemic Racism Review Committee

Mr. Froehlich suggested the SRRC recommend the Assembly have a timeline requirement for release of body cam footage even if the Chief of Police or the Manager protects public safety by a delay.

Ms. Patterson asked who determines what's considered serious physical injury.

Chief Bos responded that 'serious physical injury' is defined and pulled from state statues.

Mr. Froehlich applauded the city for putting forth an ordinance like this, noting that we want to limit exemptions as much as possible, there should be a timeline despite all exemptions and thirdly address the grammatical concerns brought forward by Ms. Pemberton.

<u>MOTION</u>: by Ms. Pemberton to forward Ordinance 2024-05(b) to the full Assembly for action with the following statement included: the SRRC appreciates the City and Assembly's efforts to put forth this ordinance; the SRRC urges the Assembly limit the number of exemptions included and allowed for the release of body cam footage. The SRRC further encourages the Assembly to implement a policy that requires timelines for release in all instances. The Committee has concerns about the use of the term officer-involved and recommends replacing it with officer. **Hearing no objection, motion passed.**

Mr. Froehlich discussed Ordinance 2024-01(b)(AL) An Ordinance Appropriating \$200,000 to the Manager for Contingency Federal Staffing Support Related to Tourism; Funding Provided by State Marine Passenger Fees. Longterm what does this mean and who are CBJ's partners?

Ms. Pierce responded that this is not intended to be a long-term fix. The United States Forest Service is working to regain revenues that are currently frozen. She gave an overview of what the CBJ and partner agencies are trying to coordinate.

Mr. Froehlich commented that when public lands get privatized the SRRC supports the local tribes having first right of refusal.

Ms. Pierce said they have been talking with the Federal Government and if they are looking at divesting of Mendenhall Glacier Recreation Area that CBJ or the Tribes would be involved in first right of refusal.

MOTION: by Mr. Nance to move Ordinance 2024-01(b)(AL) to the full Assembly for action. *Hearing no objection, motion passed.*

Systemic Racism Review Committee Recommendations Best Practices for Recruitment and Diversity Relating to CBJ Boards & Committees

- Have a current list of affinity groups that are always contacted directly with vacancies: Fil-Comm, Black Awareness Association, Haa Tooch Licheesh, ANS & ANB, SHI, etc.
- Post flyers at churches, restaurants, stores, community spaces where a wide swath of Juneau visits or that are specific to under-represented people on our boards and committees. Utilize the Juneau Arts & Humanities Council (JAHC) postering service.
- Write "juicy" social media posts that really say why someone would want to join. Include testimonials from board members. Maybe videos. Share those posts with the various local Facebooks groups such as, Juneau Community Collective.
- Run radio spots on KTOO and KINY -- they reach different and overlapping audiences in our community
- Once or twice a year, host "open house" meetings, where people are invited to see what
 we do be more intentional during those meetings about explaining what we do, what
 impact we have on the community, how we conduct our meetings, etc.
- Post on job boards for nonprofits/volunteers like Craigslist, Indeed, Alaska Municipal League, Foraker Group, UAS
- Use part of an assembly meeting or a separate town hall to introduce boards and committees with vacancies
- Is there a list of contacts for people who testify at assembly meetings? Maybe reach out to people who are signed up to testify and see if they want to serve on a board. If they had enough engagement to testify, maybe they want to help work on solutions.
- Create YouTube videos outlying "What it's like to be a boardmember" and other helpful information.
- Adding summaries of what each board or committee does, the time commitment, and
 what is expected of the board or committee to that board or committee webpage (f they
 have one) or the Board Portal that lists the Rosters and Charging Documents of each
 board and committee.
