Mr. Barr gave the committee an update on the most recent Assembly Finance Committee (AFC) meeting where the Assembly went through their Pending List and began moving some of those items forward. The AFC will meet again on May 22 to finish review of the Pending List. There is a Special Assembly meeting on June 3 for budget adoption. This is the SRRC's last meeting to review the ordinance and resolution that has been held in committee before it goes before the Assembly for adoption on June 3.

Mr. Drips noted that the SRRC's silence reflects that reviewing a CIP and budget for a municipality is a large lift for a group of untrained volunteers. We have opportunities to make comments as a committee so it makes sense for us to consider what we know as individuals, what we can agree on and say collectively.

Chair Nance asked for motions to move these pieces of legislation forward to the Assembly.

MOTION: by Mr. Drips to move Resolution 3052 to the full Assembly for action. *Hearing no objection, motion passed.*

MOTION: Ms. Patterson to move Ordinance 2024-01 to the full Assembly for action. *Hearing no objection, motion passed.*

J. STAFF REPORTS

This time of year, the Assembly Human Resources Committee reviews annual reports from the various Advisory Boards. Since the SRRC is reviewing boards and committees as a worksession topic, staff wanted to share the [5/13 HRC packet link](#) which has on its agenda the Parks & Recreation Annual Report as well as updates to the CBJ Board Information Pamphlet. If the SRRC is interested in getting these types of updates, staff will include links in the SRRC packet when Advisory Board annual reports are on an HRC agenda.

Ms. Cathcart gave an update on vacant seats on the Docks & Harbors Board, Airport Board, and Eaglecrest Board.

K. COMMITTEE MEMBER / ASSEMBLY LIAISON COMMENTS & QUESTIONS

The committee held a casual discussion around boards and committees, how do you get the community involved. Would combining similar boards into one help with quorum issues or a stipend for board members. Moving back to in-person meetings or hybrid, would that encourage citizens to apply.

Mr. Barr commented on the on-going challenge to fill board seats and staff capacity to support those boards. Most boards don't get the staff support that the SRRRC gets. Depending on what the current Assembly priorities and goals are, boards that work within those priorities see more staff support to help move those goals forward.

Ms. Patterson noted the SRRRC had agreed to have boards and commissions as the first topic for standing agenda items to take a deeper look at during a worksession.

Ms. Cathcart let the committee know standing agenda topics would be placed back on the agenda for future meetings and had gotten overlooked when pulling this agenda together.

With poor internet connectivity and members getting dropped from Zoom it was agreed to hold this discussion later. Ms. Patterson noted the SRRRC had agreed to have boards and commissions as the first topic for standing agenda items to take a deeper look at during a worksession.
