# G. INFORMATIONAL ITEMS

- 2. Summary of May 25, 2023, meeting by Ms. Hale
  - a. 2023 Goals for Joint Assembly/School Facilities Committee
- Ms. Hale At last meeting, this committee reviewed and approved committee goals. As a result, a change was made to state repurposing space 'could include childcare'. The committee discussed the funding formula, the effects of consolidation, the variables of the matrix, the six-year CIP plan.
- 3. May 25th Follow up Ms. Koester summarized the answers to the questions the committee had at the last meeting.

Ms. Koester – introduced memo summarizing questions from the May 25 meeting.

- According to Fire Marshal, occupancy totals will not be changed with the other code changes
- Marie Drake and Mendenhall River renovation details are included in a memo from administrative services director Olin
- Facilities master plan from 2017 will be valuable for planning going forward. The document is called CBJ/JSD Facility Master Plan. It was never officially adopted by the committee. Therefore, it is not available online.

- Ms. Olin presented the Marie Drake and Mendenhall Hall River schools renewal and replacement schedule from the Department of Education and described the projects identified in the memo.
- 4. Draft School Facilities Evaluation Matrix Ms. Koester presented the draft matrix and the committee worked together through the matrix.

Section 1 – Approved Variables Incorporated into the Draft Matrix

- Quantitative
  - Enrollment vs Capacity Capacity is defined according to Fire Marshal. DEED determines enrollment capacity based on school construction funding allocation methodology.

Ms. Gladziszweski – how is the UBC determined? Does it take into consideration a classroom that is used for some but not all hours of a school day?

Ms. Olin – The UBC is used in determining the maximum capacity for fire safety.

 Capital Cost of Renovations – Ms. Koester asked for feedback on what level of detail needed. The memo provides cost figures based on the JDS 6-year CIP report.

Ms. Woll – Her understanding of the goal of the matrix is to provide information to be used 'someday'. From that perspective, it is helpful to use numbers that are readily available.

School Size and Impact on Funding Formula –

Ms. Gladziszweski – Noticed the cost for closing a school was listed twice in the matrix and asked if that meant closing one high school would incur \$900,000+ for each of the schools or would it be that amount once. It would be a single \$900K+ incurred.

 Maintenance and Operations (M&O) – This is the possible savings in M&O if schools consolidated.

Ms. Koester – Recommends looking at this component from an order of magnitude perspective. (i.e., older buildings cost more to maintain.)

Mr. Holst – Suggested including a Likert scale to rate facilities to illustrate how well a school performs or the energy efficiency of a building.

- Qualitative
  - Operational Use, Special Services reflects the classrooms reserved for special education and related services
  - Operational Use, Classrooms used for Instruction reflects number of classroom considered instructional for budget purposes

Ms. Gladziszweski – Does the percentage used for this category come from an actual count of classrooms or simply a percentage?

Ms. Olin – A count is taken but not all educational rooms are classrooms. Principal's office, and some other rooms are also considered instructional because the purpose of the room is for instruction.

Ms. Gladziszweski - requested a count of actual classrooms in the district.

Ms. Koester - Would the committee like to also have student/teacher ratio information?

Ms. Hale – Not needed.

- Mr. Holst Including demographic information on diversity would also be helpful/important
  - Impact on Quality of Education –

Ms. Koester – Asked for feedback regarding what the committee wants to see included in this item.

Impact to the Neighborhood – What impact does a school/school closure have on a community.

Ms. Hale - The Auke Bay school is the only City facility besides the fire stations at that end of town. Glacier Valley is centrally located and has been there for so long that it has become important to that area.

The purpose of this memo is to continue the committee work on establishing matrix variables for the evaluation of school facilities. A key with these definitions will accompany the matrix. Variables with a \* have been added or changed since the last meeting based on committee input.

# **Quantitative**

This section reflects numbers and metrics that can be used in analysis. The definitions below attempt to help provide narrative and context to the figures.

# Enrollment versus capacity (as a percentage).

This category reflects how many students are enrolled in the school versus the capacity according to the Uniform Building Code.

**Capital Cost of Renovations**: This figure was pulled directly from the JSD 6-year CIP. The 6-year CIP is based on the renewal and replacement schedule submitted to DEED annually. It is not a comprehensive condition assessment.

**School size and impact on funding formula**: This figure reflects the annual loss in state funding after a four-year step down. It is based on FY23 enrollment and will change annually.

\***Pupil teacher ratio:** The pupil teacher ratio is set by the Board of Education annually and varies by grade level.

\*Highschool Graduation Rate: The high school graduation rate divides the number of graduating seniors by the total enrollment of freshman four year prior. Also referred to as a completion ratio. Information is only readily available for high school students.

\***Predicted future enrollment by grade level:** This category uses state demographer data to predict how many students will be enrolled in that grade level based on historical information.

\***Demographic Diversity:** This category captures ethnic diversity and number of students qualifying for free and reduced lunch.

\*Maintenance and Operations (non-instructional): This figure reflects the maintenance and operations line item in the JSD budget for this facility. If this facility is consolidated into another, some, but not all of those expenses will be transferred to the new facility.

# **Qualitative**

This category helps decisionmakers think about the variables that are more difficult to measure but no less important. 'Operational Use' is broken out into 3 separate metrics. Some of these uses are determined by the Pupil Teacher Ratio set by the Board of Education each year, others are determined on the number of students identified with special needs and the federal regulations associated, and others are set by which special programs are housed at individual school sites.<sup>i</sup>

**Special Services:** Schools serve programmatic and educational needs and buildings are used for special education classroom use, related services (OT/PT, SLP, School Psychologist) needs, small group instruction, etc. This category reflects the classrooms reserved for those purposes.

**Classrooms used for Instruction**: Outstanding work: Staff needs to present a revised definition of instructional use that meets the committee's intent of how often a classroom is used for student instruction throughout the day.

**Cultural Impact:** Often a school has a strong identity and sense of place; students, faculty, teachers and community members develop a culture rooted in the facility and what it represents. Any changes need to be considered the cultural impact.

**Impact on Quality of Education:** Speaks to the JSD mission statement "In Juneau, we partner to provide each student with meaningful, relevant, and rigorous learning experiences in order to graduate diverse, engaged citizens ready for a changing world."

**Impact to the Neighborhood:** School facilities are often used outside the school day and are key gathering spaces for community functions. What impact would repurposing a facility have on those uses?

# **Opportunities**

Alternative Facility Needs: This reflects alternative facility needs in the community this facility could serve.

**Can it be Repurposed and at what cost?:** This figure reflects the cost of reconfiguring a building to meet an identified community need.

# **Recommendation:**

Discuss, provide amendments or recommendations to be incorporated in a future draft matrix.

<sup>&</sup>lt;sup>i</sup> The committee discussed using a Likert scale, or similar tool, to help provide numbers to the qualitative variables. A Likert scale is a rating scale used to measure opinions, attitudes, or behaviors. It is commonly used in survey research, marketing and social sciences. Using a 5-point quality scale as an example, "how would you rate this variable on a scale of 1-5: 1. Very poor, 2. Poor, 3. Sometimes, 4. Often, 5. Always. If the committee would like to apply numbers to the qualitive factors, thought will need to go into the most strategic way to make that meaningful.

SUBJECT:	CBJ and JSD Investment in Maintenance

The purpose of this memo is to provide the committee with an overview of the annual dollars spent on both major maintenance (CBJ) and operational maintenance (JSD).

The attached spreadsheet shows a list of JSD projects from 2017- current. These are projects managed by CBJ Engineering, in consultation with JSD administration and maintenance. As you can see, over the last 5 plus years, almost 12 million dollars of maintenance projects have been accomplished or are underway. This represents the annual deferred maintenance funds the CBJ Assembly appropriates to JSD projects in the CIP (traditionally \$1M) and larger named projects like the three school roofs that were part of a bond package.

JSD will provide maintenance budget information as a supplemental item.

According to CBJ Charter Section 13.9, "The board, unless specifically transferring such responsibilities to the assembly, shall provide custodial services and routine maintenance for school buildings and shall provide employees for these purposes. The assembly shall provide major maintenance and all rehabilitation, repair and construction of school buildings." However, there may be some efficiencies worth exploring in combining CBJ and JSD building maintenance functions.

**Requested Action:** Discuss and provide staff direction on additional information needed regarding facility maintenance.

# **Regular Attendance is Crucial**

- Students can earn a semester credit (.5) for each class in a quarter in core classes - a total of 10+credits/year.
- Students who miss over 5 days of class may be dropped from a class and lose credit for the quarter. This requirement varies depending on the type of class.

# Why have an advisor?


# STUDY HALL

# Earning credit outside of the school building

SUBJECT:	Draft CBJ JSD Facility Master Plan

The purpose of this memo is to re-introduce the committee to the Draft Summary of Findings for the <u>CBJ JSD Facility Master plan</u>. In 2015, CBJ contracted with Jensen Yorba Lott (now Jensen Yorba Wall), to "provide research and information to form the basis of a comprehensive facility master plan slated to be completed in a subsequent phase of work" (Executive Summary, p.1).

The Draft Master plan is full of information that will be useful to the committee. For example, it develops a matrix that looks at the long term viability of the each facility taking into account age, educational adequacy, and energy efficiency of Schools (p. 72). Similarly, there is an Educational Adequacy assessment of each facility that looks at six categories including classroom learning environment, safety and security, and building community (p.205).

However, the Draft Master plan was never adopted. From what I gather researching the public record, the committee reviewed the Draft at their June 14, 2017, meeting. At the September 8, 2017, meeting they discussed recommendations from the Board of Education and questions from the consultant necessary to proceed with their work (see attached memos). At the December 13, 2017 meeting the Committee discussed the recommendations and directed staff to write and a summary memo and action plan and distribute to the committee members who can then decide if they would like to meet again. There is no record of a Joint Facilities Committee meeting until April 18, 2019, where this topic is not discussed.

Committee members should spend some time reviewing this plan and decide how to use the information presented. It may be as simple as using the document as inspiration to develop additional matrix criteria. Or the committee may want to update the plan with the goal of formally adopting it.

**Requested Action:** Discuss and provide staff direction on how to incorporate the Draft CBJ JSD Facility Master Plan into future committee meetings.



# Children's House



The Children's House is a multiage (ages 3, 4, and 5) classroom with younger children joining the community of learners for a threeyear period. Parents and teacher form a strong partnership and a community network of families to support each

other and the development of their children.

The Children's House stimulates the development of executive functions: independence, self-motivation, self-direction, and self-control; the development of social skills and interpersonal communication; and a sense of community in a diverse, small learning environment. The curriculum provides early literacy with a strong emphasis on language development, which is an indicator of later success. It also provides early exposure to math, and place-based science, art, and culture, emphasizing the development of the senses. It is ideal for English Language Learners (ELL), since sensorial experiences precede language.

# Montessori Elementary

The elementary classrooms are multi-grade (1/2/3 and 4/5/6) and children generally remain with the same teacher for three years. This gives teachers and families an opportunity to get to know each other well, develop community, and work together from one year to the next.

The day is organized around an uninterrupted 3-hour "Great Period", during which children focus on academic subjects. Children plan and select their work and the order in which their work will be done, while the teacher provides guidance and presents lessons. Children as young as 1st grade are encouraged to research subjects that interest them. Depending on the subject and the child, the result of this exploration may take the form of a research paper, map, poster, science experiment, art or other project. P.E., recess, silent reading, and other aspects of the elementary school day are scheduled after the Great Period. Lunch is eaten family-style in the classroom. Art, drama, vocal and instrumental music are integrated into the child's day.

The elementary community is designed so children can work with those who are older and younger. Children have the opportunity to be leaders and followers, to both teach and learn, and to socialize with children of different ages.

# Montessori Middle School

The Adolescent Montessori Program (grades 7-8) emphasizes academics, social responsibility, and service to the community. AMP provides a small and supportive setting in which students can attain personal independence through academic choice, social respons



choice, social responsibility, and service to the community. In this environment, students feel secure enough to risk being different

students feel secure enough to nsk being differen and to consider unfamiliar points of view. Basic to advanced math and literature are taught

Basic to advanced math and literature are taught daily, while science, history and geography are covered in intensive blocks to allow for in-depth exploration and learning. Classes in Spanish, art, music, and P.E. round out the curriculum. AMP provides a supportive community where students know they are respected and cared for, where they can challenge themselves through hard work, grow responsibly, and build meaningful relationships with peers and teachers.

Joann Lott then presented information on boundaries and housing development. There was discussion about best use of schools and about future changes in areas of student density.

There was discussion about the information presented and what priorities the plan should address. It was mentioned that phase one was data collection and phase two will be more about options.

There was much discussion on the areas of enrollment, capacity and efficiencies and the idea of combining grade levels or programs. There are other options to consider before closing a school.

There was also discussion about good vs. okay facilities tying to performance of students. Karen Montovino shared that important items are daylighting, relationships/collaboration spaces, and after-school support.

Information was presented about boundaries and housing development. There was discussion about enrollment projections and change in number of students by elementary and secondary grade levels.



- 2. Identify options for incorporating Charter School into JSD facilities;

4. Recommend changes in use of facilities around the district to more optimally match programs with facilities and provide a cost estimate for moving
