- Land Acknowledgement at 12:04pm
- Public comment introductions of all present
- Agenda item: artificial turf for parks & rec locations
 - Dianna: CBJ did some risk assessment of risk of contamination from artificial turf in response to concerns about PFAS content of artificial turf
 - There is risk of contamination, but not any more than other buildings / clothing / environment
 - Nick: It is a potential source of PFAS contamination, but we have bigger fish to fry
 if we want to tackle this issue. The particular product we're looking at unless
 you're living on these fields, it's not going to be a major source of contamination
 for you. Issues with other products (not the one being used in Juneau) have
 presented larger risks, but we're not using those.
 - Dianna: any further questions, send them to me and/or Michele Elfers, parks & rec. The major pathway for PFAS to enter the body is through drinking water.
- Agenda item: Construction industry waste
 - Nick: I reached out to SEAK Construction Industry Association, an industry consortium. My pitch was that JCOS is looking at reducing what goes into our landfill, particularly demo/construction. Received a positive but guarded response, they will talk about it at their next meeting and attend one of our future meetings
 - Nick references Talking Trash meeting, recording: https://www.youtube.com/watch?v=iEn16EoQn6U
 - Jessie: Do you have a sense of whether it's bigger because it's higher volume? how much room is there for reduction?
 - Dianna: Several avenues to explore. C&D waste is about 20% of our waste stream. Landfill is a willing partner in finding ways to reduce, reuse.
 - Marian: how do we begin outreach to engage the private sector in the reuse portion of this? Seed the idea of the need for a ReStore?
 - Dianna: we're convening a stakeholder group as part of our zero waste plan.
 People to engage might be Chamber of Commerce, DBA, potentially JEDC
- Agenda item: Juneau Composts & future of composting

- Juneau Composts, local business, is already engaged in composting. CBJ Salso recently received funding for a facility, and is figuring out how to design it
- Lisa: I've been operating since 2017, food scraps and yard debris, also distributing garden supplies to community as product. CBJ is our landlord, the owner of the unpaved property where we're located. Now entire business is at a standstill due to uncertainty, because the city can't guarantee I'll be the operator due to RFP process. I'm interested in whether the RFP process can happen now, before the facility is designed, so that whoever gets the contract can plan for the future and prepare to engage the facility as it is. The main point is that composting continues to happen in the city I'm at the point of taking no new customers and potentially shutting down if there's no future for the business, if I can't invest in heavy equipment.
- Lisa: Talking Trash session (linked above) had some issues. If we want to know more about how to divert from the landfill, it's important to ask DNC Recycling (Valley), Skookum, Juneau Recycling, asking people already engaged in diversion
- Dianna: Talking Trash was requested by assembly and questions came from assembly, hopefully there will be more and we can share out more of the story.
 We have the power to work on more Talking Trash events and can continue the conversation.
- Marian: what autonomy does CBJ have when it comes to the timing on the RFP?
- Dianna: procurement is a huge complex process and the people in procurement have been historically fairly conservative. That said, the Assembly may have some authority over the process and could make it possible to do things differently if they wanted to. But procurement process would be the hurdle. We're looking at models of public/private partnership and trying to find a model for success, Lisa is aware of several failed attempts.
- Nick: could there be more than one facility for diversion, with food grade / non-food grade output, ie for road grade etc? w bio-solids for example?
- Lisa: that seems unlikely, what would be added to the compost that would make it non-food grade? as a composter I wouldn't want to rehydrate bio-solids, so all my compost is food grade, and there is no advantage to pursuing a non-food-grade
- Zach: our solid waste can be dried for disposal but it's essentially just dry sewage, so when it re-enters a wet environment (like the landfill) it rehydrates and microbes create methane. There's also PFAS contamination in sewages solids (not as high as elsewhere, but still very present). So plans to dispose of dried sewage solids that way were scrapped, now they are shipped to a landfill in Oregon. So it's allowable to use it in compost, but a problem to use since it produces so much methane and contains PFAS. CBJ has been looking into other options, including the option of fully composting sewage, which is quite a different process. I don't know that it would make sense to attempt to merge solid waste and compost processes at this time.
- Dianna: we ship biosolids out at \$600/ton, we purchased the drier to make shipping safer, but at the time there were thoughts it could help with other waste
 but it's not suitable to blend w compost solutions.
- Marian: Lisa, what would be indicators to you that progress would be happening?
- Lisa: moving towards an RFP now would be helpful I'm aware the city can't favor my business, but the risk here is that composting vanishes completely for a few years if I close before the new facility can work. I personally wish businesses

like mine were able to get the funding instead of the muni government, but private sector really isn't eligible for that. In other states, grants are made directly from states and munis to compost businesses. The state of AK doesn't have any vehicles for this to happen. Waiting in limbo for this to happen is terrible – I'm considering closing my business down.

- Nick: next steps what recommendations JCOS might want to put forward to the assembly. We might have to come up with a resolution as a full body.
- The subcommittee will reconvene May 23rd and spend time on a work session drafting language to share with JCOS to move us towards a resolution on the matter of composting and this important community issue. Will read some resources and references in the meantime.
- Next subcommittee meeting:
 - o discuss construction waste if the industry can get back to us
 - work on compost RFP question and potential resolution language to bring to JCOS
 - o discuss Dianna's work on food waste mitigation / diversion

 JCOS
 - Duff: this is a matter worth consideration by HR / the assembly
 - What would the award be? Jim: a certificate (people get tired of plaques), to be awarded at a major event in Juneau, Earth Day or perhaps Innovation Summit
- Marian: what is JCOS' role versus the city's role? There's a lot of hours of work in this project, design and administration plus subcommittee doing the awarding
- Jim: I'd like this to happen organically, start small and let it grow, it could be mostly volunteer JCOS has the passion
- Marian: CBJ has an interest in these being branded for the city and being a long-term project, for the city to know their involvement level up front will help them anticipate what saying yes to awards means
- Duff shares some examples of existing websites for awards for <u>King County</u> and <u>Port of Seattle</u>, mentions we need comprehensive contacts / promotional plan
- Gretchen: we should come up with a clear idea of how much work is entailed and who's going to do it to present that to HR
- Marian: to know what the Outreach subcommittee's role will be, we'll need to think through the actual steps of taking this project from abstract to concrete
- Jim and Marian decide to work together on breaking down the different steps of the project and thinking through which ones would be the work of the city, which would be JCOS or volunteer work

JUNEAU COMMISSION ON SUSTAINABILITY ANNUAL REPORT JUNE 2022 - MAY 2023

I. INTRODUCTION

The Juneau Commission on Sustainability (JCOS) continued to be engaged and productive this past year. The Commission's work is typically researched and drafted by its committees, and the full Commission conducted 11 regular monthly meetings, numerous work sessions, two special meetings, and a December 2022 annual retreat.

The JCOS charter, and resolutions for the *Juneau Climate Action & Implementation Plan* (2011) and *Juneau Renewable Energy Strategy* (2018), identify its duties:

- 1. promotion of sustainability in the community,
- 2. recommendations to the Assembly and other boards and commissions on policies and programs,
- 3. research and applying for grants,
- 4. advising CBJ staff on GHG emission reductions, and
- 5. acting as a liaison between the community and Assembly on sustainability-related issues.

Sustainability, as defined in JCOS's charter, encompasses economic, social, environmental, and local government components.

II. HIGHLIGHTS – JCOS Governance, Priorities, Accomplishments and Pending Work

A. GOVERNANCE

The Commission experienced considerable turnover in membership in 2022, with former members moving on because of business and work commitments, personal health, and graduate school. Remaining members provided orientation sessions, 1:1 guidance, and led an abbreviated work load while new members came up to speed. The commission's December 2022 retreat provided new members the opportunity to step into committee and leadership roles.

In 2023, the Commission established a consistent day/week schedule for JCOS subcommittee work sessions, in order to optimize Eng/PW liaison support and in recognition of staff workloads.

B. PRIORITY - ENERGY

1. <u>Implementation of the Juneau Climate Action Plan and the Juneau Renewable Energy</u>
Strategy

a. JCOS Actions

- actively engaged with CBJ staff to monitor and advocate for energy-related components in CBJ projects.
- actively participated with E&PW Dept on the contract with Dynamhex (now Constellation) to obtain an updated *Juneau Energy Use & GHG Inventory* for 2021.
 Conducted three review sessions of report drafts with the consultant at JCOS meetings.
- provided specific sustainability recommendations to the Assembly for its annual retreat goals-setting.
- prepared for the Assembly a JCOS Report: Juneau's Climate Action and Sustainability
 & Proposed Action Plan (December 2022). The report
 - summarizes the actions undertaken in the community over the 5 years since JRES was adopted;
 - o offers JCOS recommendations on "next steps" moving forward; and
 - o identifies 40+ potential clean energy/climate action funding opportunities in the federal Bipartisan Infrastructure Law and Inflation Reduction Act.

b. Pending Work

• make a presentation at 6/5/23 Assembly COW on the 2021 Energy/GHG Inventory analysis, recent/current actions, and recommended next steps to meet the community's GHG emission and renewable energy goals.

2. Transportation

a. JCOS Actions: Juneau Dock Electrification

- Provided input to CBJ Docks & Harbors that was incorporated into CBJ comments submitted to EPA which sought public feedback on how to structure a new grant program. The program, directed at reducing air pollution in ports, may be a potential funding source for dock electrification in Juneau.
- Recommended the use of Marine Passenger Fees (MPFs) in 2023 for several projects:
 - prepare bid-ready engineering/design and environmental permitting and order the two load tap transformers for the 16B docks electrification;
 - conduct a beneficial electrification impact analysis with 3rd party consulting services to assess and evaluate alternative approaches and CBJ investments

- in the downtown/port area electrical infrastructure; and
- provide local matching funds for a federal grant application in 2023 for downtown electric bus circulators.
- Recommended 16B Dock Electrification as a community project for CBJ's 2023 Legislative Priorities list.

b. JCOS Actions: Electric Vehicles

- advocated to use MPFs for local matching funds to a federal FTA Low No grant application for downtown electric bus circulators (which was not pursued in the 2023 grant cycle).
- actively monitored the Alaska Energy Authority's (AEA) development of the State of Alaska's EV Plan, a requirement to receive substantial federal Bipartisan Infrastructure Law funding. Participated in a summer 2022 AEA workshop to represent Juneau/SE Alaska input.
- engaged with the Juneau International Airport (JIA) manager to determine and recommend how the JIA parking lot improvements in 2023 include EV charging stations. This follows up on JIA's commitment for EV chargers as part of JCOS's waiver of airport LEED requirements in 2019.

c. JCOS Pending Work

- continue to monitor the State's allocation of federal EV funds through AEA.
- assist CBJ staff on grant applications for EV program funding.

Space Heating

a. JCOS Action: Financing for Commercial Building Energy Efficiency Upgrades

 conducted background research and education of commission members about C-PACE (Commercial-Property Assessed Clean Energy) financing for upgrades to multifamily housing and other commercial buildings.

b. JCOS Pending Work

 Advocate for and assist in an examination of potential CBJ participation in clean energy financing and identify federal funding opportunities and requirements.

4. <u>CBJ Energy Management</u>

a. JCOS Actions: Energy Use in CBJ Facilities

- engaged with CBJ staff on energy efficiency components to renovations to Centennial Hall and new construction at Bartlett Regional Hospital.
- received an update and applauded CBJ Facility Maintenance staff actions to track

energy data and establish separate billing records for approx. 600 CBJ facilities.

b. JCOS Pending Work

• offered to work with CBJ staff to re-examine the 2011 LEED ordinance and current "green" building certification programs.

C. PRIORITY - SOLID WASTE

a. JCOS Actions

- toured the City of Whitehorse waste management facility and met with staff (June 2022) to consider successes/failures of the City's waste planning.
- re-established a Solid Waste Committee of JCOS.
- recommended the municipal composting facility design and construction as a project to be included in the CBJ's 2023 Legislative Priorities list.
- Attended the "Talking Trash" public meeting in April 2023 organized by Eng & PW staff and Assembly PWFC.
- Provided a letter of support for a CBJ grant application to EPA for funding to augment the congressional grant for a municipal composting facility.

b. JCOS Pending Work

 present a memo to the Assembly PWFC regarding CBJ's approach to seek consulting services for design/build/operations of a municipal composting facility.

D. PRIORITY - OUTREACH

1. Public Education and Community Awareness

a. JCOS Actions

- conducted a JCOS Sustainability Session in May 2023 on the public review draft of the 2021 Juneau Energy Use and GHG Emissions Inventory.
- drafted for the mayor two energy-related proclamations
 - Juneau Participation in the National Drive Electric Week EV Road Rally (September 2022) and
 - Earth Day/Litter Free (April 2023).
- maintained a website under the CBJ/Eng& PW website and also has a Facebook page.
 Sustainability sessions are recorded and posted, as are JCOS reports, meeting minutes, and useful articles.

2. Collaboration with AK municipalities

a. JCOS Actions

- regularly participated in bimonthly meetings of the Alaska Municipal Climate Network of local elected officials, staff, and advocates around the state to share information and actions. Presented an overview of JCOS duties, procedures, and actions in February 2023.
- Met with members of the newly established Sitka Sustainability Commission in March 2023 and provided information about JCOS governance, duties, priorities, and procedural approaches.

b. JCOS Pending Work

 consider an initiative and investigate work tasks to present to the Assembly the concept of a Sustainability Award to honor an individual, organization, business or agency that takes substantial action to further Juneau's sustainability and resilience.

E. PRIORITY - CLIMATE IMPACTS/SUSTAINABILITY INDICATORS

a. JCOS Action

 Presented the Juneau Climate Impacts Report, a collaborative effort by UAF and UAS scientists and others, to the Assembly (July 2022).

b. JCOS Pending Work

 develop sustainability indicators/metrics as part of a CBJ Comprehensive Plan update.

III. OVERVIEW OF JCOS

The Juneau Commission on Sustainability, established by the Assembly in 2007, researches and advises the CBJ on community sustainability. The Commission's mission is to promote the economic, social, environmental, and governmental well-being of Juneau and all its inhabitants, now and in the future.

Membership

The 11-member Commission includes nine public members appointed by the Assembly, and one non-voting member each of the Assembly and the Planning Commission. In June 2022, the Commission liaison support switched from CDD to Eng&PW staff to be better aligned with most of JCOS work priorities. ATTACHMENT 1: History of the Juneau Commission on Sustainability

The governing legislation for the Juneau Commission on Sustainability is CBJ Resolution 2401am, July 9, 2007. The policy and purpose of the Commission incorporated the mission of the former Juneau Energy Advisory Committee, which was also repealed by Resolution 2401am. The Commission's 2010 sunset date was removed by CBJ Resolution 2528, May 19, 2010.

The membership structure of the Commission was altered in 2015. Resolution 2755; February 5, 2015 renewed the Commission and repealed an earlier Resolution 2718. The Planning Commission and Assembly Liaison members are now non-voting members and do not count towards a quorum.

Subject: JCOS recommendations on composing facility contracting process

The future municipal composing facility is an exciting development and JCOS fully supports the City's efforts to increase the scale and efficiency of composting services as a means to divert waste from the landfill and recover valuable resources. However, the promise of this facility in the near future is creating financial uncertainty for the one business which currently offers commercial composting services in Juneau. To support the continuity of compost services in a way that is fair and business-friendly, JCOS recommends launching a competitive bid process for compost facility operations prior to the facility actually being operational.

Background

- JCOS is invested in supporting continued and expanded composting services in Juneau because composting is a far more sustainable means of food waste disposal than landfilling. Benefits include:
 - o Diverting waste from the landfill, which has limited remaining capacity.
 - o Reducing greenhouse gas emissions by processing organics in an aerobic environment, where carbon is emitted as CO₂ rather than methane, a much more potent greenhouse gas which is generated in anaerobic landfills.
 - Produces valuable compost for Juneau's gardeners, reducing the need to ship bulky compost in from out of state or produce and ship chemical fertilizers.
- Juneau has a single commercial composting business, Juneau Composts, which has diverted approximately 1.5 million pounds of food waste since 2017.
- The owner of Juneau Composts has testified to JCOS' Solid Waste Subcommittee that if another
 business is selected as the operator of the new City facility, it will most likely put her out of
 business.
- This uncertainty reduces Juneau Composts' ability to invest in maintenance and upgrades to their current facilities and equipment, possibly leading to a situation where it does not make sense to continue operations, even before the new facility opens.

Proposal

- JCOS recommends the City issue a request for proposals (RFP) and sign a contract as early as possible in the pre-planning and design process for a contractor to both:
 - advise on the design of the new facility;
 - o be its first operator when it comes online.
- The contract with both the advisor/initial operator and the facility designer should specify a flexible design, to avoid the creation of a facility that only one operator could use in the future.
- The contract should include optional tasks and contingency language to avoid committing public funds to paying for operation services prior to the facility being operational.

Benefits

- The City gains a design advisor with a vested interest in the success of the facility.
- Establish a predictable business environment.
- Ensure the facility is ready to begin operations as soon as it is completed instead of having to go through an additional competitive bid process once it is built.
- If the existing local business is selected, awarding the contract early ensures a continuity of service and retention of local expertise between now and the opening of the new facility.
 - No other operator is likely to or able to replace this one before the new compost facility is completed and open for use in a few years. The premature loss of this private operator effectively means that mid-scale composting services for the public would cease for several years.
- If a different business wins the contract, the longer lead time gives them an opportunity to prepare for operations concurrently with the design and construction of the facility.

Drawbacks

- If a business other than Juneau Composts wins the contract, there is a possibility that this course of action may lead Juneau Composts to wind down their operations earlier. This would be a loss for sustainability in Juneau, but one which also may occur if the City follows the default option of waiting to issue the contract.
- If there are construction delays, the facility may not be operational within the span of this contract, reducing the benefits of this proposal and expending unneccesary effort and money on the procurement process.
 - Careful writing of the contract can ensure that public funds are not committed to tasks which are not needed.

Overall, JCOS believes that the benefits outweigh the drawbacks. If the existing local small business wins the contract and this added certainty allows it to stay in business and continue providing services in the interim, the City's sustainability goals are served greatly by the continued waste diversion and composting. If another business wins the contract then an answer is known and all parties can plan appropriately for the new facility.



















2021 Energy Use & Greenhouse Gas Emissions Inventory for Juneau, Alaska DRAFT • Public Review until June 16, 2023

Total Juneau GHG emissions






Community wide Energy (MMBtu)

Community wide Emissions (MT CO₂e)




