#### D. APPROVAL OF MINUTES:

January 10, 2023, Draft Minutes of the Juneau Local Emergency Planning Committee – approved
unanimously with the addition of language we could not here on the zoom recording for Item F. Staff
Reports. Elected Official Paul Kelly reported the assembly had a relatively light meeting month. Monday's
assembly meeting voted to update the Hazard Maps and review/remove some rockslide areas. Tom
asked Paul to elaborate more on the Planning Commission efforts to address a recent request by a
resident to seek redesignation for a rockslide area for construction. Paul reported that during the
December LEPC meeting he mentioned that at the December Assembly meeting they passed the new
maps that deal with landslides and hazard zones.

# MEDICAL COUNTERMEASURES: POINT OF DISPENSING (POD), PLANNING, AND RESPONSE

MGT-319
