Director Kittel went over the status of the existing RACK Programs. In general, Renew Kaukauna is about halfway through its existing funds. To be able to ensure that more properties are able to take advantage of this program some concepts were discussed on how to retool the program. Some options are to apply for grant money with the Wisconsin Economic

Development Corporation, request additional money from the city, change the program to be only a partially forgivable loan and investigate using TID monies. The discussion also included some updates to both Renew Kaukauna and the Revolving Loan fund to provided greater clarity on what the group is looking for. The Revolving Loan Fund currently does not have a cap which is something the group would like to re look upon. Lastly Director Kittel recommends creating a design guideline for the downtown to better assist the property owners in what the Redevelopment Authority would like to see as well as helping those who would like to update their facade but do not know where to start. Director Kittel will start to bring items back to RACK for additional discussion and action on funding, program language and a design guide.
