PUBLIC APPEARANCES

Matt Wallace – 901 Sullivan Ave., Kaukauna – employee of the City of Kaukauna in the Street Department for over 9 years spoke. The City of Kaukauna Street Department jobs are not as coveted as they once were. He feels the wages are the reason for this. As the City Street Department continues to work with an aging and retiring force, making them a highly paid department for the area would ensure that the City will continue to get qualified new employees as well as maintain the experience of the existing crew.

Ald. Moore thanked Matt Wallace for his comments. He thanked the City Street Department for all their work as dedicated employees. The Council thoroughly went through the Wage Study and have made changes that are appropriate to the wages at this time. Comparisons were made to make changes throughout the entire wage scale.

He received many nominations and ultimately won the award. Presentation of the award will take place on Saturday, December 10 in the City Council Chambers at 11:00 am. Council President Moore was thanked for nominating Mr. Weaver and giving vital information in order for Mike to receive the award.

Public Hearing for 1875-2022 An Ordinance Creating Section 17.52 Landscaping Requirements. Planner Stephenson provided information on the changes to the ordinance. Staff put this together as minimum landscape requirements to be used on new buildings for commercial and multi-family industrial and institutional uses.

Bid Tabulation was provided. Carl Bowers and Sons Construction was the low bidder with total base bid of \$340.946.60.

a. Bayorgeon Hardball Concession Remodel.

Street Superintendent Van Gompel stated Kaukauna Youth Baseball (KYB) would like approval from the Board of Public Works for a remodel project in the concession area at the hardball diamond. The concession area has electrical from an old security system that should be removed, paneling on interior and exterior walls that needs replacing to discover where the mice are entering the building and to remove panels that are deteriorating from the bottom, old locker closets that are no longer a good use of the space, and outdated cabinets and countertops. KYB is not requesting financial contribution from the City for new material or labor costs associated with the project. KYB is requesting that the City pay for costs associated with the disposal of removed building materials. KYB would like to have the Street Department deliver dumpsters and service them throughout the project. KYB will fill out the standard volunteer service agreement form, provide a certificate of insurance, and will work with the Inspection Department to obtain any required permits. Photos of the site areas were provided and questions from the Board were answered.

Motion by Kilgas, seconded by Schell to authorize KYB to complete the project with the Street Department providing for the disposal of removed building materials and with other conditions as discussed.

b. Public Works updates.

DPW/Eng. Neumeier provided a list of projects happening in the City. Blocked culverts along the Nelson trail are being opened up by a crew from Carl Bowers Construction. A pipe in the upper Riverside Park, along Wisconsin Avenue and Riverside Drive, is being replaced. The seawall project is moving forward. Soil borings at this location will happen on or around December 19. DWP/Eng. Neumeier thanked the Planning Department for helping to initiate the downtown garbage discussions. Business meetings will take place this Thursday and next Wednesday for downtown business owners to meet with city staff to discuss the implementation of the downtown garbage revisions.

Street Superintendent Van Gompel provided a presentation with leaf collection data. The numbers reflect collecting leaves with anywhere from 3-10 staff members. The Street department has three leaf vac machines and 5 trucks that are set up to haul leaves during the season. Overtime ran on 11 different occasions throughout the collection season, 2 of which were Saturdays. Overtime was not forced. Leaf season was extended for an extra week. Collection period was from October 10th-November 18th.

We, the undersigned municipal leaders, write to jointly express our interest in incorporating Green Bay and the greater Fox Valley region in the FRA's Corridor Identification and Development Program. This extension would build on Amtrak's highly successful Hiawatha Line from Chicago to Milwaukee.

The Fox Valley is the third largest metropolitan area in Wisconsin. Currently these communities are serviced by Amtrak Thruway I-41 Bus Service. This new passenger rail corridor would provide residents of Green Bay and the greater Fox Valley region with increased mobility options to the state's largest city, as well as service to Chicago.

A Green Bay — Milwaukee — Chicago Amtrak service would create new connections between major metropolitan cities, medium-sized cities, and colleges and universities. Students, their families, faculty, and staff will be able to take advantage of frequent Amtrak service to avoid traffic between destinations and to enjoy greater productivity or relaxation while they travel.

All seven cities along this corridor that would be served by the Hiawatha Extension strongly advocate for incorporating the project in the Corridor Identification and Development program. We strongly believe that this corridor satisfies the Selection Criteria outlined in the Federal Register Notice.

2. Public Appearances

No appearances were made.

3. Approval of the Minutes of the October 11, 2022 Regular Meeting and the October 26, 2022 Special Community Meeting

The minutes of the October 11, 2022 Regular Meeting and October 26, 2022 Special Community Meeting were presented to the Commission. A motion was made by Commissioner Coffey and seconded by Commissioner Siebers to approve the minutes as written. Motion carried unanimously. The minutes were reviewed and pre-approved by Secretary Hennessey.

4. Correspondence

The commission received a copy of a letter dated 10/19/2022 sent to Brian VanStraten of Outagamie County Recycling & Solid Waste regarding HOV's and Little Chute's response to their Proposal dated 8/29/2022.

5. Discussion Items

A. Interceptor Rehab Project; Plans, Specs, & Bidding

District Director Helminger District noted that an updated ITA and PERF was submitted for Clean Water Funding on the interceptor project which was due 10/31/2022. There was a working meeting held on 11/6/2022 with HOV staff, Commissioner Casper, and Strategic Municipal Services (SMS). Discussion on the project and progress since the last meeting included review of existing exterior coatings that have not held up to expectations. A conference call with Sherwin Williams revealed the coatings cannot be repaired and removal

is recommended as there is no alternative product available. SMS recommends removing existing coatings and implementing regular detailed inspections of the manholes in the future. Coating of manholes would be removed from the scope of the project and SMS recommends implementing standard concrete maintenance like concrete patching and grout sealing of cracks which is normal practice with other in-water and submerged concrete infrastructure like dams and bridges.

B. Adoption of Resolution #203; Abating Levy

A motion was made by Commissioner Casper and seconded by Commissioner Coffey to adopt Resolution #203; Resolution Abating Levy of 2022 Real Estate Taxes. A roll call vote was taken: Commissioner Casper, yes; Commissioner Sundelius, yes; Commissioner Coffey, yes; Commissioner Hennessey, yes; and Commissioner Siebers, yes. Motion carried. The Resolution was signed by Commission Secretary Hennessey.

C. Effluent Filtration Project – Monthly Activity Report

D. FOG Program – Monthly Activity Report

John Stoeger of Stoeger & Associates provided a written fats, oil, and grease update by community, including a grease trap inspection report and site visit correspondence. The Commission also received an itemized copy of the October 2022 invoice.

Revenue received from the WPS-Fox Energy Center for effluent purchased in October = \$11,198.28; Revenue received to date for 2022 = \$136,020.73. WPS-Fox Energy purchased 43% of the effluent produced in October.

Kevin Skogman, Director of Operations & Maintenance, provided a written O & M Report on plant operations for October. He noted that one of the DAFT pressure vessel tanks has been installed, a new heating/air conditioning unit is on order for the solids building garage, and the delivery date for peak flow pump #3 VFD is estimated to be mid November. Skogman also talked about quotes he received from EC&D and August Winters to replace the Patterson Kelly hot water boiler. After a discussion the commission directed staff to get a breakdown of the quotes and investigate other options for maximum efficiency. This will be discussed again in December.
