### BUSINESS PRESENTED BY THE MAYOR

#### Beyer Trial Update.

Chief Graff provided information on the Beyer Trial investigation. He highlighted the thorough job and hard work the officers did to solve; and ultimately, get a conviction. The case was led by Lieutenant Tom Bartolazzi and Detective Kory Krueger, along with the help of many of the Kaukauna Police Department Officers. Department of Criminal Investigative Agents, FBI Agents, and the DA's office were involved. Officers were able to track the movements of the defendant from Manitowoc to Kaukauna during two practice runs and then the night of the murders. The statistics on this case are covered in the 700 pages of the Kaukauna Police Department Report. Each of these pages were proofread by the administrative staff. This case was one of the biggest DNA cases in Wisconsin

history. The State Crime Lab report was 25,000 pages. Between 50 and 60 search warrants were issued. Over 100 interviews were performed. About 650 pieces of evidence were collected, 3,700 video files, 600 audio files and 1.6 terabytes of data were used. A new server needed to be bought. Dive teams from Manitowoc were used. Trained dogs were used to search for evidence. Our officers walked ditch lines for evidence. Officers put in many hours on this case. The community support and support of spouses was huge. Judge McGinnis stated, on record, that this was the best criminal investigation he has seen in his 17 years as a Judge. Chief Graff stressed how proud he is of the officers, staff and spouses for their support on this case.

Council President Moore, on behalf of the Common Council, thanked officers, staff and spouses for all their hard work.

Mayor Penterman thanked Chief Graff, Assistant Chief Sanderfoot, Detectives Krueger and Bartolazzi and the rest of the police department on their hard work in putting together this case and getting justice for Will and Dani.

**Federal Rail Association Joint Letter of Interest - extending service from Chicago to Green Bay.**  
Mayor Penterman read the December 9, 2022 letter from the Federal Railroad Administration. The extension would build on Amtrak’s highly successful Hiawatha Line from Chicago to Milwaukee. All seven cities along this corridor that would be served by the Hiawatha Extension strongly advocate for incorporating the project in the Corridor Identification and Development program.

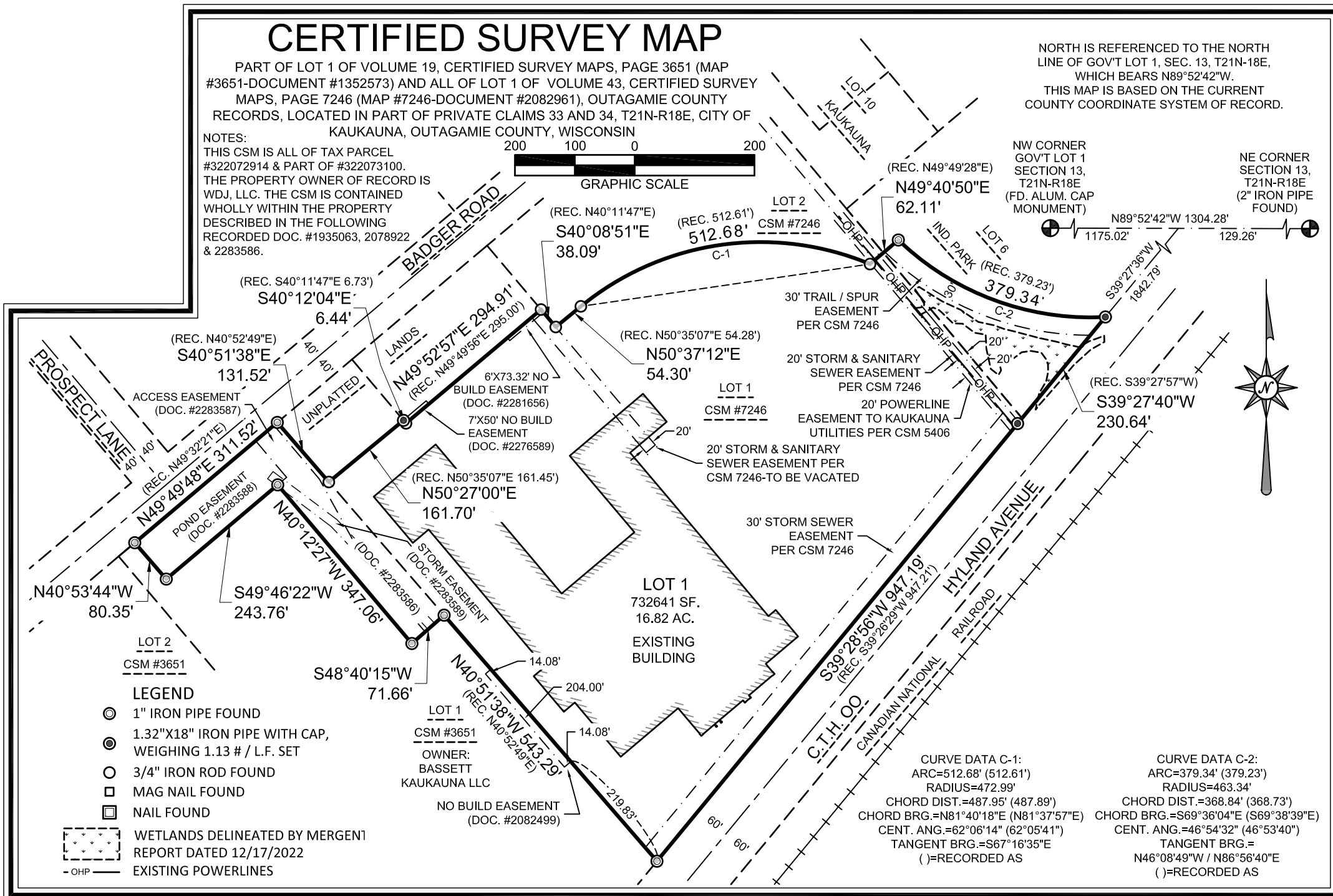
