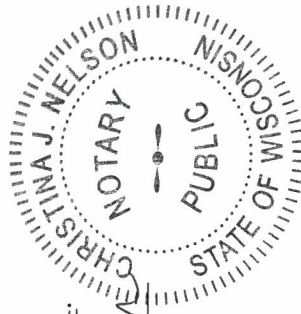

All other fireworks are prohibited within the City limits of Kaukauna.
