## **Naturalist's Report**

An estimate from Milbach Construction was received for the boardwalk replacement work. We will continue to look for Grants to help cover this expense.

Focus on the Fox: Planning continues for this event, and we are hoping Kobussen Buses will donate a shuttle bus and driver to transport people to Lock 3 and back. Guide Studio is finalizing the design of the "Focus on the Fox" logo as well.

Van Berkel made a motion to accept the July Naturalist's Report and place it on file. Seconded by Jakel. Motion carried.

## **Admin and Finance Sub-Committee**

Van Berkel made a motion to accept and place on file the Admin and Finance Sub-Committee Meeting Minutes of July 6, 2023. Seconded by Gertz. Motion carried.

Endowment Fund: Continued discussion regarding the Endowment Fund and ways to improve the return. Van Berkel noted that we do need the City Council's approval to create a 1000 Islands Endowment through the Community Foundation and for the Fund

to solely benefit 1000 Islands Environmental Center. Van Berkel made a motion to pursue the creation of a designated fund within the Community Foundation for the Fox Valley Region with the support of the City of Kaukauna Common Council. Seconded by Carlson. Motion carried.

Interest Income Account: Currently the Interest Income account is part of the General Fund of 101, but should really be a 201 Restricted Account. Nowak to review the current policy and will work with the City's Finance Department to change this.

Non-Personnel 2024 Budget: Nowak has been working on the 2024 non-Personnel budget and shared it with the Admin and Finance Sub-Committee earlier today. Discussion and clarifications on several accounts were covered. Van Berkel made a motion to approve the proposed 2024 non-Personnel budget as discussed. Seconded by Manion. Motion carried.

2024 Capital Improvement Plan (CIP): Several items have been requested for the 2024 CIP budget including a new truck, siding for the building and boardwalk replacement. Other more expensive items that need to be addressed are trail and building signage, bathroom remodeling—especially the sinks and counters, and updating the main entry way to make it easier for wheelchairs and strollers to get in and out of the building. Program and event registration software start-up cost of \$4,600 is also needed.

Personnel for 2024: Nowak is requesting an additional full-time Naturalist be added to the 1000 Islands staff. She is also working with AmeriCorps for a potential full-time person to work October 2024 – August 2025 through their organization. Our cost would be \$20,000 for this person. Nowak will work with the City's Finance Dept. to get this in the 2024 budget as well.

## Naturalist Report August 2023

### Admin/Finance

- Department Heads have completed the City Strategic Plan. The plan will be presented to Council at a Committee of the Whole meeting on October 16.
- The Finance Department has decide to make a City-wide change on how the processing fees for credit cards are handled. Previously, the City paid the processing fee for all 1000 Islands credit card transactions, but it was not consistent across all departments. Moving forward, all credit card fees will be paid by the card holder. Credit transactions will be assessed at 2.2% or \$1.00, whichever is greater. Debit transactions will be assessed a flat \$3.50 fee. Signage on this change has been updated.
- Outagamie County has set their 2024 budget schedule. I will be meeting with the Finance Committee virtually on October 19 regarding the County grant to 1000 Islands for our 2024 budget.

### **Education**

- We will be welcoming another group of goats from Mulberry Lane Farm for the fall browsing session on September 25. The goats will be on-site for 2 weeks, getting picked up on October 9. I will be hosting 2 "meet and greet" sessions for City employees, Council members and staff. We are once again working with the high school's Environmental Topics class to survey the vegetation in the browsing areas both before the goats arrive and after they leave.
- The Grover the Goat book is now complete and we have 100 printed copies thanks to the Friends of 1000 Islands for sponsoring the printing costs. The book will be available for purchase in the gift shop and will be the featured storybook walk in September while the goats are on-site.
- The 2023 Focus on the Fox event will be held on September 23. We have a new event logo created through Guide Studio and have 7 partnering organizations highlighting several different aspects of the Fox River. The Fox River Navigational System Authority will be offering lock demonstrations at Lock #3 during the event. Kobussen Buses has offered to donated shuttle services between 1000 Islands and the lock. Volunteers are still needed to cover various activity areas.
- I have received notification that the City of Kaukauna has once again been awarded Bird City status
  through the Bird City Wisconsin program. Many qualifying factors that help the City achieve this
  designation come directly from the Conservancy Zone, 1000 Islands programming and staff time put
  into the application process. I will work with the Mayor to put this achievement on a future Council
  Meeting agenda.

## **Building & Grounds**

- I have been in contact with the Community Foundation on pursuing a grant through the Nelson Family Fund to help cover costs of the boardwalk replacement project.
- Site Manager Garrity and I will be working on getting some quotes on replacing some of the windows in the Nature Center. The majority of the windows are no longer operational for opening and closing.
   Although a few windows have been replaced in previous years, we would like to start replacing additional windows as our maintenance budget allows.
