Motion by Lindberg and second by Wirth to approve the February 16. 2022, KATODA Prevention Board minutes. All members present on teleconference via Zoom voted aye. Motion carried.

Pautz reported to the board the letter regarding informing Kaukauna Youth Sports Organizations hosting tournaments to notify outside youth organizations of the City of Kaukauna's no alcohol ordinance at youth events in city parks. The Health and Recreation Committee approved to allow KATODA to send this information to the local sports organizations. Pautz will see if the Times-Villager will publish this reminder in the paper next month during Alcohol Awareness Month.

Discussion was held regarding the CBD vending machines located at both Piggy Wiggly stores. The concern is regarding the items being sold as to being legal. Van Neupert mentioned that some of the items may contain Delta 8 and Delta 10. It was also noted that Alcohol Pops were being sold in the popsicle section and not in the alcohol section. More information will be sought before approaching the store to seek changes.
