Background

- 1. City Staff have been working with McMahon Associates to develop a modified building plan and alternative bid items and specifications for the construction of a pavilion at Jonen Park. Items removed from the previous design, now to be bid as alternates include:
 - a. Plumbing fixtures
 - b. Painting
 - c. Concession casework
 - d. Landscaping
 - e. Removed insulation under concrete slab.
 - f. Removed face brick and insulation at exterior.
 - g. HVAC ventilation only

A rendering is attached and is the same exterior look/design as previous. We would anticipate an August bid opening and construction schedule of Fall 2023-Summer 2024 to be ready for next summer park use.
