# 2. Discussion Topics.

# a. 2026-2030 5-Year Capital Improvement Plan (CIP).

Finance Director Van Rossum presented on the 2026-2030 5-Year Capital Improvement Plan (CIP). The City of Kaukauna CIP was recently updated by staff as of September 2025. The CIP serves as both a planning tool for operations and a framework for financing and budgeting, providing a five-year outlook for equipment, parks, streets, utilities, and other capital needs. The plan consolidates requests from all departments, ensuring a citywide perspective on priorities. Departments are encouraged to bring forward requests in a timely manner so needs can be evaluated before equipment or facilities become critical. Alder Moore mentioned providing information/justification for CIP projects. Discussion held and questions answered.

Motion made by Moore, seconded by Antoine to acknowledge the updated 2026-2030 CIP as a planning document and use it as a guide in evaluating and prioritizing future projects. Specific approvals for 2026 projects will be brought forward in Spring 2026 ahead of bonding and bidding. All Ald. Present voted aye. Motion carried.

# b. Recommendations for Disposal Site.

Street Superintendent Van Gompel discussed his recommendations for the City of Kaukauna disposal site. When discussing operational changes with the refuse dumpsters at the Municipal Disposal Site a full cost analysis of the site was suggested along with gathering information on what percentage of users are utilizing the refuse dumpsters vs the other material services. Currently there are five categories of materials accepted, and each material has its own process and timing for servicing. Residential garbage, recycling, brush, yard waste, and motor oil are the current accepted materials. Currently there are 2088 site users which net \$52,200 a year. With site fees only covering around 56% of actual costs of operations, changes need to be considered. 18% of site users utilize the refuse dumpsters which is roughly 47% of total operational costs. The continued concern of staff safety, non-compliant dumping, costs of tipping fees, and enforcement of this material need to be considered and determined if this material is worth the continued risk and cost for collection. Discussion was held on which recommendations were most favorable. Some alders were ok with recommendation 1, which was "direct staff to remove garbage and recycling dumpsters from Disposal Site on determined date and update Waste Material ordinance 11.11." Suggestions were also made about alternative options, which included an additional large/ irregular pick-up or special drop-off days at the disposal site with staff onsite around the end of the year.

Motion made by Moore, seconded by Schell to table this item and come back with recommendations.

KASD was able to donate three basketball hoops, the baseball backstop, and the two square picnic tables that were located at the lower playground for re-use at City parks. Special thanks go to Street Superintendent VanGompel and Kevin Veldman, KASD Maintenance Engineer, for seeing an opportunity to benefit the community and working together to improve our city parks. And thanks to street department staff for collecting and refurbishing some of this material for reinstall.

# 2. Discussion Topics.

# a. Electric City River Jam 2026 budget request.

Com. Enrich. and Rec. Director Vosters discussed the Electric City River Jam 2026 budget request. The dates for the festival have been set for June 17–20, 2026. To secure vendor commitments for these dates, the City will need to enter into agreements in the coming months. A few deposits may be required, but most of the fixed costs will not be due until closer to the event in 2026. The estimated fixed cost for the event is \$60,000. This includes expenses for bands, staging, tents, portable restrooms, and food/drinks. The planning committee will continue establish a sponsorship program, which is expected to cover much of these expenses. Any shortfall in sponsorship funding will need to be addressed by the City's budget if something happens where the event does sell enough product during the event due to poor attendance or bad weather. As reported in August of 2025, Electric City River Jam expenses were \$58,572.25 with revenues of \$49,252.50.

Motion by Moore, seconded by Antoine to grant permission for the Community Enrichment Program Manager to enter into agreements with vendors to secure commitments for the 2026 Electric City River Jam event with a total commitment not to exceed \$60,000.

# b. Review the Deferred Compensation Committee Charter.

Over the past year, staff from the City of Kaukauna and Kaukauna Utilities have collaborated to develop a charter for the Deferred Compensation Committee. This work was undertaken to establish a formal governance structure for oversight of the Employers' 457 Deferred Compensation Plan and 401(a) Defined Contribution Plan. The draft charter was provided by the city investment consultant and reviewed by both former and current city attorneys. It reflects best practices from other municipalities and utility organizations with similar retirement offerings. The proposed charter provides clear guidance on membership, authority, responsibilities, meeting structure, and reporting expectations. This proposed action aligns with the Strategic Plan's focus on Operational Excellence and Financial Stewardship. By creating a structured committee with defined responsibilities, the City and Kaukauna Utilities will enhance oversight of employee retirement benefits, reduce fiduciary risk, and promote best practices in investment oversight and plan administration. Discussion held and questions answered.

Motion by Moore, seconded by Antoine to forward the Deferred Compensation Committee Charter to Common Council with the language change "or designee" in item 3 composition for both the city and the utility.

# c. Review and endorse Investment Policy Statement.

The City of Kaukauna and Kaukauna Utilities Deferred Compensation Committee undertook a review of the Investment Policy Statement governing the City's 401(a) and 457(b) Deferred Compensation Plans. The policy was originally adopted in 2018 and has guided the administration, monitoring, and evaluation of plan investment options and fiduciary responsibilities. As part of the Committee's regular oversight, the updated policy was reviewed in August 2025 to confirm continued alignment with plan objectives, participant needs, and industry best practices. Following its review, the Committee determined no substantive revisions were necessary. To maintain compliance with governance practices and reaffirm oversight, the Committee intends to re-sign and re-adopt the policy in its current form.

Motion by Moore, seconded by Schumacher to endorse the Committee's review and reaffirmation of the Deferred Compensation Investment Policy Statement. Specifically, staff recommend Council authorize the Deferred Compensation Committee to sign the updated policy dated August 18, 2025, thereby reaffirming the City's continued oversight of employee deferred compensation plans without substantive changes. President Casper called the meeting to order at 5:00 PM.

- 2. Approval of the Minutes from the August 18, 2025 Regular Meeting The minutes were not completed in time for formal acceptance. No action taken.
- 3. 2025 Sewer Rate Service Review Trilogy Report Discussion and possible action regarding recommended changes to cost allocations and the HOVMSD Sewer Service Rate methodology-

Christine DeMaster appeared via TEAMS and reviewed the Trilogy report that contains proposed revisions to the existing sewer user charge and rate calculation methodology. The existing system has been in place since 2008 as no major projects or bonding has been necessary since then. Utility debt obligations are fixed costs that require stable revenue to ensure timely repayment. The changes proposed by Trilogy move to align the sewer rate structure with evolving utility cost trends and in particular recognizing the increased proportion of fixed costs. An example, pointed out by DeMaster is insurance and administrative wages as being fixed costs unrelated to the amount of flow or suspended solids in the inbound

sewage. Any revised allocations towards recognition of fixed costs will be contained in the monthly demand charges to the communities. Demaster also recommends elimination of the reserve capacity charges as they came as a result of the last plant upgrade and the Clean Water Fund debt service has been fully paid off as of 2025.

The only outstanding item is the revisions to the Equipment Replacement Fund to include the depreciation of the new process equipment used for effluent filtration. The information and Trilogy report was received the date of the meeting and so Commissioners will continue their review and are expected to take action on this item at the regular monthly Commission meeting schedule for September 9<sup>th</sup>. No action taken.

**4. 2026 HOVMSD Budget** – Initial discussion on the 2026 budget changes, annual projects & replacements, and added budget lines.

Helminger inquired with each Commissioner on their preference on hard copy versus electronic delivery of the 2026 District budget.

The Commission consented to two new budget lines to be added in order to account for polymer purchase and consumption at the process where it is consumed. Currently, there is a single budget line for polymer despite continuous feed in the Actiflo process, the Dissolved Air Floatation thickener, and as needed ahead of the new effluent Disk Filters.

Helminger suggested and the Commission consented to removing Line 59980 formerly added and used for Covid 19 Expenses.

The funding for line 59922 - Public Relations was discussed as the District wraps up its 2 major projects in 2025. Kane came on site and presented a transition at the last Commission meeting. The line for 2025 was budgeted for \$30,000 with \$17,000 spent as of meeting. A brief discussion ensued about the level of funding and reduced outreach anticipated for 2026. The Commission determined that for 2026 the line will be funded at \$20,000 and used as needed and at District request.

# 5. Adjournment

With no further business before the Commission a motion was made by Commissioner Sundelius and seconded by Commissioner Coffey to adjourn the meeting. Motion carried unanimously. (Time: 5:40PM)

# 3. Approval of the Minutes of the August 18, 2025 Regular Meeting

The minutes of the August 18, 2025 Regular Meeting were presented to the Commission. A motion was made by Commissioner Coffey and seconded by Commissioner Siebers to approve the minutes as written and presented. Motion carried unanimously. The minutes were reviewed by District Director Helminger and Commission Secretary Hennessey prior to the meeting.

# 4. Correspondence

One article carried by the Times-Villager dated 7/16/2025 about the effluent disc filter project, was copied for the Commission.

# 5. General Discussion Items

# A. Kane Communications – Monthly Activity Report

Kane Communications provided a written update on work tasks completed in June as well as a list of ongoing scheduled tasks for July & August.

# B. Kane Communications – 2026 PR Transition Plan

Cole Buergi and Chris Christensen of Kane Communications presented a PowerPoint with suggested print and media communications including a social media presence as effective methods of disseminating information to the public. Kane was complimentary of past District efforts while under construction over the past two years. Kane emphasized the importance in maintaining communication with the public and our member communities. Consistent and regular communication channels build trust with your audience for when major emergencies require immediate public contact. Kane staff appeared in preparation for the District to begin budget deliberations for calendar year 2026.

# C. 2025 Sewer Service Rate Review & Recommendations - Triology

Christine DeMaster appeared via TEAMS and reviewed a PowerPoint with recommendations on allocations and proposed modernization of the existing Sewer User Rate model in place since 2008. Trilogy noted a trend with utilities rates being data driven for anticipated flow and loadings along with a general industry trend away from variable cost allocations. The project also looked at the District's equipment replacement fund contribution which will require a major addition due to the effluent filtration equipment being added onto the equipment roster being depreciated. DeMaster informed the Commission that there were several options that can be discussed for the future of the equipment replacement fund and its balance. DeMaster used District payroll as an example of a recommended allocation change to a greater demand or "fixed" allocation percentage resulting in increasing the demand charges to the member communities. Discussion ensued around specific percentages and the effects on the overall treatment billings. The Commission determined additional discussion was necessary and determined that a meeting for 9/2/25 specific to the changes would be necessary. No action taken.

# D. Interceptor Rehab Project – Monthly Activity Report

Scott Schramm of Strategic Municipal Services provided a detailed activity/progress summary for July to commission. We are at the 80% complete mark, and 17% of the remainder is driven by structures.

# E. Interceptor Rehab Project – Change Order #1, Discussion and possible action

Visu Sewer provided a letter dated 7/31/25 detailing increased efforts in MH 16, 38A, and 26 and requesting a contract time extension for contract completion to be November 30, 2025. An emailed schedule of manholes to be coated was also in the meeting packet.

A motion was made by Commissioner Sundelius to approve change order #1 as presented with the deadline for completion to be November 30, 2025 and seconded by Commissioner Hennessey. A roll call vote was taken: Commissioner Sundelius, yes; Commissioner Casper, no; Commissioner Coffey, no; and Commissioner Siebers, no; Commissioner Hennessey, yes. Motion failed.

# F. FOG Program- Monthly Activity Report

John Stoeger of Stoeger & Associates provided a written fats, oil, and grease update by community, including a grease trap inspection report and site visit correspondence. The Commission also received an itemized copy of the July 2025 Invoice.

# G. Resolution #36; Discussion and possible action

Discussion on this item from past meetings did not result in action. Helminger had not yet reached legal counsel on questions communicated by the Commission. A recent email response from Kaukauna did not identify city expenditures associated with its role as Treasurer that the District may elect to reimburse. Legal follow up is still needed. No action taken.

# 6. Plant Reports for July 2025

# A. Flows & Revenues Report

The Commission received a copy of the hydraulic & organic loadings data, along with flow & strength projections, which shows the year-to-date surplus/deficit in revenue for the month of July 2025. Revenue received from the WPS-Fox Energy Center for effluent purchased in July was at \$ 21,336.32. Revenue received year to date is \$78,938.30. WPS-Fox Energy purchased 57% of the effluent produced in July.

# **B.** Operations & Maintenance Report

Dustin Jerabek provided a written Operations & Maintenance report for July. The disc filters were in operation continuously throughout the month. Chemical addition ahead of the filters was added from July 22<sup>nd</sup> to 25<sup>th</sup> to exercise the chemical feed equipment and drive down the effluent phosphorus concentration. Land application of biosolids started August 6<sup>th</sup>.

On July 15<sup>th</sup> we experienced a total power outage that lasted from 8:46AM to 9:28AM. This caused some flooding in the Actiflo building because the gates in headworks were not closed quick enough to reroute the flow into the peak flow train. A treatment plant overflow report was submitted to DNR for the incident. The crew did a fine job getting the plant back up and running once we got power was restored.

Various repairs were detailed in the report including a new water heater, sludge pumping flowmeter, and telemetry radio for MS #6. A blacktop repair on the plant grounds was completed near the biosolids storage tanks and a laser flowmeter sensor replaced in MS #3.

### 7. Financials

# A. July 2025 Accounts Payable; Action for Approval

After a review of the bills payable, a motion was made by Commissioner Casper and seconded by Commissioner Hennessey. Approve payment of the bills in the amount of \$1,562,272.39. A roll call vote was taken: Commissioner Casper, yes; Commissioner Siebers, yes; Commissioner Sundelius, yes; Commissioner Coffey, yes; and Commissioner Hennessey, yes. Motion carried unanimously. The Commission signed the check voucher register which includes general, and pre-paid checks.

# **B. Budget Comparison Report**

The Commission received a Budget Comparison Report; there were no new budget lines discussed this month.

### 8. General Old or New Business

Lamers contacted the District on 7/24/25 to inform HOV that testing issues were resolved with Badger and they are installing a grease interceptor and in the process of getting multiple quotes for the work. They will send a letter detailing their plan and efforts to date.

Feller made a motion to approve the minutes from June 19, 2025. Seconded by Jensen. The motion passed unanimously.

- 4. New Business
  - a. Park Donation Application Review Benches
    Associate Planner Nelson introduced the park bench donation application
    submitted by Gail and Jeff Gustman for two benches, to be installed at
    Riverside Park and Horseshoe Valley Park, in memory of Tom and Suzy
    Gustman and Elwyn and Margaret Schroeder. The benches would be in
    the City of Kaukauna's standard bench style and would include plaques.
    The donors have requested that these benches overlook the baseball

fields at both parks. At Riverside Park, there are currently four benches along the sidewalk that overlook the baseball field. These benches differ in style from the standard benches, but they are in good condition, so they do not need to be replaced at this time. There is room, however, for another bench to be placed in that same area. At Horseshoe Valley Park, there is ample space in the area overlooking the baseball field, and no current benches are in place along the large curve of sidewalk around the baseball field. Both parks would benefit from benches to allow people to comfortably watch the baseball games.

Schoenike made a motion to approve the park bench donations for Gail and Jeff Gustman in memory of Tom and Suzy Gustman and Elwyn and Margaret Schroeder with the finalization of the location to be done by staff. Seconded by Jensen. The motion passed unanimously.

# b. 2025-2030 Park Plan

Director Kittel introduced the 2025-2030 Comprehensive Outdoor Recreation Plan. He explained that this is an introductory item, but if the Plan Commission has no changes they would like made to the document, they can forward it on to the Common Council for review. The plan as presented was shaped by information gathered from the community survey, standards taken from the National Recreation and Parks Association (NRPA), and items that have recurringly been brought up to staff by community members. Items that kept coming up included maintenance, amenities, community events and involvement, and beautification. Staff then worked to pinpoint what the issues were for these areas and why they kept coming up in order to develop tactics to address them.

Kittel then went on to explain each of the items in more depth. For maintenance he explained that, given the large number of parks Kaukauna has, it can be difficult to maintain all of them. Some of the tactics suggested to address this issue included creating an annual park conditions report, creating a formalized user reporting system accessible via QR codes at parks so maintenance issues can be addressed quickly, performing semiannual park inspections, hiring a park foreman and having dedicated park maintenance staff, and investigating security measures at parks in order to reduce vandalism.



For amenities, Kittel explained that many residents want more diverse, accessible amenities for a wide variety of age groups. There were quite a few requests made for ziplines, trails, and dog-friendly parks. Some of the tactics suggested to address this issue included exploring small fenced in areas for dogs at parks, performing public outreach to neighbors when a park is to be updated, creating and providing digital and paper trail maps, improving bike lanes and safety, using national park standards when planning for amenities, investigating the possibility of a permanent event stage, creating a Central Park redevelopment plan, and mapping parks and service areas in order to plan for future park needs.

For community events and involvement, tactics included investigating the possibility of having community gardens, exploring any legal requirements for having beer garden events, and increasing the promotion of parks on social media so community members are aware of existing amenities.

For beautification, tactics included more native plantings, the creation of a beautification committee, adding landscaping at park entrances for larger regional parks, introducing more public art, creating an adopt a park/planter program, and hosting community clean-up events.

Schoenike commented that there are definitely amenities that go unused, such as the boat launch at Riverside Park and the kayak launch at Trestle Park.

Avanzi commended staff for their work and Director Kittel for his presentation on the document. He stated that he would support whatever the rest of the Plan Commission was wanting to do.

Feller made a motion to recommend adoption of the 2025-2030 Comprehensive Outdoor Recreation Plan to the Common Council. Seconded by Jensen. The motion passed unanimously.

c. Revised Site Plan Review – 101 Kelso Road (CoVantage)
Associate Planner Nelson introduced the revised site plan for the new
CoVantage building to be located at 101 Kelso Road. The original plan
was approved by the Plan Commission on May 22, 2025. In order to
address items brought forth by the Wisconsin ANR during the wetland
permitting process, however, a revised plan was submitted. No changes
were made to the driveways, the north parking lot, or the location of the



building. Changes have been made to the location of the drive through, solar panels, and gravel path.

Thiele made a motion to approve the revised site plan with the condition that, prior to issuance of building permits, updated Stormwater and Erosion Control permits are obtained from the Engineering Department. Seconded by Schoenike. The motion passed unanimously.

 d. Façade Variance Request – 1020 W Hyland Avenue (GE Contracting) Director Kittel introduced the façade variance request made by GE Contracting for the construction of their new vehicle storage garage at 1020 W Hyland Avenue. The property is zoned Commercial Highway District (CHD) and, per ordinance, the façade must have a minimum of 10% masonry on any side facing a public street. This requirement has already been discussed with the applicant, and they plan to add a kneehigh masonry component to the side of their building that faces a public street. They are requesting a variance, however, to allow for the use of metal siding in the façade. Per ordinance, up to 10% of the façade of the building may be metal if approved by the Plan Commission. The applicant wants to use steel siding for a façade because it doubles as a structural component, allows for a stronger building, and helps keep down construction costs. There have been other buildings in the CHD approved and constructed with entirely metal siding. If the Plan Commission were to approve the 10% metal façade, the applicant would go to the Board of Appeals as well to obtain a variance allowing for a fully metal façade (aside from the 10% masonry on the side of the building facing a public street).

Neumeier commented that, in this area of the city, concrete and masonry is used heavily. Metal would appear out of place. He would lean towards following all ordinance requirements and not allowing for a variance.

Mayor Penterman agreed with Neumeier

Thiele noted that these façade ordinances were created for a reason, and that there are residential homes in this area. The ordinances should be followed.

Feller agreed, commenting that there is no reason to have ordinances if they are being bypassed. Jensen stated that the ordinance should be followed, and that the 10% masonry component should be included in the plans moving forward.

Neumeier made a motion to direct Director Kittel to inform the applicant that the Plan Commission will not support anything outside of the existing ordinance and to return with a new plan. Seconded by Feller. The motion passed unanimously.

# Naturalist's Report

Garrity highlighted some points of interest.

The downturn in pavilion rentals may be due to the city having many great facilities. Staff are still getting calls on building rentals for parties, which generated some discussion on the policy change. Garrity will clarify our policy for non-profit rentals.

Programs are going well, with Crayfish and Critter Hunts being the most popular. 20 new nets were just ordered for \$1000 leading to the necessity to be more vigilant about locking the nets when not in use. Nets are not checked out during the day, but staff are thinking of piloting a process whereby users alert the staff when taking equipment out on a hunt.

Service Saturday is finally taking off. Many groups are coming and working together as a service project.

Local TV stations –1000 Islands is becoming a go-to for stories and expertise. Garrity and staff are also being contacted by radio and podcast hosts – "Living Outdoors with Mark Drewek". It was suggested that the staff consider a Facebook or Times Villager "column" weekly or biweekly. That discussion then jumped to an informational column or weekly blog that could be featured online or in print in connection with city information. Manion stated he had experience in providing updated info to the community; he will provide examples.

Information on the Three Sisters Garden was then presented. This project is spearheaded by the Kaukauna Public Library. Once the Garden is established it will become a community thing. 1000 Islands provides the plot of land and maybe some watering.

### 2nd Quarter Usage Report

Pautz raised the question about the numbers not adding up. It was explained that school groups and registered program participants are easy to quantitate, although counties of origin may be estimated. Shared programs, like Storybook Walk, are very hard to quantitate. It was suggested that maybe those activities are each counted with the number of participants estimated based on number of programs. This will be taken to the Education Committee to evaluate what needs to be quantified accurately, what doesn't, and the means by which to do that.

Director Kittel provided an overview of the site plan for the creation of a 30,000 square foot warehouse for Quick Transport for their property located at 1900 Tower Drive. The warehouse will be located at the rear of the property. Quick Transport is also proposing adding a third driveway onto Tower Drive. This would improve truck traffic and allow for better maneuvering. The proposed driveway is located far enough away from the

existing driveway to not be a cause for concern. Staff has reviewed the plan and confirmed that it is in compliance with all covenants and meets all requirements set forth in city ordinance. Staff recommends approval with the following conditions: prior to issuance of building permits, Stormwater and Erosion Control permits must be obtained from the Engineering Department.

Schilling made a motion to approve the site plan as presented with the condition that, prior to issuance of building permits, Stormwater and Erosion Control permits are obtained from the Engineering Department. Seconded by Gaffney. Motion passed unanimously.

c. Site Plan Review – 1801 Progress Way (G&G Machine)
Director Kittel provided an overview of the site plan for an 8,455 square foot addition to the G&G Machine building located at 1801 Progress Way. The addition will match the existing facade and should blend into the building. Staff has reviewed the plan and confirmed that it is in compliance with all covenants and meets all requirements set forth in city ordinance. Staff recommends approval with the following conditions: prior to issuance of building permits, Stormwater and Erosion Control permits must be obtained from the Engineering Department.

Schilling asked what the purpose of the addition is.

Kittel stated that the addition will primarily be used for shipping and quality control purposes.

Eggert made a motion to approve the site plan as presented with the condition that, prior to issuance of building permits, Stormwater and Erosion Control permits are obtained from the Engineering Department. Seconded by Gaffney. Motion passed unanimously.

Adding Data Center for Permitted use in Industrial Zoning district

#### **Background information:**

Technology continues to evolve rapidly, leading to the emergence of new industries and land use needs. One such growing industry is data centers. While there is currently no active proposal for a data center development, staff recognizes the importance of proactively updating our zoning regulations to attract future opportunities.

#### **Proposal**

Re:

Staff recommends updating the City's Industrial Zoning Code (Section 17.25) to include data centers as a permitted use. This change would position the City to accommodate a modern and growing industry, helping diversify our commercial base and remain competitive. Additionally, staff suggests allowing data centers as a **conditional use** in the **Commercial Highway** and **Business Districts**. This flexibility acknowledges that data centers vary significantly in size and infrastructure needs—some may require large tracts of land and heavy utilities, while others may resemble small office buildings.

#### Benefits of This Use (if one is built)

- Increased tax base, helping offset the overall tax burden.
- Diversification of the commercial base, ensuring long-term economic relevance.
- Attraction of support industries, such as IT services and maintenance.
- Job creation, including both technical and operational roles.

**Considerations & Challenges** While data centers offer many benefits, they also present challenges that must be addressed collaboratively:

 High power demand: Requires coordination with utility providers but can lead to long-term infrastructure improvements. • Water usage for cooling: Modern cooling technologies have significantly reduced this concern, though it remains a consideration for larger facilities.

#### **Next Steps**

Staff is seeking feedback and direction from the Council on whether to proceed with drafting zoning amendments to accommodate data centers. This would lay the groundwork for future discussions with stakeholders and potential developers.

#### Strategic Plan:

This aligns with part of the foundation of the strategic plan of innovation by providing new types of opportunities. This would align with the mission of the plan by offering new opportunities and the Vision of the plan as a community of choice and offering new economic opportunities.
