#### Minutes

#### In Person

1. Roll Call.

Hennes made a motion to excuse the absent member. Seconded by Sprangers. Motion carried unanimously.

- 2. Approval of Minutes.
  - a. Approve minutes from May 2, 2024 meeting.

Hennes made a motion to approve the minutes from May 2, 2024. Seconded by Kilgas. Motion carried unanimously.

- 3. New Business.
  - a. Heritage Mall Mural

The original design for the mural has been changed and we are looking for approval for new mural. The mura will be done asap if the certificate of appropriateness is granted.

Motion to grant a certificate of appropriateness to mural as presented by Kilgas, seconded by Lenz. Motion carried unanimously.

b. 2<sup>nd</sup> and 3<sup>rd</sup> Street Alley Project-Renew Kaukauna Loans

Director Kittel presented the project to occur to meter updates that will need to take place at some buildings as part of the alley project. Some are already updated and compliant. There are a few buildings who already took out Renew Kaukauna loans and are not eligible to apply again for 10 years unless RACK agrees to reopen their loan or grant a new loan. This will be coming up in the very near future. We don't need action today, would like to have more conversation about this before making a final decision. Heather supports and Quin also mentioned to make sure they are paying their loans back prior to issuing more money. Nikki suggested maybe making an amendment to the Renew Kaukauna documents to include not to exceed \$15,000 and out of the scope of their control. Heather questioned whether it is possible to apply for the microloan prior and if they don't get that then they can revisit the Renew Kaukauna loan. Director Kittel also brought up the possibility of taking out the 10 years and putting it in as "with RACK approval." Moore said the other guideline we are missing is how much a business is taking up of the funding. All are in general agreement with the philosophy and Director Kittel will bring the changes back to the next meeting. Director Kittel will get a list of the properties that this effects and will bring back funding totals.
