Re: Renew Kaukauna Façade Improvement Application – 109 W 3<sup>rd</sup> Street

Lori Gaede, owner of 109 W 3<sup>rd</sup> Street, has submitted an application for the Renew Kaukauna program. 109 W 3<sup>rd</sup> Street is a two-story, mixed-use building. It has a commercial first floor and residential second floor. Lori runs a barbershop out of the commercial unit – Hair Studio on 3<sup>rd</sup>.

The applicant is proposing a façade renovation. Infinity Exteriors is the contractor of choice. They intend to remove the existing vinyl siding and replace with vinyl siding in the color Norandex Cedar Knolls Carbon. The siding replacement includes trim, too. They also plan to replace the windows on the second level of the building, and two more bathroom windows.

The cost for the project is \$27,180.12. All activities described are allowable expenses for the Façade Renovation portion of the program. The applicant's eligible forgivable loan amount is \$13,590.06.

The owner has also submitted application materials for the removal and replacement of the furnace of the building, with a cost of \$3,100 done by Christensen Heating and Air Conditioning INC. If this expense is approved under the Interior Renovation portion of the Renew Kaukauna Grant program, they could be eligible for \$1,033.33 reimbursement.

The business is in good financial condition with the ability to cover their portion of the project.

### **Recommendation:**

Approve Renew Kaukauna Façade Improvement Application for 109 W 3rd Street in the amount of \$13,590.06 to be paid directly to the contractor upon completion.

Approve the Renew Kaukauna Interior Improvement Application for 109 W 3rd Street in the amount of \$1,033.33 to be paid directly to the contractor upon completion.





Skye Properties has updated their application for the Renew Kaukauna program for 140 E Second Street. 140 E Second Street is a two-story, mixed-use building. It has a commercial first floor and residential second floor. The building was built in 1901 and is a historic contributing building due to its age and boomtown style architecture.

The applicant is proposing a façade renovation. The contractor of choice is J.Owen Construction LLC. They then plan to remove the existing vinyl siding and install new vinyl siding. Necessary wrapping and trim work is included, as well as blending the siding with the stone work.



Re: Renew Kaukauna Beautification Program – Winter Arrangements

#### Option 1

Artificial Pre-Assembled - \$112.99 each

Planter diameter is 36 inch from outside to outside. Inside diameter is ~30 inches which is the size of these arrangements. They can be re-used for multiple years. Easy to install. Things to consider is that they still might not be full enough for the size of planter, and we would need storage space. Not guaranteed to arrive before Christmas Parade.

#### Option 2

Purchase Materials and use a Team Building event to complete - ~\$40 each, cost varies Bales of evergreen boughs (balsam) are \$39.99 - size of bale is roughly 2ft x 4ft. Estimating 4 bales to fill 9 planters. Alternative to purchasing bales, would be to purchase Christmas trees from a tree lot and strip the boughs off. Prices range at Christmas tree lots and could purchase for as little as \$25 and would need 3-4. Red Twig Dog Wood bundles are \$11.99 roughly 6 stems per bundle, and would need one bundle per planter. More options to add to the arrangement are birch logs, 3 per planter, cost is typically \$3 per log, or can advertise for donations/forage. Birch logs can be re-used for many years. This would be a reoccurring cost every year since it is fresh. In future years, materials could be foraged. For example, Street Department trims Red Twig Dog Wood around Municipal Services Building that can go toward this project. This project would be completed before the Christmas parade.
