# **Background**

The Engineering Department has reviewed the bids from four contractors, received on April 13, 2022 for Project 9-22: 1000 Islands Steps to Upper Woods. Apple Valley Landscaping LLC was low bidder. The contractor has visited the site with staff multiple times and is familiar with the work. The bid received was over the original estimate, partially due to bidding requirements, and an increased scope of work. Reviewing all bids, we feel the total bid price is competitive and we would recommend award.

## **Recommended Action**

Award Project 9-22: 1000 Islands Steps to Upper Woods to Apple Valley Landscaping LLC, for a total contract price of \$41,810.00.

# Red Hills Landfill Update April 2022

#### **General Overview**

Three big things are happening at Red Hills: recovering from the wettest March on record, constructing the new leachate collection system for Phase 6, and excavating for sequence 2. The City of Kaukauna is also planning on conducting the air survey in the next two months as well.

#### **Surface Condition**

As you can see from the pictures below, the month of March has brought a lot of moisture. Right now our key activities are:

- Maximizing pumping time of leachate. The leachate levels are down significantly from their levels in late March, but are still elevated from February levels. Later in this letter you will see that we are installing a new force main to allow pumping to the city 100% of the time.
- Installing a new surface sump on the west side. The rain and quick thaw caused one of the surface sumps to sink below grade. We will be installing a new one the week of 4/11.
- Restarting the surface sump pumping system. This system was down for winter due to freezing. The generator is one site and the system will be operational the week of 4/11


#### **Leachate Management**

Leachate levels are down from October, but did see a rise in March.

West Leachate Levels

10/14/21 92" 12/8/21 59" 1/12/22 52" 2/11/22 44" 3/9/22 56"

The graph to the right shows our trend in leachate levels since 10/1/18.



#### **New Leachate Collection System**

The construction of this new leachate collection system has started. This system allows for leachate to be removed from Phase 6 100% of the time. Piping installation should begin on the week of April 11<sup>th</sup>. The construction of the complete leachate system is going to take longer than the original schedule due to some equipment delays from supply chain issues. We are currently working with the DNR and HOV to connect Phase 6 Sequence 1 leachate pump to this system before the tanks are installed. We are hopeful to be pumping to the new system by the end of May or early June.



This is the new force main for the leachate collection system. The pipe was fabricated the week of 4/4/22, and expect installation to start the Week of 4/11/22.

Construction of this piping will result in a small section of the screening berm to be removed directly across from Links Ct. The berm disturbance is expected to be less than 3 weeks.

# **Phase 6 Sequence 2 Construction**


Phase 6 Sequence 2 project should be starting before the end of April. The contractor has started to mobilize supplies and equipment for the project on-site. Construction of the site has not changed from the last update. The design was modified from Phase 6 Sequence 1 to include:


- Smaller overall footprint to reduce collection of rainwater
- Internal berm to promote stability
- Increased diameter of leachate piping
- Increased number of leachate collection lines
- Continuous leachate level monitoring

# Agenda Item #2c No-Mow May Discussion

## **Background**

To promote and educate the community about the critical period of pollinator emergence, City Staff is recommending that the month of May 2022 be designated as No Mow May in the City of Kaukauna. Have you ever noticed that when you don't mow your lawn for a couple of weeks, a new plant pops up? These plants are often native to Wisconsin and great sources of food for bees, butterflies, and other pollinators. Allowing lawns to grow by not mowing for a month leads to an increase the number and types of both pollinators and plants. By not mowing your lawn for the month of May, you can help the pollinators and plants right in your back (and front) yard.

Ways you can participate:

Forgo mowing during the month of May.

Forgo mowing the first 2-3 weeks during the month of May.

Forgo mowing your terrace, front yard, backyard, or any other area of your property. Forgo using insecticides/pesticides.

RFP - Planning for Future Growth - Sewer Service Area Study

## **Background**


Two potential growth areas for the City of Kaukauna on the south side of the Fox River include areas to the east of Haas Road toward Brown County and areas around the Konkapot Creek corridor. The City currently has an sanitary sewer interceptor pipe extended to south of CTH CE along the Konkapot Creek with a service area shown on the attached in yellow. Extending this pipe along the stream corridor would allow the City to serve approximately 980 Acres. The area to the east of Haas Road, shown in red on the attached map is not serviceable by the City at this time. In order to service some or all of the approximately 3,800 Acres shown, it is likely that a new interceptor sewer would be needed, crossing the Fox River.

Currently, East Central Wisconsin Regional Planning Commission and Heart of the Valley Metropolitan Sewerage District are beginning long range planning for future growth areas and sewer service areas in the Fox Valley. Plan Commission discussions will help steer City staff work with these entities during the planning process.

# **Staff Recommended Action**

Direct Engineering Department to seek proposals for planning of future growth areas, per discussion.
