ORDINANCE NO. 1915-2025

ORDINANCE REPEALING AND REPLACING SECTION 1.55

WHEREAS, City of Kaukauna has changed the number of Wards within the City for voting purposes over the last number of years; and,

WHEREAS, to bring the City of Kaukauna's Ordinance related to the numbered Wards within Aldermanic Districts in the City to be up-to-date with their voting location; and,

NOW THEREFORE, it is ordained by the Common Council of the City of Kaukauna, Wisconsin, that Ordinance Section 1.55 of the Kaukauna Municipal Code be repealed and replaced as follows:

BEFORE REPEAL AND REPLACE

1.55 Voting Places And Aldermanic Districts

Amended Voting Places And Aldermanic Districts

The voting places and aldermanic districts for the city shall be as follows:

- 1. FIRST ALDERMANIC DISTRICT. The First Aldermanic District shall consist of Wards 1, 2 and 3.
- 2. SECOND ALDERMANIC DISTRICT. The Second Aldermanic District shall consist of Wards 4 and 5.
- 3. THIRD ALDERMANIC DISTRICT. The Third Aldermanic District shall consist of Wards 6 and 7.
- 4. FOURTH ALDERMANIC DISTRICT. The Fourth Aldermanic District shall consist of Wards 8, 9, 10, 11 and 12.
- 5. The voting place for Aldermanic Districts 1 and 2/Wards 1, 2, 3, 4, and 5 shall be in the Municipal Services Building. The Voting place for Aldermanic Districts 3 and 4/Wards 6, 7, 8, 9, 10, 11, and 12 shall be in the Street, Parks and Recreation (SPAR) Building.

AFTER REPEAL AND REPLACE

1.55 Voting Places And Aldermanic Districts

Amended Voting Places And Aldermanic Districts

The voting places and aldermanic districts for the city shall be as follows:

1. FIRST ALDERMANIC DISTRICT. The First Aldermanic District shall consist of Wards 1, 2 and 3.

- 2. SECOND ALDERMANIC DISTRICT. The Second Aldermanic District shall consist of Wards 4, and 5, and 16.
- 3. THIRD ALDERMANIC DISTRICT. The Third Aldermanic District shall consist of Wards 6, and 7, and 17.
- 4. FOURTH ALDERMANIC DISTRICT. The Fourth Aldermanic District shall consist of Wards 8, 9, 10, 11, and 12, 13, 14, and 15.
 - a. The voting place for Aldermanic Districts 1 and 2/Wards 1, 2, 3, 4, and 5, and 16, shall be in the Municipal Services Building. The Voting place for Aldermanic Districts 3 and 4/Wards 6, 7, 8, 9, 10, 11, and 12, 13, 14, 15, and 17, shall be in the Street, Parks and Recreation (SPAR) Building.

This ordinance shall be in full force and effect from and after its adoption and publication.

RESOLUTION NO. 2025-5456

A RESOLUTION OF THE COMMON COUNCIL CHANGING POLL LOCATION FOR WARDS 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, AND 17

WHEREAS, the City of Kaukauna did by Ordinance establish where polling locations would be for each ward; and

WHEREAS, Wisconsin Statute Section 5.25(2) provides cities, villages, and towns with populations under 500,000 shall establish polling locations by the governing body; and

WHEREAS, Wisconsin Statute Section 5.25(3) states that polling places shall be established at least 30 days before the election; and

WHEREAS, the City of Kaukauna wishes to utilize only one of the two polling places established in its City Ordinance 1.55(5) for the Spring Primary Election to be held on February 18, 2025; and

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Kaukauna, State of Wisconsin, that the Spring Primary Election held on February 18, 2025, for Wards 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, and 17, shall be changed to the Municipal Services Building located at 144 W. Second Street, Kaukauna, Wisconsin.
