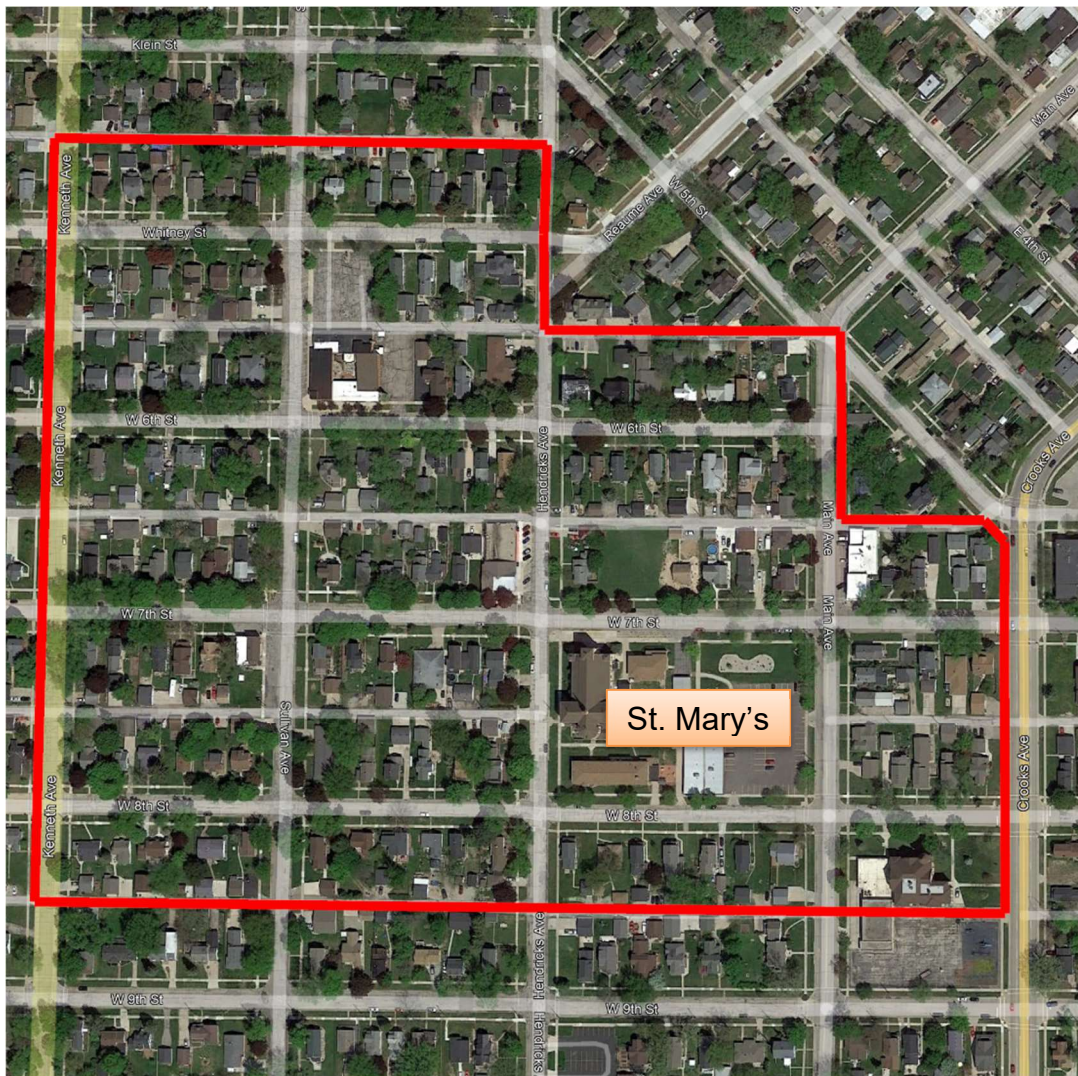
Authorization to seek bids for Project #2-22, Kenneth Avenue Area Utility Relay – 8th Street to Whitney Street

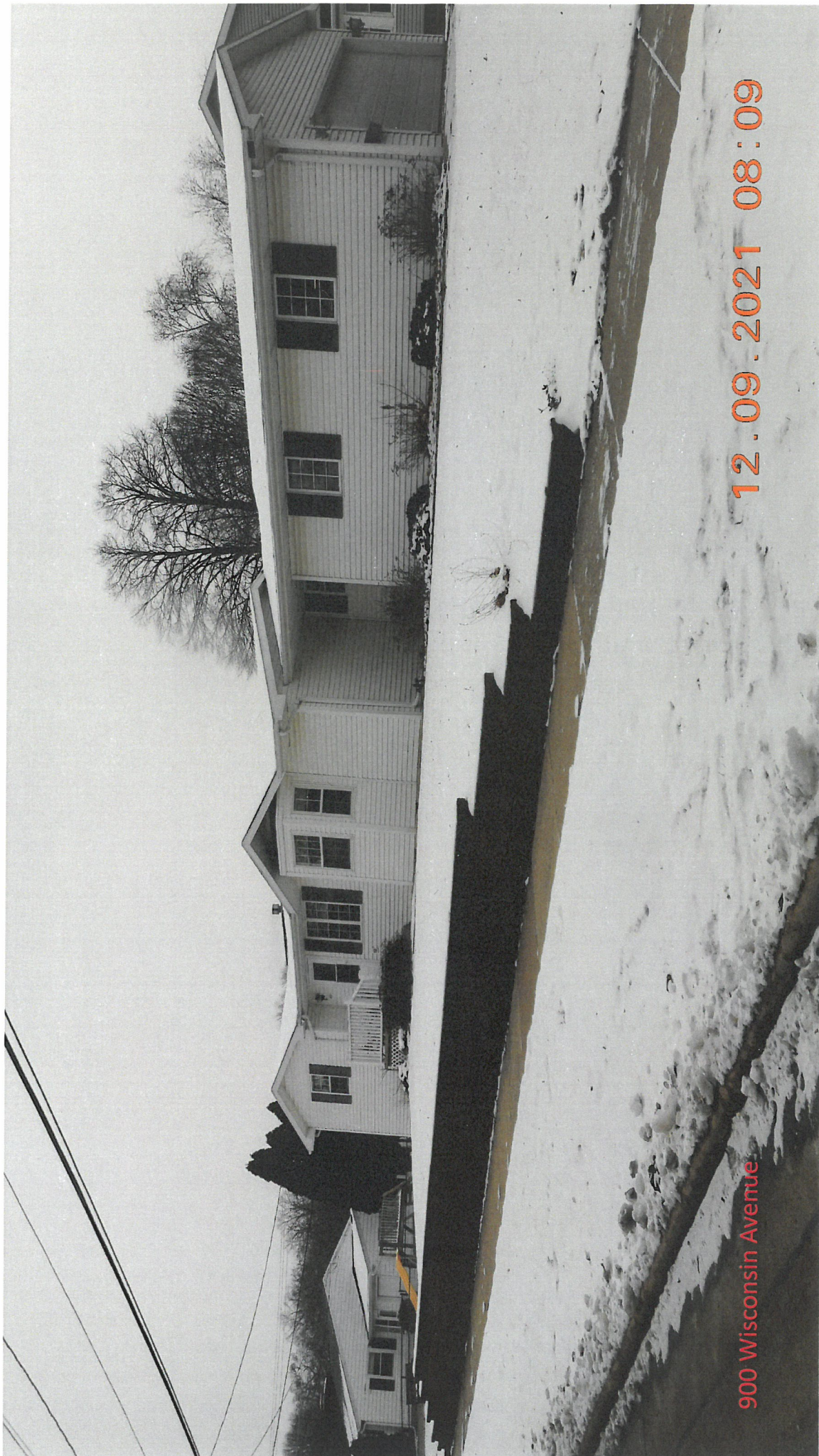
Background
