A meeting of the KATODA Prevention Board was held April 20, 2022, at 6:00pm with remote teleconference via Zoom.

Motion by Wardlow and second by Ald. Schell to approve the March 16, 2022, KATODA Prevention Board minutes. All members present on teleconference via Zoom voted aye. Motion carried.

Discussion was held regarding a financial request from the KHS Senior Class Post Graduation organization for \$500 from the KATODA Board. Motion by Wardlow and second by Dr. Russo to donate \$500 to the KHS Senior Class Post Graduation organization for AODA free activities. All members present on teleconference via Zoom voted aye.
