A meeting of the KATODA Prevention Board was held September 22, 2022, at 6:00pm with remote teleconference via Zoom.

Members present: Jack Pautz, Karen Wirth, Laura Lindberg, Satia Kavanaugh Vanderloop, Chris Wardlow, Scott Granger, Dr. Paul Russo, Jerry Brien and Philip Kohne.

Absent: Ald. Brian Schell, Karleigh Kluever.

Guest: Annie Von Neupert from Community Action for Healthy Living (CAHL).

Motion by Wardlow and second by Lindberg to approve the August 17, 2022, KATODA Prevention Board minutes. All members on the teleconference via Zoom voted aye. Motion carried.

No Financial Business.

Pautz introduced the possibility of creating an ordinance to deal with the Delta 8 and Delta 10. Wardlow shared with the board a sample copy of Wood County, City of Wisconsin Rapids ordinance regarding the mentioned Delta's and marijuana. Discussion was held. Von Neupert mentioned she had been working on this subject in another county. Pautz, Russo, Wardlow and Von Neupert will work up an ordinance draft and bring it back to the board for review.

Wardlow mentioned to the board to beware of currency laying around for it may contain fentanyl on the bills and if held it may be fatal to the holder. Fentanyl the size of a sesame seed is 100 times more potent than morphine. Narcan Training was mentioned prior to the pandemic and will be discussed at a future meeting.

Wirth requested KATODA funds to support events at the schools for Red Ribbon Week. Discussion followed. Red Ribbon Week will be held on the last week in October. Motion by Wirth and second by Dr. Russo to provide \$300 for Red Ribbon Week events in the Kaukauna Schools. All members on the teleconference via Zoom voted aye. Motion carried.

Pautz read an email from Karleigh Kluever mentioning that at their next LEAD Meeting she hopes to find a student to be a member of the KATODA Board. She also mentioned some of the upcoming alcohol-free events that members of LEAD will be doing this year. Such events as bake sales, kids toy drive, going to a corn maize, Brewer games and ice skating at Titletown.

Dr. Russo mentioned about the Annual KATODA Brat Fry on October 15, 2022. The fry will start at 9am to 4pm. Personnel and prices were discussed.

Pautz mentioned to the board of the Wisconsin Alcohol Policy Seminar. Wardlow and Pautz will be attending on behalf of the KATODA Board. Pautz requested funds to pay for the seminar fees.
