Friends of 1000 Islands Report

The Friends met on Monday, August 15th and further discussed tasks associated with planning of the Art Fair. The Friends will have a Food Stand at the Focus on the Fox event on Saturday, September 24th. The Friends made a commitment to give 1000 Islands \$9,000 towards their 2023 budget.

Naturalist's Report

Nowak welcomed the Kaukauna High School Administrators on Monday, August 1st for a team building meeting at 1000 Islands. She reiterated that we are here for teacher's needs.

Education Sub-Committee

Carlson made a motion to receive and put on file the June 13, 2022 Education Sub-Committee meeting minutes. Seconded by White. Motion carried.

Buildings and Grounds Sub-Committee

Ash Tree Stump Removal: The quotes came in under the minimum amount needed for Committee approval, thus item number 9.C.i. can be removed from the agenda. Van Berkel made a motion to remove item 9.C.i. Approve Quote for Grinding Ash Tree Stumps from the August 18, 1000 Islands Committee Meeting agenda. Seconded by Carlson. Motion carried.

HVAC Equipment: Nowak received three quotes (Bassett, Baumgart, Berken) for replacement of the broken units that control the office areas and Conservation Room. The Building & Grounds Sub-Committee reviewed all quotes and made the recommendation to proceed with Berken. Eggleston made the motion to approve the estimate from Berken Heating & Cooling including lines 1 and 2 for the conservation room heating, lines 2, 4 and 5 for the conservation room cooling, lines 1 and 5 for office heating, and lines 2 and 5 for office cooling for a total of \$23,085. Seconded by Carlson. Motion carried.

Broken Concrete Floor: The concrete floor by Jabber's cage/live animal area has expanded and broke the tile flooring causing a safety concern. Nowak worked with John Neumeier to get estimates to remove a strip of the concrete where it has expanded. Staff from the Street Dept. will pour new concrete and replacement flooring will be completed in 2023. The quotes came in under the minimum amount for Committee approval.

Naturalist Report August 2022

Admin/Finance

- I attended the annual budget meeting with Outagamie County. I recapped our accomplishments over the past year and mentioned some of the projects in the works. Meeting attendees were impressed with what we are able to accomplish with a small budget. The proposed budget support from the County is expected to be \$10,000.
- City Council recently approved an updated employee handbook. The employee handbook is part of our policy binder which means updates are needed. Please bring you policy binder in to the Nature Center at your earliest convenience and we will update it for you.

Education

- The Fall's Focus on the Fox event planning is well underway. We are looking for some volunteer for a number of different areas including facilitating some of our activities as well as participating in our River Cleanup. If anyone is interested in helping on September 24, please let me know.
- The annual Fairy Walk program done with the Kaukauna Public Library was back to pre-pandemic attendance levels with a near record 800 attendees this year.
- A new documentary focusing on the Fox River titled "The Power of the River" premiered in both DePere
 and Menasha. 1000 Islands as well as an interview that I gave is featured is a small portion of the
 video. The documentary is available to download on Vimeo and we were given a copy on DVD. We will
 be featuring the video at our Focus on the Fox event.

Building & Grounds

- Berken Heating & Cooling was on-site to replace our failing furnace and air conditioning unit, install an
 air return and insulate ductwork as well as install the new furnace and air conditioning unit. Electrical
 work to power the new equipment still needs to be completed. Berken will return to test and finish the
 project once the electrical work is done.
- We have been working with Concrete Cutters and the City Street Department to schedule the foundation repairs. The concrete cutting is tentatively scheduled for October 6. We will likely close the building on the day of the concrete cutting. If possible, we will keep a portion of the building open to the public before and after the concrete cutting to limit the impact to visitors.
- The City is hosting a League of Municipalities Leadership Training day for all City department heads on October 25th. The training will be held at 1000 Islands as all other meeting facilities in the City were unavailable. We will need to close the building to the public in order to successfully hold the training session.
- A good majority of the ash tree stumps have been ground out and the rest should be taken care of soon. The project has proven to be difficult with the large number of rocks in the ground causing damage to the grinder equipment. After the grinding is complete, we will be working on planting 4 new trees in the picnic area.
