Recommendation to Review and Provide Feedback on the Draft Historic Buildings/Sites Website

Recommendation and Summary

Current Name: Elephant's Perch

Horace Lewis established the Ketchum Fast Freight Line and built the first wagon road over Trail Creek Summit, called the Ketchum-to-Challis Toll Road. He built this home in the early 1880's and was the first residence to have indoor plumbing and a modern bathroom. Horace married Katherine Barry and when the mining boom ended they moved to Seattle. After Horace died in 1911, Kate returned to spend the remainder of her life in this home. Members of the Lewis family lived here until 1967 when it was sold and coverted to commercial use.

Recommendation to Provide Direction on Walking Tour Next Steps

Recommendation and Summary

Staff is recommending the Commission provide feedback and direction to staff on next steps to further the walking tour discussion.

Introduction and History

The Historic Preservation Commission has been in the process of reviewing options for walking tours for the 24 buildings/sites which have been identified as historic. At the 5/03/2022 meeting, the Commission directed staff to reach out the Community Library to gauge their interest in either updating or expanding the existing walking tour already in place. Staff met with Regional History representatives and discussed the possibility of updating the existing walking tour pamphlet. Regional History representatives expressed interest in the possibility of updating the existing walking tour to include more properties on the HPC's list of historic buildings/sites and would be available to meet with interested parties to further discuss the specifics.

Next Steps

Staff will take feedback and direction from the Commission on how to move forward collaborating with the Community Library, Visit Sun Valley, and any other local organizations.



STAFF REPORT KETCHUM HISTORIC PRESERVATION COMMISSION REGULAR MEETING OF JUNE 7, 2022

Introduction and History

The Historic Preservation Commission is in the process of reviewing the draft Historic Preservation Handbook. At the May 03, 2022, meeting of the HPC, commissioners provided feedback on the draft handbooks contents and graphics. The Commission disapproved the formatting, image/graphics selection and other graphic design aspects of the handbook. Staff was directed to identify and reach out to local graphics designers who may be better suited to design the handbook document. Staff has begun to reach out to local graphics designers and will update the HPC on the progression of the search.

Next Steps

Staff will continue to contact local graphics designers to assess their interest/availability in designing the Historic Preservation Handbook moving forward. The results of this search will be brought forward to the HPC at the July 2022 meeting.
