**4. Action on request for rumble strips in the area of Warm Springs Road adjacent to the bike path**

Alison Burpee spoke before the Group about her safety concerns due to the increase in distracted driving on Warm Springs Road, particularly alongside the bike path. Vehicles are speeding, especially in the area where it goes from 30mph to 20mph and texting while driving. Burpee added that drivers are putting adult and children's safety at risk being posed as it stands currently. Riley commented that the engineering of Warm Springs Road is an issue. HDR Engineering has been retained by the City and we have asked them to look at traffic calming options and engineering enhancements from the YMCA to Saddle Rd. Brian Christiansen explained the pros and cons of the use of rumble strips. Jamie Shaw stated that Warm Springs is a specified emphasis patrol area for the Ketchum Police Dept.

**5. Action on public comment from Phyllis Shafran on Ketchum Police cars blocking the sight of traffic for vehicles coming down 5<sup>th</sup> St wanting to turn left on 2<sup>nd</sup> Ave.**

Phyllis Shafran spoke before the Group about driving west on 5<sup>th</sup> Street and if turning left onto 2<sup>nd</sup> Ave she cannot see the traffic coming down 2<sup>nd</sup> Ave without getting into the street. She said if the police cars have to park there, they should park parallel. Riley recommended that the Group combine this item with **Agenda Item Number 8. Action on citizen comments from CSO Wes Whitesell on the safety of parking in the 100 block of 5<sup>th</sup> Street W and the potential of turning diagonal parking into parallel.** Ketchum Community Service Officer Wes Whitesell spoke about the 5<sup>th</sup> Street West crosswalk that goes from alley to alley. He said if someone is walking across and a full sized pickup truck is parked there on the south eastbound lane, the truck will take up almost the whole eastbound travel lane. People coming westbound down the hill and someone coming from the alley at the same time, could be a bad situation. Whitesell thinks that parallel parking would be good for the whole block. Riley said short term they could do all of 5<sup>th</sup> Ave parallel. Suzanne Frick said that it is a dangerous situation for pedestrians as well as vehicles coming up and down the hill. Frick added that URA is funding a study for this entire area and we should be looking at short term and the longer term. Additionally, we want to do outreach to business tenants in the area. Riley stated that there are sight line issues because there is not a 4-way stop there. Maybe short term, a stop sign could be placed there and that would bring traffic in view of each other. Christiansen said that those two parking places are shoved out into the roadway a bit, any cars that park there have a shortened parking area.

**Motion to convert the diagonal parking to parallel parking in between 1<sup>st</sup> Ave and the alley on 5<sup>th</sup> St, on the south side of the street. Ask our engineer to evaluate a stop control intersection at 5<sup>th</sup> St & 2<sup>nd</sup> Ave and also evaluate the appropriateness of a 4-way stop at 6<sup>th</sup> & 2<sup>nd</sup> Ave**
