I saw the latest Word on the Street discussing Multi Use Paths and E-Bikes. Good start, please distribute the flyer to all bike shops, especially rental shops.

I support 20 mph on the Paths for consistency. I live on Warm Springs Rd. and watch all types of things go by and only a few are going 10 mph or less.

I almost always ride my Class 3 E-Bike on the Road, rather than the Path for safety. Too many Maids pushing strollers with a dog, 2 abreast cyclists and short sight distances to cars at intersections.

Please consider changing the Warm Springs Rd. car Speed Limit to 25 MPH and than maybe cars will only go 30 instead of a lot of the 37 mph that I observe.

Please consider outreach to car drivers so they understand that bicycles have as much right to the road as cars. Thanks!

**RE:** Parking on Stirrup Lane

Dear Mayor Bradshaw and Council Members,

This law firm represents the residential property owners on Stirrup Lane, a quiet, residential cul de sac. As you know, my clients object to any parking lot adjacent to Stirrup Lane and to any increase in parking on Stirrup Lane. Several months ago, I filed a successful appeal on behalf of my clients challenging an administrative approval of such a parking lot for the owners of the Bigwood Golf Course. The parking lot was deleted from the administrative approval because it requires an amendment to the CUP; however, now it appears that the owners of the Bigwood Golf Course are once again imposing their parking issues (caused the restaurant construction) onto Stirrup Lane—again without any attempt to meet with and make mutually acceptable arrangements with the Stirrup Lane residents.

Since late June, multiple cars--at times as many as 25--have been parking on both sides of the north end of Stirrup Lane. Drivers are routinely entering my clients' private driveways to turn around. My clients do appreciate the City's putting in "No Parking" signs on the east side of the street and a part of the west side to alleviate the congestion at the Stirrup Lane/Saddle Road/cart path intersections. This was a small step; however, it is a temporary and inadequate response to a much larger problem.

My clients have been told that Zenergy has an arrangement with the owners of the Bigwood Golf Course allowing golf course employees to park in the Zenergy parking lot while Zenergy employees must park their cars on Stirrup Lane and walk from there to work. Such an arrangement and the resulting parking chaos is unacceptable. It is unsafe and unreasonable.

Stirrup Lane is a quiet neighborhood on a cul de sac. There is no developed apron for parking and the entrance to Saddle Road from Stirrup Lane is already one of the most dangerous intersections in the City. Even if there is an actual need for parking, there are many better alternative locations, such the parking lot for the Bigwood Recreation Center and the YMCA parking lot which was acquired to be a park-and-ride lot which could be serviced by a shuttle from Zenergy.

My clients brought this matter to the attention of the City as soon as the problems arose and were planning to address the issue with the Ketchum Traffic Authority on July 17 when the

meeting was abruptly cancelled. My clients have now been told that Zenergy and the owners of the Bigwood Golf Course are working with the City to come up with a new plan which will be discussed at a special meeting of the Traffic Authority. This is also unacceptable. Any public airing of this problem could be delayed until almost the end of the golfing season, which will moot the move to an appropriate solution. My clients are stakeholders. They must be included in this process, and if they are to be excluded, then a public hearing before the Traffic Authority must be held immediately. My clients demand transparency, due process and best practices.

There's not nearly enough room for an emergency vehicle to make its way with one whole lane blocked, constant turning around of vehicles in our driveways, and a shear undeniable disrespect from the City of Ketchum providing very little help to fix this issue. I'm disappointed that the City of Ketchum has been having discussions with both Zenergy management and the Lyles at Bigwood golf course, but no residents on Stirrup Lane were a part of those "discussions." You cancelled the traffic authority meeting for July 17th, and the situation continues to get worse. I understand there's another meeting but honestly, it feels like a stall tactic.

I personally turn onto Stirrup Lane and think what a disaster all parties above have made this. What was a beautiful quiet cul-de-sac street is a busy, unsafe, slap in the face.

We have attempted multiple times to talk to the city, the Lyle's, even Zenergy management, but it leaves us with no response or help. The accidents will happen, and there is no way to say that all parties were not warned.

Hello,


My name is Yuhko Grossmann and I live at 101 Stirrup Lane. My house is the first house as you enter the cul de sac. Our street is not very big, and is strictly residential. However, with the change of ownership of the golf course and recent redevelopment, moreover the arrangement between Big Wood Golf Course and Zenergy for their employees to park on the neighboring residential streets, our small cul de sac has turned into a parking lot. We had written to the city and we appreciate their quick action on the partial restriction of parking on the street. However, unfortunately all this has done is to push the cars further down. The danger this situation presents is unlimited. Reduced to a one lane street, an emergency vehicle would not be able to pass should a car be coming in the opposite direction. My driveway has turned into a turn about for the employees as they enter and exit the street. The parked cars make it difficult for me to see if there is oncoming traffic as my view is blocked. More importantly a small child stepping out between the parked cars, to chase a ball or simply to get out on his bicycle, would have no chance should a car be passing by. The many dogs that belong to the residents can no longer be let free to enjoy their gardens, should they venture to close to the road. Furthermore, turning in and out of Stirrup Lane onto Saddle has become a lottery. With the close proximity to a main highway intersection with cars crossing at speed, this situation has made an already tricky turn even more treacherous.

I attach a photo of cars leaving for the day. You can see cars parked on both sides of the road, as well as one using my driveway to turn around in, in order to exit the cul de sac. I have five grandchildren under the age of five and a dog. As you are aware there was a child recently killed in Sun Valley by a car pulling into a driveway. You can imagine the concern for the safety of my family, this situation has created. We can no longer enjoy the use of our own private property, to play on the front lawn and garden area or move freely in our driveway, without having to worry about a child or our dog getting hit by a car.

For the safety and well being of our families, this situation is simply unacceptable. Parking on Stirrup Lane should be limited to residents only with permit parking. Before we have our first casualty, I beg the city to take immediate action. Please add us to the agenda of your upcoming Ketchum Traffic Authority meeting July 17.

We'd like to get on the agenda. How can we do this? In the meantime:

My name is Christine Davis, and my husband and I live at 130 Stirrup Ln, Ketchum, ID 83340. This is my 3rd letter to the city regarding our concerns about Stirrup Lane and the excessive cars, trucks, and maintenance vehicles that continue to create a major safety issue on our residential street.

Zenergy and Big Wood Golf Course employees are now being directed to park on our streets. There is conflicting information regarding who directed the employees 20+ cars to line Stirrup Lane every day. I am writing to you a 3rd time about this issue, because it continues to get worse and worse. I know you are receiving plenty of notification about these concerns from multiple people, but we aren't seeing solutions that are solving the problem. I'd welcome the city's expertise and guidance, rather than silence.

Big Wood and Zenergy are evidently experiencing a busy summer, but why should that be at our expense and safety? Stirrup Lane has become a dumping ground for personal maintenance crew parking, maintenance vehicle traffic, and now employee parking? Trails like Proctor and Chocolate Gulch have "no trail parking signs." I'd suggest we do the same for our streets with "No Zenergy or Big Wood Parking" signs. Seems pretty simple really, but we'd like to hear from you on your suggestions to rectify this dangerous and problematic situation.

Finally, I truly hope that we don't get to a point where it's too late, and we sadly experience a catastrophe because the city and such businesses choose to ignore the inevitable - we will have accidents, we will continue to put people in danger if something doesn't change now. Whether it's Stirrup Lane residents, visitors, golfers, gym goers, employees - no one needs to get hurt, so I plead with you to help keep our street safe.

Hello,

My name is Yuhko Grossmann and I live at 101 Stirrup Lane. My house is the first house as you enter the cul de sac. Our street is not very big, and is strictly residential. However, with the change of ownership of the golf course and recent redevelopment, moreover the arrangement between Big Wood Golf Course and Zenergy for their employees to park on the neighboring residential streets, our small cul de sac has turned into a parking lot. We had written to the city and we appreciate their quick action on the partial restriction of parking on the street. However, unfortunately all this has done is to push the cars further down. The danger this situation presents is unlimited. Reduced to a one lane street, an emergency vehicle would not be able to pass should a car be coming in the opposite direction. My driveway has turned into a turn about for the employees as they enter and exit the street. The parked cars make it difficult for me to see if there is oncoming traffic as my view is blocked. More importantly a small child stepping out between the parked cars, to chase a ball or simply to get out on his bicycle, would have no chance should a car be passing by. The many dogs that belong to the residents can no longer be let free to enjoy their gardens, should they venture to close to the road. Furthermore, turning in and out of Stirrup Lane onto Saddle has become a lottery. With the close proximity to a main highway intersection with cars crossing at speed, this situation has made an already tricky turn even more treacherous.

I attach a photo of cars leaving for the day. You can see cars parked on both sides of the road, as well as one using my driveway to turn around in, in order to exit the cul de sac. I have five grandchildren under the age of five and a dog. As you are aware there was a child recently killed in Sun Valley by a car pulling into a driveway. You can imagine the concern for the safety of my family, this situation has created. We can no longer enjoy the use of our own private property, to play on the front lawn and garden area or move freely in our driveway, without having to worry about a child or our dog getting hit by a car.

For the safety and well being of our families, this situation is simply unacceptable. Parking on Stirrup Lane should be limited to residents only with permit parking. Before we have our first casualty, I beg the city to take immediate action. Please add us to the agenda of your upcoming Ketchum Traffic Authority meeting July 17.

Zenergy and Big Wood Golf Course employees are now being directed to park on our streets. There is conflicting information regarding who directed the employees 20+ cars to line Stirrup Lane every day. I am writing to you a 3rd time about this issue, because it continues to get worse and worse. I know you are receiving plenty of notification about these concerns from multiple people, but we aren't seeing solutions that are solving the problem. To Streets and Facilities, City of Ketchum:

My name is Carole Klein. I reside at 670 2<sup>nd</sup> Street East, aka The Lodges at Trail Creek.

I am submitting this request on behalf of myself and the other four homeowners at The Lodges at Trail Creek.

There are five homes in our 670 complex. And there are ten homes in the neighboring complex at 600 2<sup>nd</sup>Street East.

600 and 670 share a driveway from which we access 2<sup>nd</sup> Street between Walnut and Spruce Avenues.

We are asking the City of Ketchum to remove the parking space just west of the common driveway and place a barrier that makes it clear to drivers that that area is not a parking space.

A mid-size sedan or SUV parked in the space limits the ability of a driver exiting the driveway to see oncoming traffic from the west until the driver is well into the path of that traffic. A parked vehicle also obstructs visibility for eastbound drivers turning into the driveway from 2<sup>nd</sup> Street.



Sometimes this space is occupied by an RV or a truck with a camper top, which obstructs the line of sight even more.

Your implementation of this request will reduce the risk of a collision for the fifteen homeowners, family members, guests, landscapers, delivery drivers, workers and anyone else who drives in or out of our residences.

Implementation will also reduce the risk to eastbound drivers on 2<sup>nd</sup> Street, a popular alternative to Sun Valley Road.

As you weigh risk vs. benefit, we hope you'll conclude that driver safety strongly outweighs the value of a single parking space among many on both sides of 2<sup>nd</sup> Street between Walnut and Spruce Avenues.

We hope you will take this matter up as soon as possible and implement a resolution in favor of enhanced driver safety.

**RE:** Parking on Stirrup Lane

Dear Mayor Bradshaw and Council Members,

This law firm represents the residential property owners on Stirrup Lane, a quiet, residential cul de sac. As you know, my clients object to any parking lot adjacent to Stirrup Lane and to any increase in parking on Stirrup Lane. Several months ago, I filed a successful appeal on behalf of my clients challenging an administrative approval of such a parking lot for the owners of the Bigwood Golf Course. The parking lot was deleted from the administrative approval because it requires an amendment to the CUP; however, now it appears that the owners of the Bigwood Golf Course are once again imposing their parking issues (caused the restaurant construction) onto Stirrup Lane—again without any attempt to meet with and make mutually acceptable arrangements with the Stirrup Lane residents.

Since late June, multiple cars--at times as many as 25--have been parking on both sides of the north end of Stirrup Lane. Drivers are routinely entering my clients' private driveways to turn around. My clients do appreciate the City's putting in "No Parking" signs on the east side of the street and a part of the west side to alleviate the congestion at the Stirrup Lane/Saddle Road/cart path intersections. This was a small step; however, it is a temporary and inadequate response to a much larger problem.

My clients have been told that Zenergy has an arrangement with the owners of the Bigwood Golf Course allowing golf course employees to park in the Zenergy parking lot while Zenergy employees must park their cars on Stirrup Lane and walk from there to work. Such an arrangement and the resulting parking chaos is unacceptable. It is unsafe and unreasonable.

Stirrup Lane is a quiet neighborhood on a cul de sac. There is no developed apron for parking and the entrance to Saddle Road from Stirrup Lane is already one of the most dangerous intersections in the City. Even if there is an actual need for parking, there are many better alternative locations, such the parking lot for the Bigwood Recreation Center and the YMCA parking lot which was acquired to be a park-and-ride lot which could be serviced by a shuttle from Zenergy.

My clients brought this matter to the attention of the City as soon as the problems arose and were planning to address the issue with the Ketchum Traffic Authority on July 17 when the

meeting was abruptly cancelled. My clients have now been told that Zenergy and the owners of the Bigwood Golf Course are working with the City to come up with a new plan which will be discussed at a special meeting of the Traffic Authority. This is also unacceptable. Any public airing of this problem could be delayed until almost the end of the golfing season, which will moot the move to an appropriate solution. My clients are stakeholders. They must be included in this process, and if they are to be excluded, then a public hearing before the Traffic Authority must be held immediately. My clients demand transparency, due process and best practices.
