





General Fund




The General Fund revenues are up approximately \$1,713,341 (17.5%) in FYTD compared to FY2020. This increase is largely due to three revenue sources, property tax, planning and building fees and state shared grants.







The General Fund expenditures are up 1,637,485 (19%) FYTD. The increase is due to New Fire Station construction and New City Hall remodel.




LOT Analysis



Revenue to the Original LOT Fund is up approximately \$569,991 (28.1%) FYTD. This increase is largely due to retail, condo and building material receipts.




Original LOT for May month of sale are up approximately 28.3% compared to last year and up approximately 52% compared to the prior three-year average.



To date in FY 21 (10 months), Original LOT collections have been generated by each sector as follows:


- 1. Retail has generated 61% of the total.
- 2. Building Materials have generated 13.8%.
- 3. Liquor has generated 8.3%
- 4. Rooms have generated 8%.
- 5. Condominiums have generated 9%.



Through the first 10 months of FY 21, collections compared to the prior three-year average are as follows:

- 1. Retail is up 18.9%.
- 2. Rooms are down 14.2%.
- 3. Condominiums are up 55.2%
- 4. Liquor is down 0%.
- 5. Building Materials are up 27.4%.


Revenues from Original LOT covered sales are up approximately 52.2% compared to the average of the prior three years.




Off-Street Parking Lots

Recommendation to Approve Alcohol Beverage Licenses

Recommendation and Summary

Staff is recommending the council to approve the license and adopt the following motion:

I move to approve Alcohol Beverage Licenses for the applicants included in the staff report.

The reasons for the recommendation are as follows:

- Ketchum Municipal Code Requires certain licenses to sell liquor, beer or wine.
- At this time, the application is for the period of September 1, 2021 July 31, 2022, the Council approval is requested to complete the process of issuing such beer, wine and liquor licenses.

Introduction and History

In accordance with Municipal Code 5.04.020, Alcoholic Beverage Sales, it is unlawful for any person to sell liquor, beer, or wine at retail or by the drink within the City without certain licenses as required pursuant to Ordinance 367. All City licenses for liquor, beer, and wine expire annually and require renewal by August 1st. Renewal for 2021 has been extended to September 1. The businesses will be vending beer, wine and liquor on premise (wine is included in the liquor fees) and not to be consumed on premise, per application.

<u>Analysis</u>

At this time, the following businesses have filed for their license and Council approval is requested to complete the process of issuing such beer, wine and liquor licenses.

• The City of Ketchum will realize revenue of \$5028.74 from approval of these licenses in accordance with the current fee structure.

Recommendation and Summary

Staff is recommending the council Adopt the following Resolution:

"I move to approve the Communications Facility Lease with the Sun Valley Company for existing communications equipment and authorize the Mayor to sign said lease."

The reasons for the recommendation are as follows:

- The main radio communications for the Ketchum Fire Department is located on Sun Valley Company.
- This lease replaces the previous lease that included Ketchum Rural Fire District.

Introduction and History

The fire department operates from a repeater located on Bald Mountain, in a facility owned by Sun Valley Company. This agreement has been in place for many years. While the license and EQ are owned by the City of Ketchum, the lease was previously executed under the Ketchum Rural Fire District. Since the land is leased from the US Forest Service, the site must comply with USFS rules. This includes having the site lease in the name of the FCC license holder, which is the City of Ketchum.

Sustainability Impact No impact.

Financial Impact

In the past, the lease fee was paid by the Ketchum Rural Fire District, and the City reimbursed KRFD 50% of the fee. Henceforth, the City will pay the lease fee and bill other users as needed.

<u>COMMUNICATIONS FACILITY LEASE</u> (Existing Structure and Ground Space)

This Lease is made and entered into as of April 19, 2021, by and between Sun Valley Company, a Wyoming corporation with an address at PO Box 10, Sun Valley, Idaho 83353, (hereinafter referenced to as "Landlord") and the City of Ketchum. with an address at 480 East Ave North, P O Box 966, Ketchum Id. 83340 (hereinafter referenced to as "Tenant").

WHEREAS, Landlord is sole permittee operating on property known as Bald Mountain Communications' Facility, County of Blaine, State of Idaho (the "Property"), which is more particularly described in Exhibit A attached hereto, upon which is located an existing structure described as a guide tower (the "Structure").

WHEREAS, Tenant desires to lease a portion of the Property for Tenant's transmission and receipt of radio-telephone and other electrical signals.

In consideration of the mutual promises, conditions, and other good and valuable consideration of the parties hereto, it is covenanted and agreed as follows:

I. <u>Lease</u>. Landlord hereby leases to Tenant that certain parcel described as the "Premises," in Exhibit B, which is attached hereto and incorporated herein by reference, together with unrestricted access for Tenant's uses from the nearest public right-of-way, on the terms and conditions of this Lease.

2. <u>Survey/Site Plan.</u> Tenant may, at Tenant's expense, cause a survey, site plan, and/or legal description of the Premises to be prepared, to further delineate and identify the land underlying the Premises, and to attach the same as exhibits to this Lease.

3. <u>Use of Premises.</u> It is understood that Tenant intends to use the Premises and the licenses granted hereunder for the purpose of installing and operating antennas and related equipment ("Tenant's Facilities") for the transmission and receipt of radio-telephone and other electrical signals; such use includes the right to install and operate antennas, an equipment cabinet, cables and other connections between the Tenant's equipment and antennas, and any other items necessary to the successful and secure operation of Tenant's Facilities. Tenant has the right to modify, supplement, replace, upgrade, expand the equipment, increase the number of antennas or relocate Tenant's Facilities within the Premises at any time during the term of this Lease. Tenant's use of the Premises shall at all times comply with and conform to all laws and regulations applicable thereto. All Mountain Travel must be coordinated with Sun Valley Co. Mountain Department at 208 622-6151.

4. <u>Term of Lease.</u> The lease term will be five (5) years (the "Initial Term"), commencing upon the Commencement Date. The Initial Term will terminate on the last day of the month in which the fifth (5th) annual anniversary of the Commencement Date occurred.

5. <u>Option to Renew.</u> Tenant shall have the option to renew this Lease for one (1) tern of five (5) years, upon a continuation of all the same provisions hereof the acceptance of this renewal option must be received in writing by certified mail or nationally recognized courier service and received by Landlord at least three (3) months prior to the expiration of the Initial Term of this Lease. Each renewal will increase by 2.5% over previous term.

6. <u>Termination</u>. If this Lease is terminated rent and other charges shall be prorated as of the date of termination.

7. <u>Rent.</u> Commencing on January 1, 2022, the Commencement Date, Tenant shall pay rent to the Landlord in the amount of \$2,560.00 per year, which shall be due annually thereafter. Landlord shall specify the name, address, and taxpayer identification number of a sole payee (or maximum two joint payees) who shall receive rent on behalf of the Landlord. Rent will be prorated for any partial year.

8. <u>Adjusted Rent.</u> On every anniversary of the Commencement Date of this Lease, rent shall be increased by three percent (2.5%) of the previous year's rent.

9. <u>Utilities.</u> Landlord shall provide primary A/C power. Tenant may install an emergency battery bank on the Premises and operate such standby systems during times when commercial power is not available.

10. Non-Interference. (a) If there are existing radio frequency user(s) on the Property, then within 20 days after the date of this Lease Landlord will provide Tenant with a list of all existing radio frequency user(s) and their respective frequencies to allow Tenant to evaluate the potential for interference. Tenant warrants that its use of the Premises will not interfere with such existing radio frequency users on the Property as long as the existing radio frequency user(s) operate and continue to operate within the frequencies disclosed to Tenant as provided above and in accordance with all applicable laws and regulations. (b) Landlord will not grant, after the date of this Lease, a lease, license or any other right to any third party for the use of the Property, if such use may in any way adversely affect or interfere with Tenant's Facilities. Landlord will notify Tenant and receive Tenant's written approval prior to granting any third party the right to install and operate communications equipment on the Property. Nothing contained herein will restrict Tenant nor its successors and assigns from installing and modifying its communications equipment. (c) Landlord will not use, nor will Landlord permit its employees, tenant, licensees, invitees or agents to use, any portion of the Property in any way which interferes with the operations of Tenant or the rights of Tenant under this Lease. Landlord will cause such interference to cease upon not more than twenty-four (24) hour notice from Tenant. In the event any such interference to Tenant's operations does not cease within the aforementioned cure period then the parties acknowledge that Tenant will suffer irreparable injury, and therefore, Tenant will have the right in addition to any other rights that it may have a law or in equity, for Landlord's breach of this Lease, to elect to enjoin such interference or to terminate the Lease upon notice to Landlord. Tenant Interference Study enclosed as part of this lease.

11. <u>Compliance with FCC Radio Frequency Emissions Requirements.</u> Tenant agrees to comply with all Federal Communications Commission ("FCC") rules pertaining to its operations on the Premises, including those pertaining to radio frequency exposure. Landlord shall require all other communications tenants of the Property to bear the same responsibility. If a subsequent communications tenant of the Property causes the radio frequency levels at the Premises and surrounding vicinity exceeding exposure levels set by the FCC, Landlord shall require that such tenant shall take all steps necessary to meet FCC compliance levels.

12. <u>Property Taxes</u> and Government Fees: Tenant shall pay the personal property taxes and all other government fees levied against Tenant's Facilities and the Landlord shall be responsible for the real estate taxes levied against the Property.

13. <u>Repairs.</u> Tenant shall be responsible for all repairs of Tenant's Facilities, and may at its own expense alter or modify Tenant's Facilities to suit its needs consistent with the intended use of the Premises.

14. <u>Mutual Indemnification</u>. Tenant shall indemnify and hold Landlord harmless from and against any loss, damage, or injury caused by, or on behalf of, or through the fault of the Tenant or its employees or agents, or directly resulting from the installation, use, maintenance, repair or removal of Tenant's Facilities upon the Property. Landlord shall indemnify and hold Tenant harmless from and against any loss, damage, or injury caused by, or on behalf of, or through the fault of the Landlord or its employees or agents. Nothing in this Article shall require a party to indemnify the other party against such other party's own willful misconduct or negligence. Notwithstanding anything to the contrary in this Lease, each of Tenant and Landlord hereby waives any claims that they may have against the other with respect to consequential, incidental or special damages.

15. <u>Insurance.</u> Tenant shall continuously maintain in full force and effect a policy of commercial general liability insurance with limits of not less than One Million Dollars combined single limit for bodily injury or death/property damage arising out of any one occurrence covering Tenant's work and operations upon the Property, and commercially reasonable property and casualty insurance covering Tenant's Facilities.

Landlord shall continuously maintain in full force and effect throughout the term of this Lease commercially reasonable liability insurance and commercially reasonable property and casualty insurance.

Neither party shall be liable to the other (or to the other's successors or assigns) for any loss or damage caused by fire or any of the risks enumerated in a standard fire insurance policy with an extended coverage endorsement, and in the event of insured loss, neither parties' insurance company shall have a subrogated claim against the other. If this waiver would invalidate policy coverage under applicable law, this waiver shall be valid only if the insurance policy in question expressly permits waiver of subrogation or if the insurance company agrees in writing that such a waiver will not affect coverage under the policies. Each party agrees to use best efforts to obtain such an agreement from its insurer if the policy does not expressly permit a waiver of subrogation. 16. <u>Monetary Default.</u> Tenant shall be in default of this Lease if Tenant fails to make a payment of rent when due and such failure continues for thirty (30) days after Landlord notifies Tenant in writing of such failure.

17. <u>Opportunity to Cure Non-Monetary Defaults.</u> If Landlord or Tenant fails to comply with any non-monetary provision of this Lease which the other party claims to be a default hereof, the party making such claim shall serve written notice of such default upon the defaulting party, whereupon a grace period of sixty (60) days shall commence to run during which the defaulting party shall undertake and diligently pursue a cure of the default. Such grace period shall automatically be extended for an additional sixty (60) days, provided the defaulting party makes a good faith showing that efforts toward a cure are continuing.

18. Transferability of Tenant's Interest. Tenant's interest under this Lease may be freely assigned in connection with the transfer of Tenant's authorization to operate Tenant's Facilities at the Site. Landlord understands and agrees that Tenant's interest in this Lease has been or will be assigned from time to time for security purposes as collateral in loan documents between Tenant and lenders. Landlord has no right to consent to such assignment, and in the event of Tenant's default of any such loan documents, Landlord will acknowledge any substitute tenant resulting from a foreclosure of a security interest as the Tenant under this Lease. Any other assignment of this Lease by Tenant shall require Landlord's prior written consent, which consent Landlord agrees, shall not unreasonably be withheld. Furthermore, no assignment shall be effected pursuant to this Section unless Tenant shall notify Landlord in writing setting forth the name, address and telephone number of such assignee. Upon the effective date of any permitted assignment, Tenant will be relieved of all future performance. liabilities and obligations under this Lease.

19. <u>Subleasing</u>. Tenant shall not sublet or grant licenses to use, all or any portion of Tenant's Facilities and/or the Premises without Landlord's prior written consent, which consent shall not be unreasonably withheld, conditioned or delayed.

20. <u>Execution of Other Instruments.</u> Landlord agrees to execute, acknowledge, and deliver to Tenant other instruments respecting the Premises, as Tenant or Tenant's lender may reasonably request from time to time, provided that any such instruments are in furtherance of, and do not substantially expand, Tenant's rights and privileges herein established. Such instruments may include a memorandum of lease which may be recorded in the County Recorder's Office. Landlord also agrees to reasonably cooperate with Tenant's efforts to obtain all private and public consents related to Tenant's use of the

Premises, as long as Landlord is not expected to bear the financial burden of any such efforts.

21. <u>Removal of Tenant's Facilities</u>. Tenant's Facilities are agreed to be Tenant's personal property and shall never be considered fixtures to the real estate. Tenant shall at all times be authorized to remove Tenant's Facilities from the Premises. Within sixty (60) days after the expiration or earlier termination of this Lease, Tenant shall, if requested by Landlord and at Tenant's expense, remove any of Tenant's Facilities located above ground from the Premises. If Landlord does not notify Tenant that Tenant must remove such Tenant's Facilities within thirty days (30) after expiration or earlier termination of this Lease, then Tenant shall have the option of either removing or abandoning such Tenant's Facilities, and in any event Tenant shall be entitled to abandon all footings, foundations, and other below-ground portions of Tenant's Facilities in place.

22. Warranties. Recommendation and Summary

"I move to authorize the Mayor to sign Encroachment Agreement 20645 with Idaho Power."

The reasons for the recommendation are as follows:

- The encroachment is necessary to provide underground power to the new Warm Spring Ranch subdivision
- The encroachment will have no impact on pedestrian or public access

Introduction and History

Idaho Power would like to install approximately 50 ft. of underground power lines and conduit within the public Right-of-Way of Warm Springs Road and approximately 375 ft. of underground power lines and conduit within the public Right-of-Way of Bald Mountain Road. Underground power lines not located with public Rights-of-Way will be located within private utility easements. The proposed power infrastructure also includes the installation of new pad mountain transformers and a sector box on private property. Placement of the power infrastructure on private property will be a separate review through the Planning Department to ensure compliance with applicable zoning codes.

<u>Analysis</u>

Engineering and Streets have reviewed the layout of the proposed utilities. No above grade facilities are proposed within the City's Right-of-Way and as proposed do not impact public access or maintenance.



Introduction and History



Recommendation to approve Right-of-Way Encroachment Agreement 20656 for placement of a snowmelt driveway in the City Right-of-Way at 116 Sage Road.

Recommendation and Summary

Staff is recommending Council approve the attached Encroachment Agreement and adopt the following motion:

"I move to authorize the Mayor to sign Encroachment Agreement 20656 with Colin and Martha Moseley."

The reasons for the recommendation are as follows:

- The improvements will not impact the use or operation of the residential street
- The improvements will not impact drainage within the City ROW
- The improvement is necessary for access to the property

Introduction and History

A Right-of-Way Encroachment Permit request was received for a snowmelt driveway within the City's Right-of-Way at 116 Sage Rd.

Right-of-Way standards were developed to achieve goals of drainage, parking, snow storage, access for emergency vehicles, and provide materials that can be reasonably maintained by the city. Pavers, snowmelt systems, and subsurface drip irrigation systems are not maintained by the City but may be approved through an encroachment agreement.

City code requires a right-of-way encroachment permit for any permanent encroachment in the public rightof-way. These agreements are intended to help protect the City in the event the proposed encroachments were to ever pose an issue requiring repair, relocation, or removal of the encroachment.

<u>Analysis</u>

The proposed encroachments were determined not to impact public access or city operations.

Financial Impact

There is no financial impact resulting from approval of this encroachment agreement.

RECITALS

WHEREAS, Owner is the owner of real property described as 116 Sage Road ("Subject Property"), located within the City of Ketchum, State of Idaho; and

WHEREAS, Owner wishes to permit placement of a snowmelt system under an asphalt driveway within the right-of-way on Sage Road. These improvements are shown in Exhibit "A" attached hereto and incorporated herein (collectively referred to as the "Improvements"); and,

In consideration of Ketchum allowing Owner to maintain the Improvements in the public right-of-way, Owner agrees to indemnify and hold harmless Ketchum from and against any and all claims of liability for any injury or damage to any person or property arising from the Improvements constructed, installed and maintained in the public right-of-way. Owner shall further indemnify and hold Ketchum harmless from and against any and all claims arising from any breach or default in the performance of any obligation on Owner's part to be performed under this Agreement, or arising from any negligence of Owner or Owner's agents, contractors or employees and from and against all costs, attorney's fees, expenses and liabilities incurred in the defense of any such action or proceeding brought thereon. 





Direction To Staff on Funding Request for Undergrounding Power Lines at 404 Broadway

Recommendation and Summary

Staff is seeking direction from Council on a request to fund a portion of the undergrounding of power lines along Broadway Boulevard north of Sunnyside Drive.

- In 2016 the City Council established a process and prioritization for providing city funding assistance for undergrounding power lines. The City Council would consider requests for funding.
- In July 2019 the City Council agreed to fund \$365 for a portion of the study for undergrounding the power lines. The Council did not commit to funding the undergrounding work.

Introduction and History

On July 1, 2019, the City Council agreed to fund \$365, or 25% of the cost to study and identify the cost for undergrounding the power lines at 404 Broadway (Attachment A). The Council did not commit to the second phase of funding the construction costs for undergrounding. Council funding decisions occur in two steps, the first is funding for the engineering study, the second step occurs once the engineering study is complete and all costs are identified. Applicants return to Council for a decision on construction funding.

The property owners proceeded with the construction work and are now asking for city reimbursement for 10% of the construction costs, or \$2,690 (Attachment B). Total cost of construction was \$26,901. Staff is requesting Council direction if city funding will be authorized for the construction work.

<u>Analysis</u>

The proposed work is in a residential zone. The priority areas approved by the City Council in 2016 were identified as:

- 1. Community Core
- 2. Tourist
- 3. All Residential Zones

Financial Impact

There is currently \$79,000 in the budget for undergrounding projects. The Council has committed \$30,000 to assist with the undergrounding work requested by Andrew Castellano at 760 Washington.

In May 2016 the City Council identified the available funding and process for city participation in undergrounding power requests. The Council further clarified the funding priorities in December 2016 (Attachment B).

<u>Analysis</u>

The proposed work is located in a residential zone. The priority areas approved by the City Council in 2016 were identified as:

- 1. Community Core
- 2. Tourist
- 3. All Residential Zones

The cost of the analysis is identified as \$1,425. City guidelines identify a 25% city cost share for the study for projects in the community core, tourist and residential zones. If Council approves financial participation, the cost to the City would be \$356.25. Council funding decisions occur in two steps, the first is funding for the engineering study, the second step occurs once the engineering study is completed and all costs are identified. Applicants return to Council for a decision on construction funding.

Financial Impact

There is currently \$180,000 budgeted toward city participation in undergrounding projects. There are several projects under consideration, undergrounding in the alley between 7th and 8th Streets just west of Warm Springs Road, and undergrounding in the alley between 5th and 6th Street just east of Second Avenue. Should this request be approved, there would be no financial impact.








Parcel Information Map

Idaho Power Franchise Fee

In November 2003 Ketchum residents approved an Idaho Power franchise fee increase from one percent to three percent for the purpose of undergrounding overhead electric facilities. This application is for city funding of undergrounding projects initiated by the public.

Funding Available from City

Annual funding from the city will be capped at a maximum of 25% of the annual franchise fee revenues, however city council will have the ability to increase the funding by allocating unused funds rolled over from a previous year.

The maximum amount of city funding that can be allocated to projects depends on the zone in which the project is located. Since undergrounding electric facilities primarily benefits private property owners the maximum amount of city funding for a project is 25%. The remaining amount of funding for the project must come from other sources, such as private funding or through a Local Improvement District (LID) or Business Improvement District (BID) initiated by petition. Table 1 shows the maximum city funding for an electric facility undergrounding project by zone.

*City contribution would be limited to the percentage listed of the actual costs, or the percentage listed of the estimated cost at the time of annual budgeting, whichever is less. If actual construction costs exceed the estimated construction cost at the time of city budgeting the applicant would be required to cover cost increases through other funding.

Selection Criteria

In order to focus city funding in areas with the most visibility and impact to the public the city will prioritize undergrounding funding as follows:

- 1. Community Core
- 2. Tourist
- 3. All Residential Zones

Projects within each zone would be further prioritized based on the following criteria:

- Beneficial to multiple properties
- Improving view corridor for visitor & resident experience
- City infrastructure needs

Funding Process and Timeline

Applicants complete the attached application and submit the application to the city by February 1st. The application schedule would coincide with the city's annual budgeting schedule so that council can consider undergrounding requests along with other city infrastructure needs. The following graphic shows an annual schedule by which applications will need to be received by the city. Funding for the project(s) would not occur until the start of the following fiscal year and city funds would not be issued until the applicant has secured other funding for the projects.

Request to Conduct First Reading of Ordinance #1223 and Approve Resolution #21-016

Recommendation and Summary

The current voter approved Local Option Tax (LOT) ordinance does not specify community housing as an eligible expense. The City Council has recently expressed interest in amending the current LOT to allow community housing as an eligible expense. Under state law, the city must transmit ballot language to the county clerk no later than September 13th for the November 2nd election. Resolution #21-016 calls for the election and transmit ballot language to the county clerk.

Motion #1 - "I move to approve first reading of Ordinance #1223." Motion #2 – "I move to approve Resolution #21-016"

Introduction and History

The current Local Option Tax (LOT) was approved on November 8, 2011 for a fifteen year period. The following are list of eligible expenses: municipal transportation, open space acquisition/recreation, capital improvements, emergency services, city/visitor promotion, property tax relief and costs related to collecting/enforcing the tax.

The proposed ballot language would <u>not</u> alter the percentages of taxes collected. Staff reviewed the following three scenarios based on Fiscal Year 2020 financial performance:

- Scenario #1 increase <u>all categories</u> to align with the City of Sun Valley would have resulted in \$1,848,064 in additional revenues.
- Scenario #2 increase in <u>retail only</u> to align with Sun Valley resulting in \$1,526,633.
- Scenario #3 increase <u>hotel/condos</u> to align with Sun Valley resulting in \$200,476.

Staff is recommending a two-phase approach regarding LOT funding for community housing. First, ask voters to add community housing as an eligible expense this November. The city is currently working to retain a consultant to assist with the creation of a city housing strategic plan in partnership with the Blaine County Housing Authority. A key outcome of this activity will be to set a city goal/target of both preservation of existing units as well as construction of new units for the next ten years. Financial modeling will be completed to understand both total costs as well the level of local governmental resources required to achieve the ten-year goal. Completion of this activity will allow

the city to return to voters the following November to request an increase in all or certain categories of the LOT collection.

Two other options for consideration: (1) ask voters to approve both changes this November or (2) wait and place both questions on the next May or November election dates. Staff is concerned with the first option as it does not give adequate time to conduct stakeholder/public outreach regarding changes to the collection percentages prior to the September 13th ballot language date.

It is important to note that State law (50-1044) does place restrictions regarding the frequency in which changes can be presented to voters. *"No local-option non property tax proposal may be presented to resort city voters for approval or modification for a period of eleven (11) months after an election to approve or disapprove such tax."*

Sustainability Impact

An increase in the supply of community housing will decrease local workers trip generation and associated carbon footprint.

<u>Financial Requirement/Impact</u> The proposed ballot language does not alter the percent of collection.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, CALLING AN ELECTION FOR THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY THE QUESTION OF ADOPTING A LOCAL OPTION TAX ORDINANCE AMENDMENT MODIFYING THE PURPOSES FOR WHICH LOCAL OPTION TAX REVENUES MAY BE USED TO ADD "WORKFORCE/COMMUNITY HOUSING PROVISION AND SUPPORT" AS AN AUTHORIZED USE; ESTABLISHING THE DATE OF THE ELECTION; PROVIDING FOR ADMINISTRATION OF THE ELECTION; APPROVING A FORM OF BALLOT PROPOSITION; PROVIDING FOR REGISTRATION OF VOTERS; PROVIDING FOR RELATED MATTERS; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Ketchum, Idaho (the "City"), is a municipal corporation duly organized and operating under the laws of the State of Idaho; and

WHEREAS, Sections 50-1044 to 50-1049, inclusive, Idaho Code, as amended, authorize the voters of resort cities (as defined in Section 50-1044, Idaho Code) to authorize their city government to adopt, implement and collect local-option non-property taxes; and

WHEREAS, it has been determined by the City Council of the City (the "Council") that the City is a resort city and has a population less than 10,000; and

WHEREAS, the Council has determined that visitors and travelers to the City place an undue burden upon the taxpayers of said City and that the question of the imposition of a localoption non-property tax has been presented to the voters of the City; and

WHEREAS, the City has adopted a local option tax ordinance, Ordinance 712, that was approved by voters on November 20, 1997, authorizing the collection of local option taxes as provided for under Title 50, Chapter 10, Idaho Code, and which was extended on November 8, 2011, by voter approval of Ordinance No. 1090 which amended Ordinance 712, to provide for an additional fifteen (15) years through December 31, 2027; and

WHEREAS, the Council has determined that it is desirable to seek voter approval to add a further purpose, workforce housing support, for which the local option tax revenues derived may be used; and

WHEREAS, the local-option non-property tax and its purposes cannot be adopted, implemented or collected without the assent of a sixty percent (60%) majority of the qualified electors of the City voting in an election called for such purpose; and

WHEREAS, the Council has determined to call and the County will conduct an election for the aforesaid purposes as required by Sections 50-1044 to 50-1046, Idaho Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KETCHUM as follows:

Section 1: LOCAL-OPTION NONPROPERTY TAX

A. The Council hereby finds, determines, and declares that the City of Ketchum has a population not in excess of 10,000 according to the most recent census and is a city that derives the major portion of its economic well-being from people catering to recreational needs and meeting needs of people traveling to the destination City for an extended period of time; that the

City has a significant economic dependence upon visitors and travelers passing through or staying in the community and the City; and, that said visitors and travelers require services of the City which place an undue burden upon the taxpayers of the City.

B. Subject to the approval of the local-option non-property tax by the qualified electors voting at the election for which provision is hereinafter made, Ordinance No. 1223, adopted on September 7th pursuant to the provisions of Sections 50-1046 to 50-1047, Idaho Code, as amended, shall take effect January 1, 2022, after the canvass of the returns of the regular election and compliance by the City with Section 50-1047, Idaho Code. Said Ordinance is attached hereto as Exhibit "A" and provides as follows:

(A) The local-option non-property tax revenue derived from and collected under the City Local Option Tax Ordinance, Ordinance 712 as extended by Ordinance 1090, shall be further amended to add the following purpose to Section 5: Workforce/Community Housing Provision and Support.

Section 2: SPECIAL ELECTION

A special election is hereby called within the City to be held on Tuesday, November 2, 2021, for the purpose of enabling the qualified electors of the City to vote upon the proposition set forth in Section 4 hereof. The ballot proposition for the special election shall be separate from any other ballot measure being submitted to the electors on the date of the election. Only those qualified electors of the City casting valid ballots upon the proposition set forth in Section 4 of this Resolution shall be counted in determining the number of qualified electors voting at or participating in the election.

Section 3: ADMINISTRATION OF ELECTION

The administration of the election shall be conducted in accordance with Chapter 4 of Title 50 of Idaho Code, Chapter 14 of Title 34 of Idaho Code, and in accordance with this Resolution. The supervision and administration of the election and election laws shall be by the County Clerk as chief elections officer, in accordance with Idaho Code §50-403.

Section 4: BALLOT PROPOSITION

The ballot proposition for the election shall be in substantially the following form:

INSTRUCTIONS: Vote on the following question by placing an X in the square according to the way you desire to vote on that question. If you, by mistake or accident, tear, deface, wrongly mark or otherwise mutilate this ballot, return it to the election judge and get another.

Local Option Tax

Shall the City of Ketchum adopt proposed Ordinance No. 1223

Ordinance No. 1223 amends the existing City of Ketchum Local Option Tax Ordinance to add a **Community/Workforce Housing** provision as an authorized use of local option tax revenues. Ordinance No. 1223 does <u>not</u> change or increase the local option tax rate.

Section 5: QUALIFIED ELECTORS

Every person eighteen (18) years of age or older, who at the time of the specified election is a United States citizen who has been a legal and bona fide resident of the City for at least 30 days immediately preceding the date of the election, if properly registered as required by law, shall be qualified to vote at said election.

Section 6: REGISTRATION

All electors must be registered to vote at said election. Voter registration shall be conducted pursuant to the provisions of Section 34-1402, Idaho Code.

No qualified elector who is duly registered as a voter, and who continues to reside at the same address or within the same precinct in which he or she is registered, shall be required to re-register.

Persons who are eligible to vote may register for the election at the office of the Blaine County Clerk. Any elector who will complete his or her residence requirement or attain the requisite voting age during the period when the register of electors is closed may register prior to the closing of the register.

Any person who is eligible to vote may register on election day by appearing in person at the polling place established for the election, by completing a registration card, making an oath on the form prescribed by law, and providing proof of residence in the manner provided by Section 34-408A, Idaho Code, as amended.

Section 7: OFFICERS AUTHORIZED

The officers of the City are hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

Section 8: RATIFICATION

All actions heretofore taken, not inconsistent with the provisions of this Resolution, by the Mayor and Council directed toward the holding of the election called for herein, are hereby ratified, approved, and confirmed.

WHEREAS, the City of Ketchum is authorized to collect certain local option taxes pursuant to Ordinance 712, as amended by Ordinances 1090, 1097, and 1108.

WHEREAS, the City of Ketchum has determined it is in the best interests of the public to amend Ordinance 712 to add an additional use, Workforce Housing Provision and Support, to the list of purposes for which the local option tax revenues derived may be used.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

SECTION 1. BALLOT. The following ballot shall be submitted to the registered voters of the City of Ketchum at the November 2, 2021 election and Ordinance 712, as amended, shall be further amended as provided that the ballot is approved by sixty percent of the registered voters that vote on such ballot:

SECTION 2. Section 5 of Ordinance 712 of the City of Ketchum, Idaho, as amended, and as codified in Ketchum Municipal Code 3.12.050, is amended as follows if approved by the registered votes of the City of Ketchum pursuant to the ballot designated above:

3.12.050: PURPOSES FOR WHICH THE REVENUES DERIVED FROM NONPROPERTY TAXES SHALL BE USED:

The nonproperty tax revenue derived from and collected under this chapter shall be used for the following purposes:

- A. Municipal transportation.
- B. Open space acquisition and recreation.
- C. Capital improvements: roads, water, sewer, parking, Ore Wagon Museum.
- D. Emergency services: police, fire, ambulance.
- E. City promotion, visitor information and special events.
- F. Property Tax relief.
- G. Direct costs to collect and enforce the tax.
- H. Maintaining and increasing air service to Friedman Memorial Airport
- I. Workforce/Community housing provision and support.

SECTION 3. SEVERABILITY CLAUSE. If any paragraph, part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 4. PUBLICATION. This Ordinance shall be published once in the official newspaper of the City.

SECTION 5. REPEALER CLAUSE. All City code sections, ordinances or resolutions or parts thereof, which are in conflict herewith are hereby repealed.

SECTION 6. EFFECTIVE DATE. This Ordinance shall be in full force and effect on January 1, 2022, after voter approval, passage by City Council and Mayor, and publication according to law.

Recommendation to Hold Public Hearing and Adopt Ordinance No. 1221 Amending The FY 20-21 Annual Appropriations Ordinance By Appropriating Additional Monies and Specifying Authorized Activities

Recommendation and Summary

Staff is respectfully recommending that the Ketchum City Council hold a public hearing on amendment of the FY 21 budget, conduct the first reading by title only of Ordinance No. 1221 with the following motion:

Motion: Pursuant to Idaho Code 50-902, to approve the first reading of Ordinance No. 1221 and read by title only.

The reasons for the recommendation are as follows:

- Revenue increases due to inflationary changes in charges for services, permits for planning and building, Idaho Rebound Grant, American Rescue Plan Act, and Blaine County rebate of excess funds.
- Expenditure adjustments will be allocated to planning and building increased costs, Warm Spring Analysis, City Beautification, fire station parking lot and essential service facility new city hall.
- State statute establishes requirements for amending the budget in Section 50-1003.

Introduction and History

Per Idaho Code 50-1003, the City Council of each city shall, prior to the commencement of each fiscal year, pass an Ordinance to be termed the Annual Appropriation Ordinance.

On September 8, 2020, the Council adopted Ordinance 1208 entitled the Annual Appropriation Ordinance for the Fiscal Year beginning October 1, 2020, and ending September 30, 2021, appropriating to the various budgetary funds sums of money necessary to defray all expenses and liabilities within each fund for the ensuing fiscal year, authorizing a levy of a sufficient tax upon the taxable property, specifying the objects and purposes for which said appropriation is made, and providing an effective date.

The city council of any city may, by the same procedure as used in adopting the original appropriation ordinance at any time during the current fiscal year, amend the appropriation ordinance as a result of an increase in revenues from any source other than ad valorem tax revenue.

<u>Analysis</u>

Ordinance No. 1208 is the Annual Appropriation Ordinance for the Fiscal Year beginning October 1, 2020 and ending September 30, 2021. Ordinance No. 1221 outlines the Proposed Expenditure adjustments in the amount of 5,357,038 and Proposed Revenue adjustments in the amount of \$5,896,841.

Financial Impact

The funds for adjustments are due to inflationary changes each exist in their respective fund balances and will be used as noted in Attachment B.

SECTION 2: That the City Council hereby appropriates each Fund as an independent fiscal and accounting group with a self-balancing set of accounts recording cash and/or other resources together with all related liabilities, obligations, reserves and equities which are segregated for the purpose of carrying on specific activities or attaining certain objectives.

<u>SECTION 3:</u> That the appropriation for the General Fund is made in the following amount to each specific division or function:

Legislative and Executive, Administrative, Legal, Community Planning and Development, Law Enforcement, Building Code, and Non-Departmental.

Recommendation to Hold Public Hearing and Adopt Ordinance No. 1220 The FY 21-22 Annual Appropriations Ordinance

Recommendation and Summary

Staff respectfully recommends that the Ketchum City Council conduct the first reading of the Annual Appropriation Ordinance No. 1220, and read by title only:

"I MOVE TO APPROVE THE FIRST READING, BY TITLE ONLY, OF ORDINANCE NO. 1220.

The reasons for the recommendation are as follows:

- State statute establishes requirements for approving a budget.
- Public hearing was held on July 19, 2021.
- Budget workshop was held on June 28, 2021.

Introduction and History

Per Idaho Code 50-1003, the City Council of each city shall, prior to the commencement of each fiscal year, pass an Ordinance to be termed the Annual Appropriation Ordinance.

<u>Analysis</u>

The City Council will hold a Public Hearing on August 16, 2021, at 4:00 p.m. for the purpose of considering and fixing a final budget and making appropriations to each office, department, service, agency, or institution and fund for the next fiscal year (2021-22).

The City Council will consider adopting Ordinance Number 1220, entitled the Annual Appropriation Ordinance for the Fiscal Year beginning October 1, 2021, appropriating to the various funds sums of money deemed necessary to defray all expenses and liabilities within each fund for the ensuing fiscal year, authorizing a levy of sufficient tax upon the taxable property, specifying the objects and purpose for which said appropriation is made, and providing and effective date.

Financial Impact

The Fiscal Year 2021-22 City Budget provides budget authority for the services and projects the City anticipates providing during the new fiscal year. The proposed budget appropriates a total of \$32,222,099 including \$12,840,516 in the General Fund.
