

WHEREAS, the City Council of Kotzebue is the governing body of the City of Kotzebue, being duly called and a quorum being present; and,


WHEREAS, Kotzebue Municipal Code §2.52.510 provides for the City of Kotzebue to publicly declare the results of the Municipal election;

Commonwealth Strategic Partners (CSP) understands that the City of Kotzebue is seeking the services of a qualified firm to provide lobbying services to advance the City's priorities, Capital Projects, funding efforts, and public policy initiatives at the federal level with the U.S. Congress and departments and agencies of the federal government, in addition to fostering positive working relationships with Members of the Congress and their staff and federal agency staff.

CSP is a bipartisan professional advocacy firm specializing in strategic counsel, skillful government relations, and public affairs services. The team working with Kotzebue would include all three federal lobbyists on CSP's team: Cofounders and Managing Partners George McElwee and Keith Pemrick, and Vice President for Federal Government Affairs Katie Hazlett. CSP worked with the client to strategize on the legislative idea and helped craft legislative language to create a Federal Housing Administration (FHA) home loan program for police officers, firefighters, emergency medical technicians, paramedics, and preK-12 teachers. CSP assisted the client with identifying Congressional champions to shepherd the proposal. The legislation has been introduced in the House and Senate and has the support of over 172 Members of Congress (117 Democratic, 55 Republican) including Sen. Lisa Murkowski (R-AK) and Rep. Mary Peltola (D-AK-At Large). During the 118th Congress, CSP has facilitated more than 100 Congressional meetings with both personal offices and committee offices. Thousands of emails and calls have been made to secure national, state, and local endorsements of more than 150 local elected officials, including the Kotzebue Police Department and the Mayors of Cordova, Kodiak, Valdez, and Wasilla. CSP has leveraged those endorsements with op-eds running in major media markets and press events in multiple states. CSP made introductions to Administration officials, and at CSP's urging, the Administration has weighed in with positive comments at Congressional hearings and provided technical assistance with the bill's drafting.

Keith Pemrick, CSP's other co-founder and managing partner, has specific expertise in federal transportation issues and appropriations. As a legislative director, Keith was the lead staff member



to a senior member of the House Committee on Transportation and Infrastructure. In this role, he wrote the legislative language included in transportation authorization bill that allows for state autonomy for culvert pipe selection and led the Pennsylvania Congressional Delegation's effort against de-combining air traffic control facilities at seven Pennsylvania airports. During his twelve-year tenure, Keith was also responsible for all of the Congressman's federally directed appropriations, securing hundreds of millions of dollars for critical projects in the congressional district for municipalities including multiple intermodal transportation centers and bridge projects.

In his current role, Keith led CSP's representation of the State of Pennsylvania during Governor Tom Wolf's Administration. Pennsylvania hired CSP to be the link to D.C., where decisions are made every day at the Federal level that impact Pennsylvania residents. This year, Keith secured language in the Federal Aviation Administration Reauthorization Act to advance several of AMFA's priorities, including \$20 million in funding per year for the FAA's aircraft maintenance technician (AMT) workforce development program. Most recently, **Keith organized a congressional site visit for AMFA in Alaska with Rep. Mary Peltola (D-AK-AL).** AMFA hosted Rep. Peltola for a tour of Alaska Airlines Maintenance and Engineering Facility and Hangar in Anchorage.

Katie Hazlett, Vice President for Government Affairs, served for fourteen years working for a senior appropriator and Chairman of the full House Committee on Appropriations including as Chief of Staff and Senior Advisor to the Committee. During her time in the Congressman's office, she worked on variety of projects for local governments including the creation of a new multimodal transportation hub in NY Metropolitan Area. She is an appropriations expert and has led efforts on securing emergency spending legislation for natural disasters including the Hurricane Sandy Disaster Relief Appropriations Act. She secured funding for projects for law enforcement hiring



and upgrades, renewable energy facilities, flood mitigation efforts, preserving open spaces and community health centers. Katie successfully executed multiple events where administration officials attended site visits to see the need for projects firsthand. Throughout this work, Katie traveled with several federal agencies to view projects firsthand including a trip with the **National Science Foundation (NSF) to Alaska.** Katie also spent 2 years in the Administration including leading an office responsible for state and local engagement and gained further insight into the working of federal agencies on grants. She was at the **Department of Energy when the Artic Energy Office** was established.

Katie has performed similar work for clients. Resumes and Key Personnel

George S. McElwee is a founding member and managing partner of CSP. He brings more than 20 years of experience in both the public and private sectors, including work in the federal government and as a commissioned officer in the U.S. Navy Reserve. For his work in 2021-2023, George was recognized as one of The Hill's Top Lobbyists, and CSP was recognized as a Top Performing Lobbying Firm by Bloomberg Government.

In the 118th Congress, George successfully introduced four bipartisan pieces of legislation including:

- HR3170 and S1514, the Homes for Every Local Protector, Educator, and Responder (HELPER) Act. The HELPER Act would establish an FHA first-time homebuyer program for law enforcement, firefighters, teachers, EMTs, and paramedics by eliminating the downpayment requirement and eliminating the monthly mortgage insurance premium. The HELPER Act is sponsored by 173 members of the House and Senate, including Sen. Lisa Murkowski (R-AK) and Rep. Mary Peltola (D-AK-At Large). The HELPER Act is endorsed by more than 500 national, state, and local organizations, and elected officials, including the Kotzebue Police Department, Alaska Association of Chiefs of Police, the Alaska Fire Chiefs Association, the Alaska State Firefighters Association & the Mayors of Cordova, Kodiak, Valdez, and Wasilla. Additionally, the HELPER Act is endorsed by over 20 Alaskan police departments, including the Anchorage, Fairbanks, and Juneau Police Departments.
- HR4757, the Cease Animal Research Grants Overseas (CARGO) Act would prohibit the National Institutes of Health (NIH) from sending taxpayer-funded grants to foreign laboratories for experiments on animals. The CARGO Act would not impact research conducted in the United States.
- HR7220, the EB-5 Regional Center Program Advisory Committee Authorization Act
 would establish an advisory committee composed of experts in the EB-5 Regional Center
 Program space. The advisory committee, hosted by the U.S. Citizenship and Immigration
 Service (USCIS), will bring together Regional Center owners and state and local officials
 to communicate, coordinate, and advise USCIS on administering the Regional Center
 Program.



In the 117th Congress, George worked with members of the House and Senate to introduce bipartisan legislation to reauthorize the EB-5 Regional Center Program through Fiscal Year 2026. HR2901 and S831, the **EB-5 Reform and Integrity Act of 2021** was incorporated in an omnibus spending package and enacted into law.

In the 116th Congress, George worked to introduce bipartisan HR1975 and S4024, Cybersecurity Advisory Committee Authorization Act. Enacted into law through its inclusion of the National Defense Authorization Act of 2021, the legislation established a new committee of industry experts to advise the U.S. Department of Homeland Security and Director of the Cybersecurity and Infrastructure Security Agency (CISA). George was able to secure language to establish the Cybersecurity Advisory Committee in the FY21 National Defense Authorization Act, which was enacted in January 2021.

George's knowledge of politics and his instinctive ability to connect people of varying backgrounds has led him to consistent success and respect among his colleagues. For example, while working as Chief of Staff to U.S. Representative Charles W. Dent (R-PA), George was elected by his peers to serve as President of the House Chiefs of Staff Association, a position he held for three years, making him the longest-serving president in the association's 36-year history.

After working for Mr. Dent, George served as the Organization for International Investment's Vice President, Public Policy & Government Affairs, as the association's chief lobbyist. He also spent five years as Director, Federal Government Affairs for the American Financial Services Association and worked on the staff of U.S. Senator Rick Santorum (R-PA).

Lt. Cmdr. McElwee is currently assigned to the Navy Public Affairs Support Element East and serves as Assistant Officer in Charge (AOIC). As AOIC, Lt. Cmdr. His previous assignments include Flag Assistant to the U.S. Navy Vice Chief of Information, Navy Office of Community Outreach, U.S. Navy Chief of Information, and U.S. Fleet Forces Command. Lt. Cmdr. McElwee's service has taken him to Alaska. Earlier this year, in June, Lt. Cmdr. McElwee supported a mission that included time at Joint Base Elmendorf–Richardson.

Nominated by Pennsylvania Governor Tom Wolf and confirmed by the Pennsylvania Senate, George is a proud member of the Shippensburg University Council of Trustees.

George holds an M.A. in Strategic Security Studies from National Defense University at Fort Lesley J. McNair, a graduate certificate in PACs and Political Management from George Washington University, and B.A. in Political Science from Shippensburg University of Pennsylvania. George is also a graduate of the Air Command and Staff College at Maxwell Air Force Base and the Defense Information School at Fort George G. Meade.

In 2018, he took on the challenge of managing the campaign of Denny Wolff, a Democrat seeking the open Pennsylvania 9th congressional district seat in a district President Trump won with 68%. As campaign manager, Keith developed and implemented the election strategy, oversaw all components of the campaign, and served as campaign spokesperson. While Wolff did not get elected, he forced the Republican establishment to fight in a seat that should have been a lock for them.

Bringing his expertise to the classroom, Keith serves as an adjunct professor in the School of Public Affairs at American University during the spring semester and an adjunct professor in the School of Public Affairs at Penn State-Harrisburg during the fall semester.

Prior to CSP, Katie served as Principal Deputy Assistant Secretary at the Department of Energy (DOE), where she led DOE's relationship with Congress including the Committees on Armed Services, the House Committee on Energy and Commerce, and the Senate Energy and Natural Resources Committee. In that role, she supported the Secretary of Energy, the Department, and the Administration's policies before the Senate and House of Representatives, while managing and overseeing the external affairs engagement activities and the intergovernmental relationships with state and local governments. Katie also served as Chief of Staff for COE's Office of the Chief Financial Officer, which is responsible for the formulation and execution of DOE's nearly \$40 billion annual budget with an office staff of over 100 employees.

Since joining CSP in 2021, Katie has worked with a municipal client on their efforts to rehabilitate a train station and make it a multi-modal transportation hub. Proposed Strategy and Methodology

Dear City Manager Baldwin, Mayor Chase, and City Council:

Thank you for the opportunity and your consideration of our proposal for Federal Government Lobbying Services for three years beginning in October 2024. This proposal outlines an offer of engagement in advocacy and the development and implementation of strategies to address municipal infrastructure development and funding, opportunities for additional federal grant funding, and improvement of partnerships with federal agencies to facilitate finding solutions to meet specific objectives before Congress and key agencies. Other topics, interests and issues will no doubt arise for which the City will benefit from having a team in DC to act quickly on your behalf.

Change is ever-present in U.S. politics, and you have seen firsthand that maneuvering through the political landscape in Washington requires nearly constant adjustment. After Congressman Young's death, the Alaska Delegation found itself in the minority in both the House and Senate where the divided Congress and White House have had radically different agendas. 



Close coordination, collaboration, and consultation (the three C's) with all the players is essential to the City's success; you need allies, as do they. Drue Pearce brings over thirty years of government service and experience to your priorities; She has written both the State capitol and operating budgets as well as federal agency budgets, lobbied for local, state and federal projects, managed federal grant programs resulting in the issuance of millions of dollars of grants, and managed large

Pricing

It is our preference to represent government affairs clients on a flat-fee retainer basis. For many reasons, the work does not lend itself to hourly billing. Government relations work is very much tied to sessions of Congress, the work schedule of federal agencies and other vagaries that are completely beyond our or your control. Retainers allow you and us to budget more reliably. We are also conscious of the city's present financial situation.

For these reasons, Holland & Hart proposes to again operate on a monthly retainer basis of \$4,500 plus overhead expenses (out-of-pocket expenses, such as transportation, meals and other expenditures). These charges will be added to the regular monthly invoice.

This retainer fee would cover all time that any Holland & Hart personnel spend on this engagement. It does not include any legal engagement outside of the government affairs scope nor any preparation of grant application documents. Work outside of the lobbying scope would be billed at the employee's Alaska rate. We would propose that during preparation of the city's next fiscal year's budget, that Holland & Hart and the city manager meet to evaluate the retainer and assess whether the amount is fair to the parties considering the work that has been done.

If we are again retained, we will execute a new engagement letter for our services that will provide detail as to our billing procedures and other engagement protocols.

Introduction

CHCG represents a wide array of clients including a portfolio of Alaska entities and several municipalities. This experience will help our firm's representation of Kotzebue. CHCG has scored a number of "wins" for our clients through specific legislation, regulatory approval of projects, coordinating briefings for Representatives and Senators, and facilitating witness testimony.

This included leading the Congressman's efforts during the development and passage of the Bipartisan Infrastructure Act. This legislation, which had its origins based in part on conversations Alex facilitated between the Congressman and the White House, is currently responsible for sending millions of dollars to Alaska. Alex's efforts helped shape the Act such that rural and remote communities received priority in much of the formula and grant money that it allocated. For example, there was a debate about whether broadband funding should include a population preference, which would have benefitted urban areas, or focus on buildout to un- and under-served communities. Alex's push with the Alaska Delegation ensured that the latter won out. Ultimately, final passage of the legislation hinged on Congressman Young, with Alex's support, rounding up Republican votes to secure House passage.

Alex led Congressman Young's team during the re-establishment of Congressionally Directed Spending, also known as earmarks or Community Project Funding. He was also responsible for setting up Representative Peltola's system for reviewing and requesting earmarks as part of setting up her office. Alex's experience on this front, and his familiarity with the annual appropriations process in general, will give Kotzebue an edge in obtaining funding for its capital projects and other programs of importance to the community.

Alex has a strong appreciation for housing policy and understanding of how limited housing availad Section IX, Item a) hampering sustainability and growth in rural Alaska. His time with Congressman Young and Representative Peltola included spearheading efforts with the Alaska Housing Finance Corporation and the Rural Alaska Community Action Program (RurAL CAP). Over the years, he fought to secure passage of a bill to reauthorize and improve the Native American Housing Assistance and Self Determination Act of 1996 (NAHASDA). This multiyear endeavor positioned Alex to work well on finding creative solutions for housing needs.

Certain federal programs have an outsized relevance to rural Alaskan municipalities. In his years serving in the Alaska Delegation, Alex has fought to protect and expand many of these programs. This includes the Impact Aid program, which reimburses school districts for tax revenue lost from the presence of federal land and facilities and for carrying out federal obligations. Alex worked with a bipartisan coalition in the House to ensure that Alaskan communities received Impact Aid funding when it was due and received back payments when disbursements were initially missed because of interruptions like government shutdowns.

Circumstances in rural Alaska can sometimes take a devastating turn. We have seen this recently with the landslide in Alex's hometown of Ketchikan. During his time with Representative Peltola, Alex led the office's response to Typhoon Merbok. In particular, his efforts in coordination with the rest of the Delegation made sure that the federal government was responsible for 100 percent of the share of the eligible disaster assistance costs. This lifted a major burden for the affected communities that had critical infrastructure damaged by the storm along with families seeking individual assistance.

Alex's unique trajectory working on Capitol Hill resulted in him building relationships with staff that will be helpful to Kotzebue. Mike Songer, who was his defense staffer in Congressman Young's office, is now Senator Murkowski's defense staffer. The same is the case for Kevin Swanson, who is now Senator Murkowski's transportation and infrastructure staffer. Alex has worked in the same office as a significant portion of Senator Sullivan's senior staff. In addition, Alex directly hired Representative Peltola's staff throughout the course of establishing her office following her special election.

Kristina Wilcox, Partner, has been with CHCG for over 16 years where she has had a major focus on Alaska issues.
