#### **SECTION 1- QUALIFICATIONS AND EXPERIENCE**

#### A. Experience

The Advocacy Partners (TAP) is a bipartisan, Florida focused full-service government relations firm located in Tallahassee, Florida. Our firm was founded in 2003 at the law firm of Tew Cardenas LLP and has been in existence for 22 years. In July 2009, the partners acquired the equity interest held in it by Tew Cardenas LLP and was reincorporated as a standalone Limited Liability Company in 2009 under the name The Advocacy Group at Cardenas Partners. Following the retirement of our founding partner, Al Cardenas, the firm rebranded as The Advocacy Partners. Each of our professionals is registered with the State of Florida to lobby on behalf of our clients. TAP also submits the required quarterly lobbyist compensation reports to remain in compliance with state law. Our lobbyist registrations and compensation reports can be located on the State's website, floridalobbyist.gov.

TAP has the qualifications and experience necessary to represent the City of Lake City (City) as the City's lobbyist before Florida government. Through our background representing other local government clients, we are intimately familiar with the requirements laid out in the Scope of Services, which we detail further in our response. It is our belief that the expertise and capabilities laid out in the remainder of this response will prove that TAP is more than capable of leading the City towards success.

We are proud to represent a wide range of clients, from some our nation's largest brands including Walt Disney World, Anheuser Busch, and Starbucks; to a diverse set of local governments including Lee County, Okaloosa County, Citrus County, Pasco County and the City of Ocala, In addition, we have extensive practice helping not-for-profit's such as The Clevland Clinic and Nurse Family Partnership, and No-Kid Hungry.

#### **B.** Political Background

ii. iv. Infrastructure Improvements | In the wake of Hurricane Ian, the worst natural disaster on record for Southwest Florida, the Lee County Board of County Commissioners turned to our firm to assist them with their State government priorities in Tallahassee. We worked with the County's legislative delegation, as well as legislative and executive branch leadership to successfully pass legislation that would allow the County to treat non-violent offenders for mental health and substance abuse disorders. TAP has continued working to secure consistent funding for the program for a total of \$1,900,000. Additionally, TAP worked to secure \$1,250,000 for the Okaloosa County Special Needs Ball Field and Park.

In addition to our work on behalf of Okaloosa County, TAP represents Community Health Systems (CHS), an investor-owned hospital system. One of CHS' facilities, Lower Keys Medical Center (LKMC), is located at the southernmost point of our nation, Key West. If you look at a map, Key West is about as remote a place as you can imagine in our state. The facility meets the federal definition of sole community provider but did not meet the state definition of a rural hospital which meant they were missing out on the increased funding appropriated to rural hospitals annually. We worked with the legislature and made the case that due to Key West's remote location, and the challenges that presents, they should qualify for the rural hospital increase. We were successful several years in a row, and eventually advocated to include LKMC's rural funding as a recurring cost, and the legislature agreed. Their rural hospital funding increase was built into their base funding, and the hospital can now count on an additional \$1.7M annually.

#### **D.** Understanding Proposed Legislation



#### **SECTION 3 – APPROACH TO THE PROJECT**

#### A. Approach to Required Services

The Advocacy Partners (TAP) has a great deal of experience working with local government entities to design and implement strategies while considering the evolving political, policy, and personnel undercurrents of Florida politics. Through our experience representing our local government clients, we have found that goals evolve as circumstances change. We have found that the key to successfully navigating those evolving circumstances has been purposeful and disciplined communication. To implement a proactive approach to communication, we would ensure that regular bi-weekly meetings are conducted, which would increase in frequency leading up to Session.

An important aspect of our communication plan is to assign specific members of our team to support the efforts of the City of Lake City (City). As previously mentioned in our response, should we earn the privilege of representing the City before the State, we would recommend Sarah Suskey and Steve Schale lead the TAP advocacy efforts. While Mrs. Suskey and Mr. Schale will be the lead interfacing with the City, understand we will utilize the time and talents of our entire firm. Should we need to bring the expertise of other members of our firm to meet with city staff, and/or elected officials, we would do so as needed.

TAP has taken a deliberate approach to our local government practice to ensure that each of our municipal clients receives the best representation possible. To achieve this, we are purposeful when determining which members of our team will assume lead responsibility. We currently have the pleasure of representing the City of Ocala, Okaloosa County, Lee County, Port Tampa Bay; and have recently begun representing Citrus County and Pasco County. Each of our local government clients has very distinct needs based on their region and in the case of the Port, their specific governmental purpose. We have been fortunate that our representation has spanned over more than a decade for Okaloosa County, the City of Ocala, and Port Tampa Bay. We feel that the fact that each has extended and renewed our contracts for this length of time is indicative of the trust and confidence that each client has in our firm. We have a deep level of understanding of the needs of local governments and yet, we are not spread so thin as to have to make choices between their priorities when going to decision-makers to advocate on their behalf.

Our record of success on behalf of our clients is unmatched, and we believe our approach allows us to ensure we both understand our clients' needs and formulate the best strategy for the City's success. TAP provides the following services, and more, to our clients – and specifically on your behalf, we will:

- Represent the City of Lake City and your priorities before elected, appointed and career state officials.
- Assist the City with developing goals, and then help to develop and implement a plan to achieve them.
- Identify challenges and opportunities that stand to impact the City at both the legislative and executive levels.
- Monitor and advise on legislation and appropriations that could impact the City of Lake City, including issues impacting Home Rule, as well as other local government issues.
- Represent the City before legislative and executive bodies and in meetings with elected or appointed individuals and their respective staff.
- Assist the City in the state appropriations process and identifying key opportunities.
- Assist the City in navigating various requirements from executive branch agencies including, but not limited to grants, reimbursements, and tax credits.
- Coordinate any Tallahassee and state-wide based needs including meetings with key officials and stakeholders such as the Governor, legislative leaders, and state agency heads.
- Report on Legislative actions and the firm's efforts at the conclusion of each Session.

TAP utilizes a team approach to ensure that our clients' needs are not only met but exceed expectations. As mentioned above, Sarah Suskey and Steve Schale will lead these efforts while being supported by each of our team members. It is important to note that due to the timeline listed in the Request for Proposal, the date listed that the evaluation committee's recommendation will be presented for approval (February 17, 2025) is passed the House Local Funding Appropriations Request submission deadline of February 14, 2025. As a result, should TAP be selected as the firm for the City, our approach to advocacy will be unable to assist with the House Local Funding Appropriations Request due to the deadline. Should the City choose to submit these forms prior to onboarding, TAP would immediately hit the ground running to familiarize ourselves with the nature of the request and assist in any way with the Senate companion forms.

Should we earn the honor of representing the City, the following is an example of what an initial step-by-step approach we would propose for the 2025 legislative session:

#### February 2025

- Immediately conduct an onboarding call with relevant members of the City to familiarize each other with the goals for the 2025 Session.
- Utilize the final Committee week leading up to the 2025 Legislative Session to meet with Representative Brannan III and Senator Bradley in addition to the respective budget Chairs if necessary.
- Establish regularly scheduled meetings between TAP and City personnel to keep officials appraised of real time issues.

#### March - May 2025

- TAP will monitor and track legislation and attend committee meetings related to the City's initiatives and priorities throughout the legislative session. Should an issue arise that would impact the City, either in a positive or negative manner, TAP would immediately reach out to work with the City on a strategy to tackle the issue.
- TAP will also coordinate meetings, discussions, etc. with industries supporting issues related to the goals of the City. It is our responsibility and pleasure to distribute a weekly report detailing the bills of consequence to the City and will provide written updates outside of these reports as circumstances evolve.
- TAP will coordinate "City of Lake City Day" in Tallahassee and facilitate meetings with pertinent legislators and agency officials in support of the City's priorities.
- As challenges and opportunities present themselves, TAP will coordinate any meeting and public testimony for City Officials throughout the 2025 legislative session.

#### Year Round

- Provide advice to the City of Lake City on regulation and state policies that might materially impact the objectives set forth.
- Throughout the year, TAP will represent the City in meetings that impact policy objectives, including industry conferences, marketing materials, and networking opportunities that will be promptly reported back to City personnel on all relevant developments. This includes any pertinent interaction with the Florida League of Cities.
- Provide the City with research and background information on any relevant issues as needed.
- Provide assistance with drafting correspondence to elected officials, staff, or other government entities when necessary.

The above list is not exhaustive, TAP will modify and expand this initial proposed plan of action as the City's needs and priorities evolve. While any advocacy effort should have a blueprint for success, it is

critical that the City's plan be fluid and retain flexibility needed to react to the ever changing and tumultuous landscape of the political and legislative processes.

#### B. Tracking & Analysis of Bill and Legislative Agenda

As a matter of practice, each member of our firm reviews and analyzes every piece of legislation filed to determine if it could impact our clients. We believe that having multiple sets of eyes on each piece of legislation filed ensures we don't miss anything.

Should we win the City's work, we will flag every bill that could impact the City's priorities, or the City's governance, in a software program called LobbyTools. This program will notify us in real time of any changes that occur. We will also share any legislation that we believe could have an impact on the City with our point of contact and seek feedback.

Every Monday during committee meeting weeks and session, we meet as a complete TAP team to review any bill that is on an agenda that impacts, or may impact, our clients. We then split up any tasks needed, such as scheduling meetings with legislators and staff.

Our bill tracking database is also the backbone of our weekly reports that we distribute on Fridays. In each report, you will receive a summary of relevant events that may have happened in the week prior, followed by a detailed bill report of all legislation that we are monitoring on your behalf. These weekly reports are an invaluable tool in our communication plan and will allow the City to review proposed legislation and communicate to our team should there be any questions or concerns.

Advocacy is our specialty and as such, we are committed to working with the City Council to determine a legislative agenda that supports the goals the City wishes to achieve. Due to the timing of this Request for Proposal, we would need to immediately get to work to shape the legislative agenda on Day 1 so that we can provide the best possible outcomes during the 2025 legislative session. Should we earn the opportunity to serve as the City's lobbyist of contract beyond the 2025 session, we would typically begin to have conversations with the City as early as July or August of 2025 so that we can begin working with stakeholders ahead of the 2026 legislative session set to kick off in January of 2026.

## C. Proactive Identification of Issues of Potential Interest to the City

Regarding the development and implementation of a strategy of support, opposition, or amendment of pending legislation that may impact the City, it is important to note that the approach taken will be different depending on the issue. Our first step would be to utilize our communication strategy identified in Section 3, Subsection A to determine the legislation that needs to be addressed. Once we have our marching orders from the City, we would reach out to the bill sponsors to provide our position on the issue. In the case of support, we would do everything possible to assist the bill sponsor in reaching the finish line. If the City does not support specific legislation, we would immediately reach out to bill sponsors and other relevant stakeholders to explain why the City's position on the issue should be considered and offer proposed amendment language to align the legislation with the City's position. Should these efforts not result in the necessary result, we would realign our mission from amending the legislation to opposing, or "killing", the proposed bill. Should our efforts at the legislative level not prove successful, we would shift to demonstrating to the Governor's Office why the legislation is detrimental to our state and encourage the use of veto power. Again, every single situation is dependent on the issue that is being considered and our strategy to advocating support, opposition, or amendment will vary on what stakeholders and members of the legislature are involved.

As briefly mentioned in Section 1 – Qualifications and Experience, we pride ourselves on our ability to see "around the corner" on issues that are important to our clients. We are well positioned to assist the City in identifying issues of potential interest. With our office conveniently located down the street from the Capitol, we are immersed in the everyday happenings when the legislature is in town. During the legislative session, things can change at a moments' notice and having a firm that is central to the happenings is an invaluable resource.

Our ability to be proactive on issues relating to the City works hand-in-hand with our purposeful communication plan laid out in this response. As your state lobbyist, we are available 24 hours a day, 7 days a week to answer any and all questions the City may have. ## III. Approach to the Project

#### A. Our Approach:

The 2025 Legislative Session is scheduled to convene on Tuesday, March 4, 2025, which is not many days before the final lobbying firm selection is made. Leading up to the start, in the Florida House of Representatives, on Friday, February 14, 2025, House Appropriation Project Request Forms are due no later than 5 p.m. When we consider the listed timeline for approval of REQUEST FOR PROPOSAL 007-2025 - STATE LOBBYIST SERVICES, this poses a challenge for City of Lake City if staff isn't already working on the required forms and working with an identified sponsor to submit the form before the due date. Pursuant to the House Rules, if a House Appropriation Project Request Form is not submitted, no funding will be included in the Florida House of Representatives proposed budget. Therefore, to qualify and proper position for budget conference, the city would need to make sure our Senate sponsor successfully gets the request(s) included in the Florida Senate's proposed budget. Our firm is experienced in this area and can be trusted by the city to overcome any initial hurdles.

Our firm, in partnership with the City of Lake City, upon being retained and lobbyist registration approvals, would strategize on immediate impact and momentum build. This strategy session can occur in-person, with us coming to the city or virtually. Here's how we approach the immediate months of March – June:

#### Month of March\*1

- - Initially, we would schedule meetings with the two members of your legislative delegation – Senator Jennifer Bradley and Representative Chuck Brannan (both we know well) and walk them through the city's legislative priorities.
  - We would schedule meetings with the respective appropriations subcommittee chairs and vice chairs, and their staff directors/budget chiefs to educate them on the city's legislative priorities.

- We would schedule meetings with senior leadership in the Executive Office of Governor Ron DeSantis to educate them on the city's legislative priorities.
  - Many lobbying firms wait until after Legislative Session has adjourned before they converse with the Executive Office of Governor Ron DeSantis. When we consider our successful outcome, our firm believes the Executive Branch is just as important as the Legislative Branch and therefore we must meet and converse with them early and often.
- If necessary, we will schedule meetings with respective state agencies to also educate them on the city's legislative priorities.

#### Month of April\*2

- This is the critical month because it's the second half of Legislative Session, but also the month when budget conference will take places.
- Since we "successfully" held meetings with the appropriate legislators and staff in the Executive Office of Governor Ron DeSantis, now we are making sure our funding sponsors have all materials they need before budget conference.
- We are consistently circling back to the respective appropriations subcommittee chairs and vice chairs, and their staff directors/budget chiefs to make sure they have all materials and so we can answer any questions.
- We are working with the city to secure letters of support for our funding request(s).
- By the time budget conference begins, we will have met with all decisions makers in both the Florida House and the Florida Senate, which will put us in great position for success.
- While budget conference is convening, we will be in each meeting conversing with members on the conference committee, especially the chairs, making sure the city remains priority.
- By the end of the month, budget conference will have concluded, and the State's General Appropriations Act (State Budget) will be finalized. Since we expect to have our request(s) included, we will make sure to express our thanks to our sponsors, respective appropriations subcommittee chairs and vice chairs, and their staff directors/budget chiefs, and any other legislative leaders who played a role.

#### **Months of May and June**

• Since Legislative Session adjourns on Friday, May 2, we will immediately shift our attention to the Executive Office of Governor Ron DeSantis. Now it is time to ward off vetoes.

- Historically, the Governor has not been in a hurry to sign the budget. So, we will spend both May and June on our post-Legislative Session approach. Understanding the Governor must act on the State's General Appropriations Act (State Budget) by June 30.
- Although we will be communicating with the Governor's staff throughout Legislative Session, we will schedule meetings with staff in his Office of Policy and Budget (OPB). Understanding the OPB staff is tasked with gathering all materials on funded projects, we will meet with them to share all relevant materials (including letters of support) and answer any questions.
- While it is important to never guarantee any client that their project is veto-proof, we
  will work effectively to make sure we have done everything possible to fortify our
  request(s) from being vetoed.

#### Months of July - September

- Take a small breath of relief!
- With the new state fiscal year beginning on July 1, we will work with the city to make sure our funded request(s) are not mishandled by the identified state agency during the first quarter.
- Since some state agencies are known for taking their time to execute the contract, we
  will work with the city to ward off any unnecessary delays. This would mean
  scheduling meetings with the respective state agencies to make sure they have all
  necessary information and know who the city's point of contact will be throughout.
- We will attend all city meetings required to give a post-Session debrief.

#### **Months of October - December**

- With Legislative Session slated to begin in January 2026, by this time we will have either already identified the city's priority requests for the 2026 Legislative Session or we will be working toward finalization of them.
- We should anticipate Legislative Committee Weeks starting in either September or October, we would implement our previously successful session all over again to maintain the streak of securing state funding.

#### **B. Tracking State Legislation**

We understand the nuances of representing city governments of all sizes and the importance of disseminating critical details to keep everyone informed and engaged. Our goal is to communicate quickly and accurately to allow our clients the opportunity to analyze, respond and react.



We actively monitor and will timely advise the city on relevant legislative actions that include the introduction of legislation, committee referrals, and when legislation is scheduled for a hearing. We also monitor, report, and take necessary action as directed by the city to support or oppose amendments and will report back about legislative action taken on those issues. Additionally, we constantly review the Florida Administrative Register to identify agency rule actions and meetings which are critical components of the legislative process.

## V. Key Partnerships

The 2025 Legislative Session will bring big changes to the Florida Legislature. While Florida maintains a Republican supermajority in the House and Senate after the November General Election, significant leadership and committee changes will directly impact local government funding and initiatives.

Danny Perez, Republican, Miami has become the Speaker of the House of Representatives. He has named Representative Lawrence McClure, Republican, Plant City as the Chairman of the House Appropriations Committee. Likewise, Senator Ben Albritton, Republican, Bartow, has assumed the office of Senate President and has identified Senator Ed Hooper, Republican, Palm Harbor, as Chairman of the Senate Appropriations Committee. As a former fire fighter, Senator Hooper fully understands the significance of local government



funding. These leaders and their appropriations chairs will be our initial legislative focus as all budget funding will be closely scrutinized by them. In addition to the lead appropriations members, we will target the respective House and Senate local government committee chairs. Our main objective will focus on key individuals who will be shaping the General Appropriations Act for Fiscal Year 2025-2026.

Additionally, our team has fostered meaningful relationships among those who are likely to assume legislative leadership positions beginning in 2026 with Representative Sam Garrison and Senator Jim Boyd. Succeeding these leaders in 2028 will likely be Senator Jay Trumbull and Representative Jennifer Canady with whom we continue to work closely.
