E. A discussion was held regarding an incident that happened in the ABC store where a known customer pointed a gun at a clerk and threatened to shoot one of the employees. Another incident occurred when the same customer entered the store and pulled out his gun. Mr. Dunst stated that he told the customer he was not to return to the store. Mr. Doster, who was at the meeting as an observer, asked Chairwoman Samarotto if he could speak to the board. Chairwoman Samarotto agreed. Mr. Doster stated that someone threatening the store is unacceptable and is a huge liability for the town if the situation got worse. The board agreed that follow up needs to be imitated and possible charges tiled.
