**BRIEF SUMMARY:**

The 2022 Commercial Licensing Model has been completed by the Parks, Recreation, and Lake Department and was recommended for approval by the LAB at their December 6, 2021 meeting. It was approved unanimously with the exceptions that applicant M-4 and OB-61 provide for operations that are allowed by the Lake Use Regulations before receiving permits.
