Committee Member Leduc motioned to approve the Consent Agenda, Seconded by Commissioner Taylor.

#### **NEW BUSINESS:**

3. Centennial Celebration Gala Discussion

Special Events Director Riunite Franks explained that Vice-Mayor Glas-Castro expressed concerns regarding the Centennial Gala ticket price (\$100.00) at the November 2, 2022 Regular Commission Meeting. Committee Member Leduc suggested to keep the ticket price at \$100.00. Commissioner Taylor agreed with Committee Member Leduc's' suggestion. Vice-Chair Harris-Clark questioned if a cost analysis for the event could help to determine ticket prices. Special Events Director Franks explained the budget breakdown was provided for each event, the prices for food, drinks, entertainment, marketing, and photography were based on the costs of previous Town Events. She explained that if the ticketed price were lowered, the Committee would need to scale back on entertainment and decorations. Chair Linden agreed the ticket price should remain at \$100.00. Special Events Director Franks explained that Vice-Mayor Glas-Castro suggested raffling a few tickets for Town Residents.

Committee Member Leduc motioned for the Centennial Gala ticket price to remain \$100.00, Seconded by Commissioner Taylor.

Voting Yea: Chair Linden, Vice-Chair Harris-Clark, Committee Member Leduc, and Commissioner Taylor.

4. Chili Cook-off Discussion

Special Events Director Franks explained that Vice-Mayor Glas-Castro suggested including a Chili Cook-off event between June 3, 2023 and September 23, 2023. She explained that budget adjustments would be necessary if the Committee chose to proceed with organizing a Chili Cook-off event or create another event. Chair Linden suggested the collaboration of the Rust Market and the proposed Chili Cook-Off. Special Events Director Franks, Vice-Chair Harris-Clark, and Committee Member Leduc agreed with the suggestion of event collaboration. Additionally, the Committee determined to include the Chili Cook-off as a part of the Town of Lake Park Back to School Extravaganza.

Committee Member Leduc motioned to approve the collaboration of the Chili Cook-off and the Back to School Extravaganza, Seconded by Commissioner Taylor.

Voting Yea: Chair Linden, Vice-Chair Harris-Clark, Committee Member Leduc, and Commissioner Taylor.

5. Centennial Celebration Commemorative Update

Special Events Director Franks explained that Vice-Mayor Glas-Castro suggested gifting the Commemorative Books to Residents. She explained that Vice-Mayor Glas-Castro announced the Town of Lantana had purchased 5000 copies of Commemorative Books, gifted some to residents, and local businesses but currently inundated with at least 3000 copies. She announced the previous Request for Quotes 114-2022 "Centennial Celebration Commemorative Book". She explained that one proposal was received from Star International Group for \$37,900.00 for 1,000 copies. As a result of the received proposal, Town Manager D'Agostino suggested to issue another Request for Quotes for 500 copies. Chair Linden suggested selling the books for \$9.99.
