BACKGROUND BRIEF:

Lake Orion Fireworks Foundation is requesting that Village Council approve its application for a sign permit to display a temporary canvas banner sign across vehicle lanes in the Downtown Center (DC) zoning district. Approval by Village Council of this type of sign is required by Village code. The application is attached for Council's information and consideration.

Administration has prepared a draft permit which the Village will issue if the sign is approved by the Council, and the draft permit is also attached.

RECOMMENDED MOTION:

To approve the issuance of a permit for a Temporary Use of Right-of-Way to Lake Orion Fireworks Foundation for the display of one (1) temporary canvas banner sign across vehicle lanes in the Downtown Center (DC) zoning district in accordance with the dimensional, timeframe, and approval requirements of the Village Sign Ordinance (Village Code Chapter 155), subject to the conditions outlined in the permit drafted by Administration dated May 2, 2024.

PERMIT: TEMPORARY USE OF RIGHT OF WAY (BANNER)

S. Broadway at M-24

Nearest Parcel ID #: 09-11-228-027 & 09-02-482-014 & 09-02-482-013 Nearest Zoning District: DC, Downtown Center Land Use: Village Right of Way

Permitted Use:

1. Display of one (1) temporary canvas banner across vehicle lanes in the DC, Downtown Center District. The banner shall conform to the dimensional, timeframe, and approval requirements of the Village Sign Ordinance (Chapter 155).

Conditions:

- 1. § 155.07(J)(1)(a): The banner shall be associated with a Council-approved special event.
- 2. § 155.07(J)(1)(c): The banner shall be located within the DC, Downtown Center District; tentatively planned for the crosswalk between parcels 09-11-228-027 & 09-02-482-014.
- 3. § 155.07(J)(1)(d): The banner shall not exceed 32 square feet.
- 4. § 155.07(J)(1)(d): The Village Council shall have the authority to approve up to four (4) consecutive 15-day permits (60 days total) for temporary banners made of canvas and other non-durable material; tentatively scheduled from May 8 through July 6, 2024.
- 5. LOFA shall submit a notarized Hold Harmless Agreement specifically for the proposed banner.
- 6. LOFA shall be responsible for the installation, maintenance, and removal of the banner in coordination with the Orion Township Fire Department; the banner shall not impede visibility of traffic signs or signals, impact public safety, or encroach upon adjacent private property without prior authorization.
- 7. Changes to the banner design and/or location, as noted in this permit and any other conditions of Council approval, shall be submitted to the Village for administrative review prior to permit issuance.


A sign sketch plan must include the following information:

- Any proposed internal or external lighting.
- Type of material sign is constructed from.
