Public Hearing to exceed the Revenue Neutral Rate and approval of Resolution No. B-8-2025 to exceed the RNR

KSA 79-2988 established notice and public hearing requirements for certain taxing entities seeking to collect property taxes in excess of the taxing entity's revenue-neutral rate (RNR). As presented at the June 26, 2025, work session, the city of Lansing intends to exceed the RNR of 39.754 mills. The proposed mill levy is 41.909.

Public Hearing on and Consideration of the Proposed 2026 Budget

Staff is pleased to present the Proposed 2026 Budget for the City of Lansing for consideration. The notice of public hearing summarizing the proposed 2026 budget was published in the Leavenworth Times on August 9, 2025. The proposed 2026 Budget includes \$740,260 worth of Capital and Supplemental Requests as discussed at the June 27th work session. The proposed 2026 budget reflects a flat mill levy rate, but exceeds the revenue neutral rate by 2.155 mills, which equals approximately \$287,148.

SUBJECT: Consideration of Petition and Resolution for Lansing Towne Centre Community

Improvement District (CID)

Overview: The City has received a petition from the property owner (the City, on behalf of) requesting creation of a Community Improvement District (CID) for Lansing Towne Centre, encompassing approximately 15.7 acres. The proposed project includes site improvements such as buildings, utilities, parking, landscaping, and related infrastructure. This resolution public hearing is scheduled for Thursday, November 6, 2025. The resolution is procedural only—Council will not discuss or debate the CID until the hearing; approval tonight simply initiates the required notice and mailing steps.

Action: A motion to accept the petition and adopt Resolution No. B-9-2025 to set a public hearing to consider creation of the Lansing Towne Centre Community Improvement District (CID) and the City's intent to levy a 1.0% CID sales tax.

PETITION

FOR THE CREATION OF THE LANSING TOWNE CENTRE COMMUNITY IMPROVEMENT DISTRICT

TO: The Governing Body of the City of Lansing, Kansas (the "Governing Body")

The undersigned, being the owner of more than 55% of the land area within the hereinafter proposed Lansing Towne Centre Community Improvement District (the "District") and owning more than 55% by assessed value of the land area within the District, whether resident or not, to be located within the City of Lansing, Kansas (the "City"), does hereby request that the Governing Body create such District and authorize the construction of the District project improvements hereinafter set forth, all in the manner provided by K.S.A. 12-6a26 et seq. (the "Act"). In furtherance of such request, the petitioner(s) state as follows:

General Nature of the Proposed District Projects

The general nature of the proposed District project (collectively, the "Projects") to be constructed within the District includes but is not limited to:

- (1) within the district, the acquisition, improvement, construction, demolition, removal, renovation, reconstruction, rehabilitation, maintenance, restoration, replacement, renewal, repair, installation, relocation, furnishing, equipping or extension of:
 - (A) buildings, structures and facilities;
 - (B) sidewalks, streets, roads, interchanges, highway access roads, intersections, alleys, parking lots, bridges, ramps, tunnels, overpasses and underpasses, traffic signs and signals, utilities, pedestrian amenities, drainage systems, water systems, storm systems, sewer systems, lift stations, underground gas, heating and electrical services and connections located within or without the public right-of-way, water mains and extensions and other site improvements;
 - (C) parking garages;
 - (D) streetscape, lighting, street light fixtures, street light connections, street light facilities, benches or other seating furniture, trash receptacles, marquees, awnings, canopies, walls and barriers;
 - (E) parks, lawns, trees and other landscape;
- (2) within or without the district, costs for infrastructure located outside the district but contiguous to any portion of the district and such infrastructure is related to a project within the district or substantially for the benefit of the district; and
- (3) the City's administrative costs in establishing and maintaining the District, and other items collectively permitted to be financed within the District under the Act.

Estimated Costs of the Proposed District Projects

The total estimated cost of the proposed Projects is \$25,959,064, a portion of which and the City's administrative costs are expected to be reimbursable ("Reimbursable Project Costs") from proceeds of the CID Sales Tax (defined herein).

Proposed Method of Financing the Proposed Project

The Project will be privately financed. The Reimbursable Project Costs will be financed on a pay as you go basis, i.e., the Reimbursable Project Costs will be paid for by the developer of the project without the issuance of notes or bonds, and such developer may be reimbursed for the Reimbursable Project Costs as moneys are deposited in the District fund through the imposition of a Community Improvement District sales tax (the "CID Sales Tax") as further set forth in a development agreement to be entered into between the City and the developer.

Proposed Amount and Method of Assessment

There will be no special assessments on property within the boundaries of the proposed District to pay the costs of the Projects described by this Petition.

Proposed Amount of Community Improvement District Sales Tax

A CID Sales Tax will be imposed in the amount of one percent (1.0%) on the selling of tangible personal property at retail or rendering or furnishing of taxable services within the proposed District for a maximum term of up to 22 years.

Boundaries of Proposed Community Improvement District

The legal description of the proposed District is set forth on $\underline{\textbf{Exhibit A}}$ attached hereto and incorporated by reference herein.

A map generally outlining the boundaries of the proposed District is attached as **Exhibit B** hereto, and incorporated by reference herein.

Notice to Petition Signers

The names of the signers of this Petition may not be withdrawn from this Petition by the signers hereof after the Governing Body commences consideration of this Petition, or, later than seven (7) days after the filing hereof, whichever occurs first. The signers of this Petition consent to any assessments to the extent described herein without regard to benefits conferred by the Projects.



RESOLUTION NO. B-9-2025

A RESOLUTION CALLING AND PROVIDING FOR THE GIVING OF NOTICE OF A PUBLIC HEARING ON THE ADVISABILITY OF CREATING A COMMUNITY IMPROVEMENT DISTRICT IN THE CITY OF LANSING, KANSAS TO BE KNOWN AS THE LANSING TOWNE CENTRE COMMUNITY IMPROVEMENT DISTRICT AND REGARDING THE CITY'S INTENT TO LEVY A COMMUNITY IMPROVEMENT DISTRICT SALES TAX WITHIN SUCH DISTRICT.

WHEREAS, K.S.A. 12-6a26 *et seq*. (the "Act") authorizes the governing body of any city or county to create community improvement districts to finance projects within such defined area of the city or county and to levy a community improvement district sales tax and/or levy special assessments upon property within the district to finance projects; and

WHEREAS, a petition (the "Petition") was filed with the City Clerk, proposing the creation of the Lansing Towne Centre Community Improvement District ("CID") under the Act and the imposition of a community improvement district sales tax in order to pay the costs of the Projects (defined herein); and

WHEREAS, the Petition was signed by the required number of owners of record, whether resident or not, as required by the Act; and

WHEREAS, the City of Lansing, Kansas (the "City") intends to create the CID and to levy a community improvement district sales tax in an amount equal to one percent (1.0%) as requested in the Petition (the "CID Sales Tax"); and

WHEREAS, the governing body hereby finds and determines it to be necessary to direct and order a public hearing on the advisability of creating the CID, approving the Projects described herein and levying the CID Sales Tax, pursuant to the authority of the Act; and further to provide for the giving of notice of said hearing in the manner required by the Act.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LANSING, KANSAS, AS FOLLOWS:

Section 1. The governing body hereby finds and determines that the Petition meets the requirements of the Act.

Section 2. It is hereby authorized, ordered and directed that the governing body shall hold a public hearing, in accordance with the provisions of the Act, on the advisability of creating the CID, approving the Projects, and whether to impose the CID Sales Tax and such other matters related thereto, such public hearing to be held on **November 6, 2025** at 7:00 p.m., or as soon thereafter as the matter can be heard, in the City Council Chambers located in City Hall at 800 First Terrace, Lansing, Kansas 66043, under the authority of the Act.

Section 3. The general nature of the proposed CID projects described in the Petition to be constructed within the CID (the "Projects") includes but is not limited to:

- (1) within the CID, the acquisition, improvement, construction, demolition, removal, renovation, reconstruction, rehabilitation, maintenance, restoration, replacement, renewal, repair, installation, relocation, furnishing, equipping or extension of:
 - (A) buildings, structures and facilities;
 - (B) sidewalks, streets, roads, interchanges, highway access roads, intersections, alleys, parking lots, bridges, ramps, tunnels, overpasses and underpasses, traffic signs and signals, utilities, pedestrian amenities, drainage systems, water systems, storm systems, sewer systems, lift stations, underground gas, heating and electrical services and connections located within or without the public right-of-way, water mains and extensions and other site improvements;
 - (C) parking garages;
 - (D) streetscape, lighting, street light fixtures, street light connections, street light facilities, benches or other seating furniture, trash receptacles, marquees, awnings, canopies, walls and barriers;
 - (E) parks, lawns, trees and other landscape;
- (2) within or without the CID, costs for infrastructure located outside the CID but contiguous to any portion of the CID and such infrastructure is related to a project within the CID or substantially for the benefit of the CID; and
- (3) the City's administrative costs in establishing and maintaining the CID, and other items collectively permitted to be financed within the CID under the Act.
- **Section 4.** The total estimated cost of the proposed Projects is \$25,959,064, a portion of which and the City's administrative costs are projected to be reimbursable under the Act ("Reimbursable Project Costs").
- **Section 5.** The Project will be privately financed. The Reimbursable Project Costs will be financed on a pay as you go basis, i.e., the Reimbursable Project Costs will be paid for by the developer of the Projects without the issuance of notes or bonds, and such developer will be reimbursed for the Reimbursable Project Costs as moneys are deposited in the CID fund through the imposition of the CID Sales Tax, as further set forth in a development agreement to be entered into between the City and the developer of the Projects. No special assessments will be imposed within the CID in conjunction with the Projects.
- **Section 6.** The legal description of the property to be contained in the proposed CID is set forth on **Exhibit A** attached hereto and incorporated by reference herein. A map generally outlining the boundaries of the proposed CID is attached as **Exhibit B** hereto, and incorporated by reference herein.
- **Section 7**. The City Clerk is hereby authorized, ordered and directed to give notice of said public hearing by publication of this Resolution in the official City newspaper. Such publication shall be at least once each week for two consecutive weeks. The second publication shall be at least 7 days prior to the date of the hearing. The City Clerk is hereby further ordered and directed to mail a copy of this Resolution, via certified mail, to all property owners within such proposed CID at least 10 days prior to the date of the hearing.
- **Section 8.** This Resolution shall become effective upon its adoption by the governing body of the City.



City Administrator's Report

September 4, 2025

Agenda Items:

A petition to establish a Community Improvement District (CID) is on the agenda for Thursday evening. The petition encompasses property presently owned by the City, located on vacant land along the Lansing Towne Centre parcels. The Community Improvement District Act (K.S.A. 12-6a26 et seq.) authorizes the creation of CIDs to finance public and private improvements within designated areas. The proposed CID would enhance retail and commercial activity in Lansing's Towne Centre. The CID would impose a 1% sales tax within the district. Reimbursement to the developer will occur only when CID sales taxes are generated and collected. The site plan for this development was conditionally approved by the Planning Commission at their June meeting. The developer is responsible for all up-front costs. A motion to approve the petition to create the Lansing Towne Centre CID and authorization of the funding agreement is recommended.

Sale of property at Town Center is on the agenda Thursday evening. The sale requires the construction of an at least 50,000 square foot shopping center within 365 days of closing, to be occupied by national retailers. If this condition is not met, the property will revert back to the City. The agreement acknowledges that a Community Improvement District (CID) will be pursued as part of the overall financing of the project. The City anticipates recouping the value of the land back through sales taxes within two years.

The Lansing Police Department will promote Sgt Richard DeMateo to Lieutenant, Officer Dustin Grace and Detective Lee Adkisson to Seargeant on Thursday evening.

Acquisition of a brush truck slide-in unit is on the agenda for Thursday evening. The City received two bids, with the low bid coming from Feld Fire for \$19,949. This equipment would slide into the 2017 Chevy One-Ton pickup and will be used for brush fires in our response area. Delaware Township has expressed an openness to partnering on this expense since we partner on fire suppression in their jurisdiction.

A proclamation on behalf of the Leavenworth County Humane Society will be read at the meeting. A proclamation for National Assisted Living Week is also on the agenda.

Library:

The Library is pleased to share that they will receive a \$35,000 grant from the Northeast Kansas Library System (NEKLS) for 2026 and 2027. Staff is planning to utilize the grant for new library shelving. The shelving will be longer and narrower than our existing shelves, allowing the library to have more space more books and materials, expanding our catalogue within our

existing footprint. The shelves also will not have a solid back, meaning it will be easier for parents to keep an eye on their children. This will also bring in more natural light into the library. The anticipated cost of the 2026 shelving project is \$40,000. This will likely be a two-part project, with the second half taking place in 2027.

Public Works:

J.M. Fahey, the contractor for this summer's Capital Improvement Plan, has completed all asphalt work. Pavement markings are on pace to be completed in the next month, with yard restoration likely taking place this fall once grass can grow. This year's budget for capital improvements totals \$822,000. This maintenance work was approved at the April 17th City Council meeting.

Bid opening for repairs to the bridge at Bernard Park will be opened on September 25th, with approval coming before the City Council at the October 2nd meeting. We have a gravel secondary entrance to Bernard Park that was created during the park improvements of 2022-2023.

The West Kansas streambank stabilization project approved earlier in the summer is slated to begin once the Town Center sewer project slows down.

Wastewater:

Linaweaver Construction is making steady progress on the Town Centre Trunk Sewer Replacement Project. To date, the contractor has installed 1,250 feet of pipe and five manholes. As they approach West Kay Street, that intersection will need to be closed temporarily while the last connections for the project are completed. The project is scheduled to wrap up by late September.

The Ida/Gamble sewer project is complete. The roadway opened to the public on August 16th. A final walkthrough inspection will be scheduled for early September. The project relocated sewers near this intersection that are oversized for current flows to the new 7 Mile 36" interceptor.

All major fieldwork for the Inflow/Infiltration Mitigation Project is complete. Manhole videos and smoke testing maps have been completed and are now on the City's GIS site. A draft report will be delivered in September, with a formal presentation of findings scheduled for late 2025.

The special sales tax to pay for the Aquatic Center generated \$487,453 this year. The special sales tax to pay for DeSoto Road and Bernard Park Improvements also generated \$487,453 (both special sales taxes are for the same amount, .45%). At this rate, both special sales taxes would generate \$731,179 by the end of the year.

Meetings & Announcements:

The City is receiving opioid settlement money through the Kansas Attorney General's Office to treat and fight opioid addiction. Government agencies throughout Kansas will receive over \$340 million over the next 18 years to treat and fight opioid addiction. Lansing is on pace to receive over \$166,000 over the life of the opioid settlement. Thus far, the City is considering utilizing these funds to fund AEDs and mobile radios to assist our first responders in responding to overdoses. The City can also utilize funds to partner with agencies that fight the opioid crisis at its root cause, mental health/homelessness, etc.

There are multiple openings for Police Officer I/II. Starting pay for police officers is competitive, with abundant opportunities for overtime. Officers with experience, education, or certification can be started higher on the pay scale. Additionally, the City offers a \$3,000 signon bonus for new, uncertified police officers!
