COUNCIL CONSIDERATION OF AGENDA ITEMS:

Lansing Town Centre North Final Plat

Approval is being sought for a replat of Lot 1 of Lansing Town Centre. If approved, the final plat will subdivide approximately 14.5 acres into two lots and one tract of 3.866, 9.863, and 0.860 acres respectively to allow potential future construction of a multifamily development on Lot 1 and commercial development on Lot 2. The Planning Commission approved the Final Plat and recommended approval.

Mayor McNeill and Economic Development Director Joshua Gentzler discussed the UDO requirements for greenspace.

Councilmember Brungardt made a motion to approve the dedication of land as described by the Lansing Town Centre North Final Plat. Councilmember Buehler seconded the motion. No discussion took place. Roll Call Vote: Aye: Councilmembers Majure, Garvey, Buehler,

Equipment Replacement Requests

An equipment replacement request for an upgrade to the finance department software has been made.

REPORTS:

City Attorney: State of Kansas court system is down and has been since October 11, 2023, because of a security incident.

Department Heads: Economic Development Director Gentzler stated that there will be changes coming in terms of cyber security. He will brief the council more on that at a later date, but SorWil will be here to help with that process.

City Administrator: The city always gets positive feedback on the Lansing Connection. The company that the city had been working with for a while got bought out by a company in Pennsylvania or something like that. So, it sounds like the current issue of the Connection is going to be a little later than was originally anticipated. But the company that bought out the other company has assured the staff that most everything else will stay the same.

Public Information Officer Ken Miller stated that the digital version will be available November 3, 2023, on the website. He will send out the link on the Friday e-blast.

Mayor McNeill clarified that the printed version would be delayed.

City Administrator Vandall: About a week and a half ago the mayor attended the ribbon cutting for On Demand Mechanical. He indicated that the council may have noticed that on K-7 at the former site of Marco Motors. He continued by stating that those guys had done a fantastic job with that building. It's a new business in town that he thinks employees 15 people.

Councilmember Kirby: 15 and he tries to use local subcontractors.

City Administrator Vandall: They're a real welcome addition to Lansing. The city is so thankful for On Demand Mechanical, and the improvements they've made to that building. Kudos to them and be sure to check them out for your heating, cooling, plumbing needs. Spooky Center was last week. Parks and Recreation Director Jason Crum stated they had over 270 kids attend. That was a really great event for the city and the children in our community. Some of you guys that have been on council for a while might remember this. Several years ago, when the city was doing equipment replacement requests, there would be 10,11,12 different requests from departments. So, he is really thankful for department heads doing a good job maintaining their equipment and being reasonable in their requests. The city went from eight years ago having ten or eleven requests to having one this year. Kudos to the department heads and also kudos to the council for working hard to make sure the equipment is up to date. Along those lines, some of the equipment that is being replaced is going up for public auction. A few of the vehicles that are up will be in the parking lot. So, they will see the Ford Ranger, the Ford van, and a Ford Explorer. There is some equipment at the Street shop going up for auction. That will be on the Purple Wave website.

Governing Body:

Councilmember Majure: Thanked everyone including Director Sanford for the budget piece and helping us get with the computer program since 1993. Next weekend is Veteran's Day. Make sure to pat your veterans on the back and be aware of the amount of travel and traffic. It's a long weekend. Thanks to On Demand and 5 Minute Oil. The 5 Minute Oil is pretty busy too. Business is coming to Lansing. That's a good news story. The Mayor's Christmas Tree...

City Administrator Vandall stated that the tree will be out in the lobby with tags this next week. The big celebration is on the first Sunday of December at the auditorium at the middle school. The deadline for applications was extended. There are currently 6 applications. If you know of any families that are in hard times right now, let us know. The city always reaches out to the school district to ask them. There is a validation of income requirement. Please let the staff know if anyone knows of someone that would benefit from the program.

Councilmember Garvey: Veteran's Day next weekend. That's going to be a big parade downtown in Leavenworth on Saturday. Tuesday, the election is coming up. Be sure and get out and vote.

Councilmember Buehler: Get out and vote. Tim, thanks to the staff. It's been a great year. On this day in 2016, the Chicago Cubs defeated the Cleveland Indians in the World Series. Ending the longest major league championship drought after 108 years.

Councilmember Clemons: Shared information regarding the Leavenworth County Port Authority.

Councilmember Brungardt: God Bless the veterans.

Councilmember Studnicka: Get up early to watch the Chiefs.

Councilmember Gardner: Thanked everyone for their kind words. Apologized for interrupting a citizen at a previous meeting.

Three bids were opened on Monday November 6th, for the above referenced project. This project will extend the sewer from Gilman Road south to McIntyre Road. All necessary easements have been acquired.

Bid Results

Legacy Underground	\$3,836,901.00
Linaweaver Construction, Inc.	\$2,995,003.00

The engineering estimate for this project was \$4,932,235. George Butler Associates, the design engineer, has reviewed the bids and found that Linaweaver Construction met the requirements of the bid, and is a qualified, competent contractor in the state of Kansas. A copy of the engineer's acceptance letter is attached. The project may begin within 14 days of contract approval, and the total contract time for final completion is 320 days. Construction observation services will be provided by Monarch Engineering under a separate contract.

Policy Consideration: N/A

Financial Consideration: Funds for this project will be paid with a combination of the Utility's reserves, the \$1.3M in grant funds from the BASE grant, and financing through the issuance of temporary notes.

Recommended Action: A motion to accept the bid from Linaweaver Construction for the construction of City Project 2021-04, in the amount of \$3,084,853 (Base bid plus 5% construction contingency), (Three million, eighty-four thousand, and eight hundred fifty-three dollars)

Please be advised that we have completed our review of the bid form submitted by Linaweaver Construction, Inc. for the McIntyre Sanitary Sewer Extension project. (Bid tab enclosed.) As of the bid opening on November 6, 2023, Linaweaver was the apparent low bidder.

Mr. Marcus Linaweaver was contacted on November 7, 2023, to discuss the bid that Linaweaver Construction, Inc. submitted for the referenced project. Mr. Linaweaver indicated that Linaweaver is comfortable with the amount shown on their bid. Linaweaver Construction also provided references for similar projects, a list of subcontractors, and a financial statement for review.

Based on the information provided and both GBA's and the City's experience with Linaweaver Construction, Inc. we can find no evidence that the company would not be able to perform Project 21-04 (McIntyre Sewer Extension) in a timely and efficient manner. Therefore, we recommend that Project No. 21-04 be awarded to Linaweaver Construction, Inc. with a base bid in the amount of \$2,995,003.00.





Policy Considerations: Installation of the proposed liner into Storm Sewer B (Alt #2) will have a reduced life than the replacement and result in additional maintenance activities until a permanent repair is performed. By adjusting the liner to Storm Sewer C (Alt #3) this will both address the item, provide significant increase in lifespan, and avoid disruption to the neighbors fencing and landscaping. In this application. This application is better suited as it is not exposed to the traffic or water flow of the primary storm sewer under 4H Road.

Financial: This cost estimate is approx. \$150k to \$200k. Actual cost will be presented once received from contractor.

Options for Consideration:

OPTION A: Issue a change order to contractor to replace Storm Sewer B with 54" RCP, and relocate the liner to Storm Sewer C (Alt #3) or other appropriate pipe. Coordinate for the closure of 4H road to occur outside of when USD469 is in Session. This may require amending the existing budget to utilize Fund 70 reserve balance.

OPTION B: Install as bid. Unsure if liner manufacture will warranty the work due to deterioration existing pipe. Additional maintenance will be required until such time as a permanent repair is effected. There is also greater risk of premature pipe failure of the sewer under 4H Road.

Recommendations: Accept Option A, direct PW to solicit pricing and schedule the work accordingly.

Action: Authorize the PW department to modify the scope of project 2023-03 as discussed. Direct Public Works to develop the plan for a permanent pipe replacement under 4H Road and solicit pricing from the contractor.



Three bids for the McIntyre Sewer Interceptor Project were opened on November 6th. The low bid came from Linaweaver Construction, at \$2,995,003. Our engineer, GBA, reviewed the bids and found that Linaweaver Construction met all of the requirements. The project may begin within 14 days of approval. The total construction timeline for this project is 320 days. This project will be paid for with \$1.3 million in grant funds from the State of Kansas, a portion of reserves in the Wastewater Fund, and a temporary note for the remaining financing. The City's Wastewater Treatment Plant from nearly twenty years ago will be paid off fully in 2025, freeing up funds to tackle other wastewater projects.

The City approved a bid to make repairs to a drainage pipe under 4H Road and along South Valley Drive. The portion under 4H Road was originally going to be a pipe liner to extend the life of the pipe and to keep 4H Road open. Now that the area has been dug up, unfortunately, the pipe is much more eroded than we anticipated, making a pipe liner less effective and potentially voiding the warranty. Public Works Director Mike Spickelmier will present options on what we can do with the pipe liner since it was already purchased by the contractor and what steps we can take to repair or replace the drainage pipe on 4H Road.

The FHWA requires bridge inspections every two years. Leavenworth County and the City of Basehor have been using Finney Turnipseed Transportation & Civil Engineering LLC for their bridge inspections. They submitted a proposal to the City to inspect the City's bridges for \$4,000. Additional inspection, plans, projects, and other services would be negotiated under this professional service agreement.

Surplus Equipment:

Some of the items we replaced earlier this year will be put out for public auction through PurpleWave.com in the next two weeks. Some of the items include a 2007 Ford E350 Van, a 2006 Ford Ranger, and a 2013 Police Ford Explorer. We are also auctioning off two Polaris' from 2005 from the Wastewater Department, as well as a nonoperational Kubota tractor and a nonoperational forklift.

Public Works:

Linaweaver Construction anticipates beginning the 4H & Valley drainage project the week of October 30th. Residents on that stretch of roadway have been notified of the detour. This will replace the corroded pipes in that portion of the Stonecrest Subdivision.

The existing decorative poles on Center Drive were removed the week of October 16th. The islands have been removed, with asphalt being poured the week of November 13th. A total asphalt overlay is not included at this time, but the staff is evaluating the pros/cons of including Center Drive in our annual CIP for 2024.

Update on ARPA Funds:

A summary of the total amount received from the federal government, and what we have spent the funds on is below.

- \$1,823,526.76 American Rescue Plan Act Funds Received
- \$800,000 High Speed Internet in Lansing
- \$90,822 Sewer Improvements near Fairlane
- \$80,000 Sewer Improvements near First Terrace
- \$35,000 Economic Development Data (Buxton)
- \$314,667.73 Water Line Center Drive
- \$503,037.03 ARPA Funds Remaining

We anticipate utilizing ARPA funds to partially fund a storm sewer project next year. We also had a potential multi-use commercial/residential building along K7 inquire about utilizing \$80,000 in ARPA funds to assist with utility work for that project. ARPA funds can also be used for fire equipment. The ARPA funds need to be committed by 12-31-2024 and spent by 12-31-2026.

Wastewater:

A bid opening for the project was held November 6th, and three bids were received. A motion to approve the low bid from Linaweaver Construction will be on the Nov 16th CC meeting. The Kansas Dept. of Wildlife has determined that the 9 Mile stream crossing is "critical habitat" for the Plains minnow, and as such, a restriction to work within the stream will be in place from April 1 thru Oct 31. This restriction has modified project timelines but has not resulted in a change in cost. We are currently awaiting the official notification from the State regarding this issue. Due to supply chain issues, PVC and iron pipe may experience longer lead times. A notice to proceed will be issued for early December 2023 so the contractor can begin the large amount of clearing and grubbing along the project corridor.

Community & Economic Development:

Filliman Dental is now open! Be sure to check out their new building. The property has additional space for another commercial building.

Take5 Oil is now open. We anticipate the light pole in the alley moving, allowing the alley to shift westward to allow a freer flow of traffic. The City also recently paved the southern portion of the alley, which was discussed in a City Council meeting back in 2022.

We anticipate receiving a 7-8 lot preliminary plat in northwest Lansing at some point in the near future.

The special sales tax to pay for DeSoto Road and Bernard Park improvements has generated \$557,389 so far this year, on pace for \$668,867.

The special sales tax for the aquatic center, which began on July 1st, has generated \$168,550 so far this year.

Meetings & Announcements:

The City received four proposals from local financial institutions to be the City's official depository. A committee composed of two councilmen and two staff members are currently reviewing the proposals.

The City will have two openings on the Fire Board in December. The City also has an opening on the Parks & Recreation Advisory Board and multiple openings on the Building Trade Board of Appeals and Plumbing Trade Board of Appeals.
