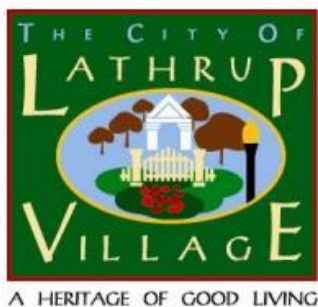

Susan Yeghissia expressed in part: Thanks to City Council for reading the Gun Violence Proclamation, and that statistics have grown from 95 to 130 people killed every day, due to Gun violence, and mentioned that people should ask if there are guns in a house they are visiting, and ask how they store them.

Timothy Hillman expressed in part: thanks to the Parks and Recreation committee members, and thanked Chuck Snelling for sharing information about the Art around the City Hall area, including one in front of Rita's Ice by Mario Moore, a Cass Tech graduate, and that there will be a free tour on June 12 to view all the art.

Jonathan Tara expressed, in part, his comments regarding the video (feed), and asked if the Wi-Fi password can be on the wall.

Tom Kenez, Glenwood, expressed in part: the Lathrup Village Homeowner's Association, which started in 1940, and put on Community programs and events, is moving forward, and they are working on bringing back: the famous pancake breakfast, summer family BBQ, a Scholarship program, a Holiday event, a Golf outing, and more. 12. Reports of Boards, Commissions, and Committees

- a. Downtown Development Authority – DDA Director Colson will be leaving at the end of June 2026.
- b. Parks & Recreation - Food Truck Friday on May 29th, the DIA Inside Out Art tour last Friday, and there will be another one on June 12th in conjunction with Food Truck Fridays, a resident presented wanting to start a GoFundMe for Sarrackwood Park.
- c. Planning Commission – the Study Session tomorrow will go over the Master Plan Economic topic, and at the Regular Meeting, the Parks and Recreation and Sustainability topics, and the Open House is scheduled for July 21st.

Communications & Engagement – looked at draft plan from a formal committee, they are creating Surveys on how people receive and want to receive information, they are looking at getting a budget for the surveys (to be printed and mailed), they looked into analytics between the reach and the engagement and where people are not interacting, they will be asking Council for what they want for ADA recommendation(s), they will launch the first survey in June, and the nature of the Committee also being an outreach Committee to get information to people.

14. Public Comment (speakers are limited to 3 minutes)

Lauren Beras commented in part: thanks to DDA Director Austin Colson, who came in to the role that was open for a bit, which is hard to do with no one there, and we were planning the LVMF, and he helped with the LVMF, and was a good team member and an asset.

Timothy Hillman commented in part: thanks to DDA Director Colson, and that he has worked with him on the Planning Commission, and he has got us prepared, and complimented DDA Director Colson for helping to plant trees, and being at other City events. Mr. Hillman also suggested requesting that someone from the Southfield Public Library be present at some events to register/give out more Library cards, to increase use and connection before the Library millage.

Bob Beras commented in part about wanting to delay the Police car purchase, to leave wiggle room in the Budget, but deferred maintenance is how the roads got so bad; if they were done earlier, it probably would not have gotten so bad.

Diane Anderson commented in part: about the Fee Schedule and charges to the Women's Club, which contributed to the making of the Community Room and kitchen, and their ability to use the room, and concern about what others have and have not paid for the room, and that celebrating the Declaration of Independence should be telling the truth.

Karen Copus expressed in part: Asking if the City had to approve the making of, or has any affiliation with the Lathrup Village Chamber of Commerce.

15. Mayor and Council Comments

Mayor Kantor commented in part:

- Someone from Southfield Public Library is coming to the Lathrup Village Music Festival
- Roads will receive some improvements with crack sealing
- There are use policies for the Community Room
- There is no affiliation with the Lathrup Village Chamber of Commerce
- Proposed Art letters would be in the Right of Way, not the Historic District

- June 1st Town Hall instead of the Study Session to discuss PA 33, Oakland School District, and the Library millage
- There is a Lathrup Village Women's Club luncheon on May 26th
- Dogs are required to be on a leash. We have had some incidents of dogs charging
- The owners of a building in Southfield, where there is an ICE-related office, were asked to foster a Town Hall, and they declined the offer
- Surnow is working on the school project funding
- There is a grant from Oakland County for the LV Music festival
- Congratulations to City Administrator Greene for being on the list of 40 under 40 Officials, and congratulations on the birth of his and his wife's child.

Councilmember Sousanis commented in part:

- He is concerned that the entire budget is deferred maintenance
- To Diane Anderson, he believes in recognizing Juneteenth; it is not about the Constitution, but he will take it under advisement to have another Proclamation to celebrate the passing of the 13th Amendment
- He does want more clarity on all our room rentals (including the Community Room) and knows the procedures and rules
- Looking at rules as to how things get in our Newsletter
- Addressing the issue with the Chamber of Commerce, it is made up of members, and we have a liaison with that group. We know that Mark was the head of that group, and he doesn't think we should pretend that we are not aware of that; he thinks we should admit that we have a liaison. Those groups are those groups; they are not their leader, they are the members. It bears recognition, acknowledgement, and some caution to make sure that we are associated with who we want to be.
