MEETING MINUTES

The meeting convened virtually at approximately 6:02 pm. The roll was called with Council President James Kole, Chair, Dana Cunningham, Amy Dunham, Amy Knox, and Alvin Smith, present. City Staff present was Sara A. Green, CPM, CMC, City Clerk. Absent were: Nicole Gore and Michelle Keating. There were two (2) members of the public in attendance.

Agenda Item No. 2 was Approval of Minutes for the September 26, 2024 meeting. Amy Dunham made a motion to approve the minutes with the following changes: 1. Sponsors had been secured: Delete Laurel Volunteer Fire Department and Nothing Bundt Cakes. 2. Sponsor Amelia's spelling change to Emelia's. The motion was seconded by Dana Cunningham and carried on a voice vote by all Members present.

Amy Dunham noted that she had not heard back from any photo booth vendors. The Committee briefly discussed purchasing photo both equipment. On motion by Amy Knox, seconded by Chairman Kole, and carried on a voice vote of all Members present, voted to authorize the purchase of photo booth equipment and backdrop from Amazon at a maximum of \$150.

Lastly, Chairman Kole noted that he had forgotten to schedule port-a-pots for the event. The Committee, on voice vote of all Members present authorized Chairman Kole to order and schedule port-a-pots for the event.

There being no further business, the meeting adjourned at approximately 6:58 pm.
