The meeting convened in the Council Chamber of the Joseph R. Robison Laurel Municipal Center at approximately 6:00 pm with Council President James Kole presiding. The roll was called with Councilman Carl W. DeWalt, Councilwoman Christine M. Johnson, Councilman Jeffrey W. Mills, Councilwoman Kyla Clark, and Keith R. Sydnor, Mayor present.

The following staff members were also present: Christian L. Pulley, CPM, City Administrator, Joanne Hall Barr, Deputy City Administrator, Sara A. Green, CPM, CMC, City Clerk, Ana R. Navarro, MMC, Executive Assistant to the Mayor, Bill Bailey, Director, Department of Parks and Recreation, James Cornwell-Shiel, Director, Department of Information Technology, Chief Russell Hamill, LPD, Robert Love, Director, Department of Economic and Community Development, S. Michele Saylor, Director, Department of Budget and Personnel Services, Stephanie P. Anderson City Solicitor, Deputy Chief Mark Plazinski, LPD, Tommy Helms, Department of Public Works, and Stephanie P. Anderson, Esquire. There were approximately fifteen (15) members of the public present.

Mayor Sydnor led the group in the Pledge of Allegiance.

Agenda Item No. 4 was approval of the following meeting minutes:

November 27, 2023- Sine Die

November 27, 2023- 1<sup>st</sup> Meeting of the Mayor and City Council

Councilwoman Johnson made a motion to approve both sets of minutes. Councilwoman Clark seconded the motion that was carried on a roll call vote of all Councilmembers present as written.

Next, the Mayor and City Councilmembers provided their reports regarding events and happenings since the last meeting and made announcements regarding upcoming meetings and events.



Agenda Item No. 6 was Mayoral Reappointments as follows:

Councilman Mills made a motion to approve the reappointments as presented. The motion was seconded by Councilman DeWalt and carried on a roll call vote of all Councilmembers present.

Next, President Kole opened the General Public Hearing at approximately 6:20 pm. There was no one signed up to speak and President Kole closed the public hearing at 6:21 pm.

Agenda Item No. 9 was the Second Public Hearing with possible action on Resolution No. 1-2024- A Resolution of the Mayor and City Council of Laurel, Maryland to Pay Tribute to the Honorable Craig A. Moe by Renaming the City of Laurel Multiservice Center as the Craig A. Moe Laurel Multiservice Center. President Kole read the title for the second reading. Mayor Keith R. Sydnor presented the proposed ordinance noting that six (6) applications requesting to rename the Multiservice Center per the City of Laurel Naming Policy for Parks, Recreational Facilities, City-Owned Buildings, Streets, Alleyways and other City Assets (Resolution No. 7-21) had been received. Mayor Sydnor said that Phase II of construction at the Multiservice Center was expected to be completed in August 2024. President Kole opened the public hearing on the item at 6:23 pm. The first person signed up to speak on the item was The Honorable Gayle W. Snyder, 507 Prince George Street Laurel, Maryland 20707, former Laurel City Council President. Mrs. Snyder said that she had submitted one of the applications to rename the Multiservice Center in honor of former Mayor Craig A. Moe, provided a comprehensive list of many of Mayor Moe's accomplishments on behalf of and for the City of Laurel during his thirty-three (33) years of City service. Former President Snyder noted that the Multiservice Center was Mayor Moe's vision and provided a summation of the services that would be available at the Multiservice Center.

Former Council President Michael R. Leszcz, 339 Prince George Street Laurel, Maryland 20707 provided remarks stating that he and his wife Mrs. Mary-Eileen Leszcz submitted one of the applications to the City to rename the Multiservice Center for Former Mayor Moe and urged the Council's approval. Former Councilman James Cross, 16013 Dorset Road Laurel, Maryland 20707 spoke in favor of the resolution and urged the Council's approval.

The Honorable Frederick Smalls, former Council President, 14933 Belle Ami Drive Laurel, Maryland 20707 spoke in favor of the proposed renaming and stated that in addition to all of the things former Mayor Moe did for the City and residents over the years, there would not be a Laurel Medical Center nor a Multiservice Center if it was not for Mayor Moe. Mr. Smalls said that it would be a travesty not to name the Multiservice Center in honor of former Mayor Moe.

Former Mayor Robert J. DiPietro, 16908 Melbourne Drive Laurel, Maryland 20707 spoke in favor of the renaming in honor of former Mayor Moe and cited many of Mayor Moe's accomplishments in his 33 years of City service. Former Laurel City Council President Donna L. Crary, 400 Montrose Avenue Laurel, Maryland 20707 spoke in favor of the renaming and noted that no matter some of the personal issues a couple of the Councilmembers may have had with former Mayor Moe, they could never negate the accomplishments of Mayor Moe, the many things he did for the betterment of the City of Laurel and the sacrifice for the majority of former Mayor Moe's adult life that he made for the City of Laurel



and the staff and urged the favorable vote of the Council. There was no one else signed up to speak and President Kole closed the public hearing at 6:38 pm.

Councilman DeWalt again brought up his feelings regarding former Mayor Moe and statements he had made in his personal newsletter called the "Moe Gram", before the November election of the Mayor and City Council and that he had not received an apology from former Mayor Moe. Councilman Mills noted that he was hurt by what Mayor Moe had said about him in his newsletter as well, but that it was clear from the testimony of the citizens and former elected City leaders that Mayor Moe deserved to have the Multiservice Center renamed in his honor. Councilman Mills made a motion to approve Resolution No. 1-2024 as presented. Councilwoman Johnson seconded the motion. Roll call continued with Councilman DeWalt voting "No", Councilwoman Clark voting "Yes", President Kole voting "Yes" and Mayor Sydnor concurring with the vote.

The next agenda item was the reappointment of Mr. Bill Bailey, Director, Department of Parks and Recreation. Mayor Sydnor summarized why he was reappointing Mr. Bailey and requested the Council's favorable approval. Councilman DeWalt made a motion to approve the reappointment, Councilwoman Clark seconded the motion that was carried on a roll call vote of all members present.

Agenda Item No. 11 was the reappointment of Christina Cornwell, Director, Department of Community Resources and Emergency Management. Mayor Sydnor requested the Council's approval. Councilman Mills made a motion to approve the reappointment, Councilman DeWalt seconded the motion that was carried on a roll call vote of all other Councilmembers present.

Agenda Item No. 12 was the reappointment of Russell E. Hamill, III, Chief of Police, Laurel Police Department. Mayor Sydnor provided a summary of Chief Hamill's resume and experience and requested the Council's favorable vote of the appointment. Councilwoman Clark made a motion to approve the appointment, Councilman Mills seconded the motion and roll call continued with a unanimous approval of the appointment.



SUBJ: Van Dusen Road Improvement Corridor Survey-Phase I

The Department of Public Works is requesting approval for engineering survey services for the Van Dusen Road Improvement Project. Van Dusen Road is one the City's major thoroughfares that runs north and south from Konterra Rd to Old Sandy Spring and serves the Westside community, the UM Medical Center, and several other residential and commercial communities along its route. It is currently scheduled for resurfacing, stormwater drainage assessments, and pedestrian facility upgrades to meet the latest ADA standards. This work will support the design and construction of improvements along this corridor that were recommended in the Concept Study recently prepared by Century. The recommended Van Dusen Road improvements will be contained within existing City/State Right-of-Way (ROW); however, this survey effort will also include establishing ROW workmaps for areas where traffic guardrails are proposed.

**Scope of Work:**


Century Engineering will provide the manpower, technological and appropriate software to perform a topographic survey for the entire 1.6-mile Van Dusen Road Study corridor. The results will be compiled and submitted to the City based on the following two (2) segments. Contee Road to Cherry Lane (Segment No. 1) The Survey along this segment will be priority, and the results will be submitted to complete the Final Design and Bidding for this segment of the corridor by April 2024. Based on the preliminary recommendations in the Concept Study, the design for this segment should not require Prince George's County review for Storm Drain, Sediment Control or Technical SWM. Cherry Lane to Old Sandy Spring Road (Segment No.2) – Survey along this segment will facilitate the associated Final Design and Bidding; however, the design is anticipated to include input from Prince George's County, which will have a long lead time, unlike Segment No. 1. The survey results will be compiled and submitted only after all survey and ROW work for Segment No. 1 is completed. This phase of work will also include task management efforts, will involve ongoing Project Management; and a minimum of two (2) Coordination/Status Update Meetings; QA/QC reviews of survey and ROW work products. Century Engineering is one of the three A & E firms on retainer with the city. Their proposed fee for this phase of the project is \$117,690.35.

**Funding and Recommendation:**



SUBJECT: Harrison-Burton Memorial Stage Roof Replacement

The Department of Parks and Recreation is requesting approval to replace the roof at the Harrison-Burton Memorial Stage located at Granville Gude Park.

**Specifications:**

The Harrison-Burton Memorial Stage was constructed in 1992 and is a major centerpiece for the Department of Parks and Recreation's outdoor concerts, movies, and special events and serves as the City's Fourth of July's main stage.

Upon inspection by city staff, the stage was found to have several leaks and deteriorating wood decking through the structure. The proposed work will include removing the existing shingles, flashing and all wood tongue and groove decking. The replacement roof will include all new tongue and groove decking, fascia boards and new 24-gauge galvanized steel roofing. A 5-year warranty on materials and installation is provided by the contractor and a 40-year manufacturer warranty on the steel roof for any manufacturer defects.

The Department of Parks and Recreation was able to secure three bids which are as follows:

Funding for this expenditure is provided in the Adopted FY2024 CIP – Major Facility Maintenance.

**Recommendation:**

It is recommended that the Mayor and City Council award the purchase and replacement of the roof for the Harrison-Burton Memorial Stage at Granville Gude Park to Paramount Roofing & Construction of Pasadena, Maryland for a cost of \$36,750.00 and provide for a contingency of 10% for an additional \$3,675.00 for an overall total proposal of \$40,425.00.



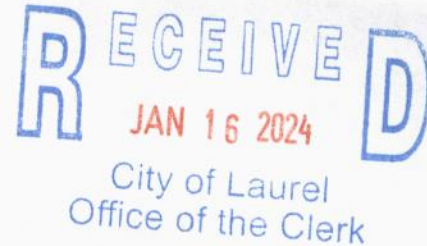
