Baseball at the high school has not been approved yet for the American Legion Field in Thompson Park. Some discussion followed. 6 new light poles are being installed at the Legion Field. The poles and installation were donated by Northwestern Energy.

- 5. Riverside Park Lead cleanup Not enough lead to recover. Waiting for a report to submit to the health department for determination of safety.
