1. Call to Order and Declare a Quorum

The meeting was called to order @5:30PM

MDD members Recker, Gilbert, Oates, Hyland, and Oates were present. Farmer was absent.

Recker lead the prayer, as well as the pledge.

5. Discussion/Action

A. Discuss and consider action on Market day agreement

Executive Director Felicia Carvajal spoke on the Market day agreement, she states there was never an agreement with Market Days. With the new ownership we would like to have an agreement with them going further. This will be a one year agreement and we will revisit it each year. Market Days will be charged \$100 per event , with flexibility regarding the number and scheduling of events. The MDD will serve as the designated authority for this agreement.

Motion made by Oates to accept the Market day agreement, seconded by Hyland, all in favor

B. Discuss and consider action on the Youth Empowerment Program - LVPD Golf Scholarship

Chief Keil discussed the LVPD Golf Scholarship, this is the fourth year the Police Department has hosted the event. The event is nonprofit, with all proceeds going directly toward scholarships. Eligible applicants must be high school seniors who have received an acceptance letter from a college or trade school. Each scholarship

awarded is \$1,000. The LVPD is requesting a \$1,000 contribution to support the scholarship fund.

Motion made by Gilbert to contribute \$1,000 to the Youth Empowerment Program - LVPD Golf Scholarship, seconded by Oates, all in favor

C. Discuss and consider action on the Little Libraries

Scout master John Keese spoke, he states the little libraries would be a good eagle scout project for the scout that accompanied him.

Executive Director Felicia Carvajal states we will have two built for now. One on the side of City Hall, as well as one at the park.

Mr. Keese states he will bring this to the scouts for approval, once this is approved he will let us know along with dates of completion.

Motion made by Hyland to have the scouts work with Felicia on the little libraries, seconded by Gilbert, all in favor
