6. Intergovernmental Agreement with City of Lawrenceville – 92 South Clayton Street

Chairman Merritt presented the Board with an Intergovernmental Agreement between the Board and the City of Lawrenceville for 92 South Clayton Street. The Intergovernmental Agreement is for the City of Lawrenceville to move the 92 South Clayton Street property to the Downtown Development Authority. The Downtown Development Authority would be able to sell the property with all proceeds, except expenses incurred by the Downtown Development Authority, to the City of Lawrenceville.

7. Proposal for Conceptual Development Plan from Precision Planning

Chairman Merritt presented a proposal from Precision Planning to do a Conceptual Development Plan for property located along Collins Industrial Way, east of Treecreek Parkway in Lawrenceville (Tax Parcel 7010-010) in the amount of \$5,171.99. This property is 17.49 acres, but since part of it is wetlands and part of it has an easement for the Colonial Pipeline only roughly 5-6 acres may be used for development.

9. State Small Business Credit Initiative Loan Program

Chairman Merritt shared the application on the Georgia Department of Community Affairs State Small Business Credit Initiative through the Treasury Department with the Board. This opportunity is for owner operated businesses for up to \$1.2M, 50% of the loan must come from a bank, the other 50% would be through this opportunity. There is a 3.5% interest rate for the loan. The property must be commercial not residential. This would be a great way to renovate or build a new building.

Mainstreet Business

Jasmine Billings, Director, Community & Economic Development gave the Mainstreet update to the Board.

Gwinnett County has made a small business grant available for businesses that were negatively impacted from COVID. The amount they are able to apply for is between \$3,000-\$15,000. The information can be found on the Gwinnett County website.

Facade grant for this year is completed.

Arts Commission is hosting a community mural project. The mural will be painted on a wall on Jackson Street below the Post Office. There are two dates that community members are able to help paint.
