- The Community Connections Workshops
 - They are going well. Westbridge Solutions has done a great job. Attendance has been a challenge. PM has worked to address attendance challenges and will continue to do so when we conduct these workshops in Year 3.
- ReCAST Sustainability
 - Key question: What will remain when the grant cycle ends in 2026? Members offered suggestions including
 - Seeking additional funding sources
 - Discovering the trust value and cost of the program. What does the City of Lawrenceville value most about the program? What are the costs associated with producing what is most valued?
 - Agreeing to take up this question again in the future
