General Discussion

Program Update - Impact46

Katie Inks provided an update regarding two Impact46 key programs: 1) Students46 (S46) and 2) the Lawrenceville Response Center (LRC).

S46: She shared the progress of Lawrenceville Legacy Leaders, the youth advisory program funded through ReCAST. We also heard about the upcoming Love Lawrenceville Day and the positive feedback from youth, parents, mentors, and internship partners regarding the Summer of Impact.

LRC: She shared about ReCAST deliverables and the progress and impact of the LRC's work. The board asked additional questions about the Deauville relocation project and the FIRST Housing Center. Katie shared about the FIRST Housing Center, and Marcus said he would email the Facebook recording of the LRC's August Council presentation; that presentation shared the Deauville project results.

Marcus reminded the board that Katie's responses regarding the Deauville project were offered as a courtesy to the ReCAST board and that ReCAST didn't provide funding toward that project.

ReCAST Budget Presentation

Program Manager Marcus Thorne shared the anticipated ReCAST Year 4 Budget. Tracy Joseph requested to see the proposed budgets from Years 1-5, and Marcus committed to providing those budgets via email.

ReCAST Program Update

During his presentation, Marcus:

- 1) Shared reflections from the prior meeting regarding including parents within the ReCAST mental health service provision framework.
- 2) Provided guidance to board members regarding solicitation from other organizations to represent the City or ReCAST. He asked board members to inform him of such requests so that he could include the city communications team for awareness.
- 3) Shared progress related to ReCAST's Year 4 transition plan
- 4) Mentioned ReCAST outreach/event possibilities for next year
- 5) Provided an update from Phoenix High School's Engagement Summit. Held on 10/8, the Youth Engagement Summit supports local high school students in providing tools and resources to 1) think entrepreneurially, 2) strengthen their mental health, and 3) build and amplify police/youth relations and trust.

Additionally, Marcus sought board guidance for an update of the agreement between the Gwinnett County Public Schools and the City of Lawrenceville (for ReCAST). This update is

sought due to the Year 4 change in behavioral health partner from Families First to View Point Health; the update will clarify (and name) the new partner.
