# 2. Discussion between the City of Leon Valley and the Leon Valley Historical Society Regarding History and Timeline

Kathy Hill, Leon Valley Historical Society Chair, gave a brief presentation on the history of the Huebner Onion House.

Dr. Crystal Caldera, City Manager, gave a brief presentation on the history of the relationship, going from a Private-Public Partnership to a Memorandum of Understanding (MOU) between the City of Leon Valley and the Leon Valley Historical Society.

There was a consensus that the City Council and the LVHS get back together to get an update within six (6) months to report out on discussions with the Texas Historic Commission.

**SAWS/Huebner Creek Erosion -** Staff will also bring back a presentation from Ardurra to be held at a future Saturday workshop. After the City Council chooses a plan, the LVHS will meet with SAWS to discuss further.

Dr. Crystal Caldera, City Manager, provided the following recap of next steps: 1. On the erosion - staff will bring back a presentation from the engineers to the Council and the
