a. Discussion and Possible Action on the Approval of Meeting Minutes:

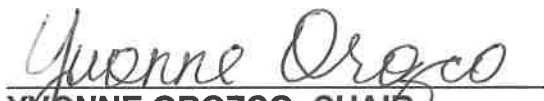
- i. 02/26/2024, Economic & Community Development Advisory Committee Meeting Minutes
