1. Call the city of Leon Valley Regular Earthwise Living Committee Meeting to Order and Determine a Quorum is Present

2. Review and Consider Approval of May 6, 2026 Earthwise Living Committee Meeting Minutes

3. Report of Earthwise Living Day 2026

Staff Liaison Miranda provided an update on the purchase and costs of two rain barrels and two composters, along with the committee's updated available balance. Discussion followed regarding the amount to request for rollover from sponsorship funds. Chair Campos made a motion to request that Staff submit a \$5,000 rollover request to City Council for consideration. Key seconded the motion.

4. Discussion and Possible Action on the Purchase of Additional Items

Additional discussion took place on making an additional purchase of a silver metal free standing flower bed. The committee reached a consensus for Staff Liaison Miranda to proceed with the purchase.

5. Discussion and Possible Action of Vendor/Exhibitor Assignments

Discussion took place and all agreed to maintain as close as possible assignment of Vendor/exhibitors due to rapport with current vendors. Assignments were made. Some assignments went out to members not present at this meeting. Additional discussion will

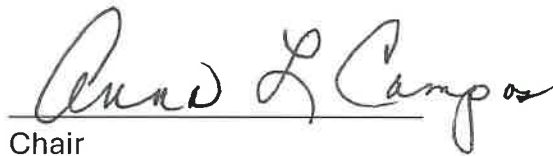
take place regarding our forms to our sponsors/vendors/exhibitors/food vendors at our September 2026 meeting.

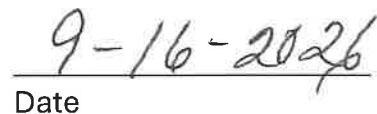
6. Announcements, Updates, and Other Business.
