The Public Works Committee of the Lincoln Parish Police Jury met in the Police Jury Meeting Room, 100 West Texas Avenue, Tuesday, May 14, 2024, at 6:15 p.m. Present were: Greg Williams, Chair, Dan Lord, Milton Melton, and Diane Richards

ABSENT: T.J. Cranford

Chair Williams called the meeting to order and Milton Melton delivered the Invocation.

Milton Melton offered a motion, seconded by Dan Lord, to approve the Agenda. The motion carried with the following votes:

Chair Williams called for Public Comments on Agenda Items. Mr. Matt Gilbert stated that he would like to see Louisiana Highway 818 repaved.

The first item on the Agenda was a presentation by Mr. Matthew French, Assistant District Administrator/Engineer for Louisiana DOTD on the Right Sizing Program. No action was taken.

Next item on the Agenda was to discuss, and take action if necessary, approval of an Intergovernmental Cooperative Endeavor Agreement with Waterworks District No. 3. for the billing and collection of receipts for sewerage system usage for customers in Lincoln Parish Sewerage District No. 1. Next item on the Agenda was to discuss and take action if necessary, amending to the 2024 Capital Improvement Plan for drainage work in Plantation Hills Subdivision, in the amount of \$63,250.00. Next item on the Agenda was approval of the final plat for the Village at Choudrant Creek, Unit 2 mobile home park. Dan Lord offered a motion, seconded by Milton Melton, to approve the final plat for Village at Choudrant Creek, Unit 2. The motion carried with the following votes:

Next item on the Agenda was to consider, and take action if necessary assistance to Municipalities.
