The Public Works Committee of the Lincoln Parish Police Jury met at the Lincoln Parish Library Events Center, Tuesday, April 13, 2021 at 6:00 p.m. Present were: Matt Pullin, Chair, Theresa Wyatt, T.J. Cranford, Logan Hunt, and Glenn Scriber.

Matt Pullin called the meeting to order and delivered the invocation.

Glenn Scriber offered a motion, seconded by Theresa Wyatt, to approve the agenda as presented. The motion carried with the following votes:

YEAS: Wyatt, Cranford, Hunt, Scriber, and Pullin

First item on the agenda was to recommend adopting an ordinance amending section 6-4.13 (speed limit) of the Lincoln Parish Code of Ordinances setting forth a 25 mile per hour speed limit on Baxter Road. Doug Postel, Parish Administrator explained that Baxter Road did not have an established speed limit and that a study was conducted to determine the average speed. Mr. Postel recommended setting the speed limit to 25 miles per. Glenn Scriber offered a motion, seconded by Logan Hunt, to adopt an ordinance setting forth the 25 mile per hour on Baxter Road. The motion carried with the following votes:

Next item on the agenda was to recommend entering into rental agreement for a front-end loader. Mrs. Jeri Webb, Purchasing Officer, explained that River City Hydraulics can provide the Police Jury with a front-end loader for approximately \$1000.00 less per month than the current rental agreement with Big Truck Rental. After discussion, Logan Hunt offered a motion, seconded by Theresa Wyatt, to enter into a rental agreement with River City Hydraulics for a front-end loader. The motion carried with the following votes:

Next item on the agenda was to recommend authorizing a resolution to DOTD for a traffic study at Tarbutton Road and Highway 150. Glenn Scriber offered a motion, seconded by Theresa Wyatt, to authorize a resolution to LA DOTD for a traffic study at Tarbutton Road and Highway 150. The motion carried with the following votes:

Next item on the agenda was a preliminary plat for the Roberson Property. It was noted that the Riley Co. and the property owner were working together to make the necessary changes to the property. After discussion, no action was taken.

Next item on the agenda was the preliminary plat for the Stowe Ridge Subdivision. Mr. Postel noted the plat was for informational purposes only. No action was taken.

Next item on the agenda was the preliminary plat for The Reserve at Moore's Dairy Road. Mr. Postel noted that the plat was in the beginning stages of 152 units. After discussion, no action was taken.

Next item on the agenda was assistance requests. Theresa Wyatt offered a motion, seconded by Logan Hunt, to approve Dubach's requests for assistance for debris pickup from the hurricane, Hamilton Road culvert and ditch digging. The motion carried with the following votes:

Richard Durrett called the meeting to order and Hazel Hunter delivered the invocation and led the Pledge of Allegiance.

Annette Straughter offered a motion, seconded by Logan Hunt, to approve the agenda as presented. The motion carried with the following votes:

Mr. Durrett called for public comment.

The following resolution was offered by Theresa Wyatt and seconded by Sharyon Mayfield:

### **RESOLUTION**

A resolution ordering and calling a special election to be held in the Parish of Lincoln, State of Louisiana, to authorize the continuation of a special tax therein; making application to the State Bond Commission and providing for other matters in connection therewith.

BE IT RESOLVED by the Police Jury of the Parish of Lincoln, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Lincoln, State of Louisiana (the "Parish"), that:

SECTION 1. Election Call. Subject to the approval of the State Bond Commission, and under the authority conferred by the Constitution of the State of Louisiana of 1974, including Article VI, Section 26 thereof, the applicable provisions of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the Parish on **SATURDAY, OCTOBER 9, 2021**, between the hours of seven o'clock (7:00) a.m. and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

### PROPOSITION (MILLAGE CONTINUATION)

Shall the Parish of Lincoln, State of Louisiana (the "Parish"), be authorized to levy and collect a special tax of four and forty-nine hundredths (4.49) mills on all property subject to taxation in Lincoln Parish (an estimated \$2,158,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning



with the year 2021 and ending with the year 2030, for the purpose of providing funds for equipment, supplies, maintenance, operation, construction and support of a public library and its branch or branches in the Parish?

SECTION 2. Publication of Notice of Election. A Notice of Special Election shall be published in *The Ruston Daily Leader*, a newspaper of general circulation within the Parish, published in Ruston, Louisiana, and being the official journal of the Parish, once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full.

Notwithstanding the foregoing, prior to the publication of the Notice of Election, the President is authorized and directed to make any amendments to the foregoing proposition that may be required to comply with any state or federal regulatory agencies.

SECTION 3. Canvass. This Governing Authority shall meet at its regular meeting place, the Police Jury Meeting Room, Third Floor, 100 West Texas Avenue, Ruston, Louisiana, on **TUESDAY, OCTOBER 12, 2021**, at **SEVEN O'CLOCK (7:00) P.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.

SECTION 4. Polling Places. The polling places for the precincts in the Parish are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. Election Commissioners; Voting Machines. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held as provided in Section 3 hereof. All registered voters in the Parish will be entitled to vote at the special election, and voting machines shall be used.

SECTION 6. Authorization of Officers. The Parish Administrator of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the President and/or Parish Administrator of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election.

SECTION 7. Furnishing Election Call to Election Officials. Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines of Lincoln Parish and the Registrar of Voters of Lincoln Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. Application to State Bond Commission. Application is made to the State Bond Commission for consent and authority to hold the special election as herein provided, and in the event said election carries for further consent and authority to continue to levy and collect the special tax provided for therein. A certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application.

NOTICE OF SPECIAL ELECTION

Pursuant to the provisions of a resolution adopted by the Police Jury of the Parish of Lincoln, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Lincoln, State of Louisiana (the "Parish"), on April 13, 2021,

NOTICE IS HEREBY GIVEN that a special election will be held within the Parish on **SATURDAY, OCTOBER 9, 2021**, and that at the said election there will be submitted to all registered voters in the Parish qualified and entitled to vote at the said election under the Constitution and Laws of the State of Louisiana and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION  
(MILLAGE CONTINUATION)

Shall the Parish of Lincoln, State of Louisiana (the "Parish"), be authorized to levy and collect a special tax of four and forty-nine hundredths (4.49) mills on all property subject to taxation in Lincoln Parish (an estimated \$2,158,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2021 and ending with the year 2030, for the purpose of providing funds for equipment, supplies, maintenance, operation, construction and support of a public library and its branch or branches in the Parish?

Said special election will be held at each and every polling place in the Parish of Lincoln, which polls will open at seven o'clock (7:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541.

The polling places at the precincts in the Parish are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, shall be those persons designated according to law.

The estimated cost of this election as determined by the Secretary of State based upon the provisions of Chapter 8-A of Title 18 and actual costs of similar elections is \$48,800.

Notice is further given that a portion of the monies collected from the tax described in the Proposition shall be remitted to certain state and statewide retirement systems in the manner required by law.

The said special election will be held in accordance with the applicable provisions of Chapter 5 and Chapter 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, and the officers appointed to hold the said election, as provided in this Notice of Special Election, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, will make due returns thereof to said Governing Authority, and NOTICE IS HEREBY FURTHER GIVEN that the Governing Authority will meet at its regular meeting place, the Police Jury Meeting Room, Third Floor, 100 West Texas Avenue, Ruston, Louisiana, on **TUESDAY, OCTOBER 12, 2021**, at **SEVEN O'CLOCK (7:00) P.M.**, and shall then and there in

open and public session proceed to examine and canvass the returns and declare the result of the said special election. All registered voters of the Parish are entitled to vote at said special election and voting machines will be used.

**Resolution 21-17**

**A RESOLUTION IN OPPOSITION OF ALL PROPOSED LEGISLATION THAT TRANSFERS THE ADMINISTRATION AND COLLECTION OF LOCAL SALES & USE TAXES TO THE LOUISIANA DEPARTMENT OF REVENUE.**

**WHEREAS**, the Constitution of the State of Louisiana grants local governments the right to levy and collect local sales and use taxes;

**WHEREAS**, House Bill 199 to create the State and Local Streamlined Sales and Use Tax Commission was introduced in the 2021 Regular Legislative Session that would transfer collection responsibility of local sales and use tax levies to the state; and

**WHEREAS**, local taxing authorities possess the best knowledge and experience to properly collect its own taxes and have a proven record of proactive advancements in the areas of enforcement, audit coverage, dispute resolution, reporting technology and successful litigation; and

**WHEREAS**, the state of Louisiana's budget issues do not offer prospects for the Department of Revenue to have sufficient resources to provide the necessary taxpayer assistance, enforcement programs and training of its employees on the specific application of local sales and use tax ordinances without significant cost contributions from local governments, thereby resulting in the direct and indirect loss of local tax receipts; and

**WHEREAS**, many local taxing authorities have issued bonded indebtedness guaranteed by the passage locally adopted sales and use tax levies, collection of said levies the direct responsibility of local governments, and which transfer of that responsibility to a state agency may generate legal challenges and jeopardize future bond issues; and

**WHEREAS**, the central local collector in each parish is directly responsible to the local taxing authorities and their elected officials for the performance of local tax administration, uncertainty exists as to who in the State and Local Streamlined Sales and Use Tax Commission will be accountable to local taxing authorities for the performance of such critical local tax administration,

**Sec. 3-6. Bottle clubs and private clubs; definitions thereof; hours of operation.**

**(a) Definitions:**

***Bottle club:*** means any establishment wherein the owner/operator, licensed seller of alcoholic beverages, or any employee of the owner/operator or licensed seller of alcoholic beverages, does not sell, serve, handle, dispense or store alcoholic beverages, or is not doing so at that time, but in which patrons are allowed to consume alcoholic beverages on or in the premises either from the patron's own store, stock or supplies of alcoholic beverages or from any other source.

***Private club:*** means an organization with limited and restricted membership which is either:

- (1) Non-profit in nature and classified as exempt from the payment of state and federal income tax; or
- (2) Charges members dues or other charges for membership of at least fifty dollars (\$50.00) per month, requires that the dues of any member must be fully paid in order to be a member, and exists for a fraternal, educational or social purpose.

**(b) Hours of operation for bottle clubs:**

- (1) It shall be unlawful for any bottle club to admit or permit any member of the public to enter on or into an establishment or any part thereof, between the hours of midnight and 7:00 a.m. and between the hours of 12:00 a.m. on Sunday until 7:00 a.m. the following Monday.
- (2) In any bottle club, the owner/operator or licensed seller of alcoholic beverages shall remove all patrons and members of the public from the premises by 12:01 a.m. and all doors to said premises shall be locked and closed and the establishment not re-opened until 7:00 a.m. the next morning on which sales of alcoholic beverages can be lawfully made. The owner/operator or licensed seller of alcoholic beverages and his employees or agents may enter the closed premises for the purpose of cleaning, taking stock or other such work reasonably required to be performed on or within the premises while such premises are closed and no business is being transacted.
- (3) It shall be unlawful for any bottle club to permit members of the public to remain in its parking lot for more than thirty (30) minutes after its closing.
- (4) Private clubs and/or individuals who allow nonmembers or the general public entry on or into the premises, who allow alcoholic consumption thereon, and who charge a fee or something of value for entry on or into the premises shall be subject to the same operating guidelines for bottle clubs as set forth in this subsection.
