Subject: Committee Report

The Parks, Recreation and Tourism Committee of the Lincoln Parish Police Jury met at the Library Events Center, 910 North Trenton Street, Tuesday, August 10, 2021 at 5:30 PM. Present were: Glenn Scriber, Chair; TJ Cranford, Logan Hunt, and Skip Russell.

Absent: Annette Straughter

Glenn Scriber called the meeting to order and delivered the Invocation.

Skip Russell offered a motion, seconded by Glenn Scriber, to approve the Agenda. The motion carried with the following votes:

Yeas: Cranford, Hunt, Scriber, Russell

Nays: None

Absent: Straughter

First on the Agenda was to discuss LCDBG grants that the parish park would be eligible for. Chair Scriber called on Administrator Doug Postel to give a report on these grants and how to proceed. Mr. Postel stated that he, Mr. Durrett, and Mr. Melton participated in a conference call with the Office of Community Development concerning these grants, which are funds that the state received directly as part of the American Rescue Act Funding. He stated that one of the programs being funded through the state, with this money, is the Love Louisiana Outdoors Program which is to develop or rehabilitate outdoor fitness and recreation parks in jurisdictions that meet the national objective requirements of low to moderate income. Only certain areas qualify for this funding; Lincoln Parish is one of eight parishes that parish wide qualify as low to moderate income area. He stated that Lincoln Parish's eligible amount is \$750,000.00 and that a proposal for this portion of the funding would be needed. He stated that possible projects include construction/reconstruction/rehabilitation of a park playground or greenspace or to provide outdoor recreation and fitness equipment to residents while maintaining appropriate social distancing to prevent the spread of Covid-19.

Mr. Postel stated that current projects would be to upgrade the water and sewer systems that need significant improvements, playground surfaces that are coming up, as well as

some improvements to bike and walking trails throughout the park. Mr. Postel recommends creating a small group consisting of himself, Mr. Durrett, Mr. Scriber, and Mr. Ramsaur to come up with the most needed projects and to authorize them to proceed with the application which is due by September 9, 2021.

After discussion, Skip Russell offered a motion, seconded by Logan Hunt to recommend creating a committee consisting of Mr. Durrett, Mr. Scriber, Mr. Ramsaur, and Mr. Postel to generate ideas and proceed with the application. The motion carried with the following vote:

The Personnel/Benefits Committee of the Lincoln Parish Police Jury met at the Lincoln Parish Library Events Center on Tuesday, August 10, 2021, at 6:00 p.m. Present were: Joe Henderson, Chair, T.J. Cranford, Logan Hunt, Milton Melton, and Sharyon Mayfield.

Joe Henderson called the meeting to order and Sharyon Mayfield delivered the invocation.

Milton Melton offered a motion, seconded by Sharyon Mayfield, to approve the agenda. The motion carried with the following votes:

YEAS: Cranford, Hunt, Henderson, Melton, and Mayfield

The first item on the agenda was to discuss an appointment to the Sparta Groundwater Conservation District Commission. Mr. Durrett noted that he had resigned from the Sparta Commission and that Mrs. Straughter's name had been submitted to the Governor's office for approval. The Governor's office, however, appointed Mr. Milton Melton to fill the unexpired term ending October 2021 and that three names would need to be sent to the Governor's Office so that a selection could be made for the 2021-2024 term. Mr. Melton offered a motion, seconded by Sharyon Mayfield, to recommend submitting a letter to the Governor's office with the names of Mr. Melton, Mrs. Straughter, and Mr. Logan Hunt as candidates for the 2021-2024 term. The motion carried with the following votes:

The next item on the agenda was to consider job description and class changes for the Lincoln Parish Police Jury. Mr. Postel gave an overview of the item, stating that in November of 2020 the Personnel/Payroll Officer, Ms. LaTonya Lacey came to the Jury with revised job descriptions. He noted that Ms. Lacey sat with the superintendents and updated the job descriptions based on current performance and as a result some of the classifications changed as well as commensurate changes in pay.

Ms. Lacey stated the following changes would take place as of January 1, 2022:

- 1. Overall:
  - a. Job descriptions now list several items at the top of the description including: pay classification, category, FLSA status, occupation code, and work schedule (hours, on call, etc.)
- 2. Administration:
  - a. Clerical Changes: Secretary is now Administrative Assistant
  - b. Purchasing Agent: Homeland Security duties added

- c. Executive Administrative Assistant: Will help coordinate and create media outreach as needed.
- d. Financial Manager Position: Range Minimum R21 for \$51,480
- 3. Courthouse Maintenance:
  - a. Removed Housekeeping Supervisor
- 4. Lincoln Parish Park:
  - a. Change Landscaper with Maintenance
  - b. Designate Lifeguard Supervisor I and Lifeguard Supervisor II classifications.
  - c. Move Security Guards to different ranges on the pay scale, from R6 to R10.
  - d. Move Lifeguard Supervisor to different ranges on the pay scale, from R6 to R10.
  - e. Assistant Park Director supervisory experience changed from 5 years to 3 years; this change was to attract and retain employees.
- 5. Solid Waste Disposal:
  - a. Job Descriptions did not change but the Superintendent asked to adjust their range on the pay scale, each job description was moved up one range.
- 6. Solid Waste Collection:
  - a. Job Descriptions did not change but the Superintendent asked to adjust their range on the pay scale, each job description was moved up one range.
- 7. Highway Department:
  - a. Updates to individual job descriptions include duties, qualification and equipment updates.
  - b. Foremen were moved to difference ranges on the pay scale, from R12 to R16.

Ms. Lacey then went over the budget summary included for estimated cost changes for each department from 2021 to 2022 should the changes be approved. After discussion, TJ Cranford offered a motion, seconded by Sharyon Mayfield, to recommend approving the changes to the job descriptions and class changes for the Lincoln Parish Police Jury. The motion carried with the following votes:

Cranford, District Four; Logan Hunt, District Five; Glenn Scriber, District Six; Matt Pullin, District Seven; Skip Russell, District Eight; Milton Melton, District Ten; Sharyon Mayfield, District Eleven.

ABSENT: Joe Henderson, District Nine; and Annette Straughter, District Twelve.

Richard Durrett called the meeting to order and Glenn Scriber delivered the invocation and led the Pledge of Allegiance.

Item seven on the agenda was to adopt a resolution authorizing the president to enter into a contract with Strategic Demographics, LLC for services pertaining to reapportionment. Mr. Postel stated that this is a reapportionment year and that census numbers should be released within the next week. Mr. Durrett, Mr. Melton, Mr. Hunt, and Mr. Postel have interviewed two companies and selected the proposal of Strategic Demographics, LLC. This proposal was considerably lower than the other received, it was for \$16,000.00 with a \$3,000.00 discount for working with the Lincoln Parish School Board. For reference, the other proposal received was for \$25,000.00 with a \$1,000.00 discount for working with the Lincoln Parish School Board. Mr. Postel recommended contracting with Mr. Bill Blair and Strategic Demographics for Reapportionment services. Glenn Scriber offered a motion, seconded by Logan Hunt, to adopt a resolution authorizing the President to enter into a contract with Strategic Demographics, LLC for services pertaining to reapportionment.

#### **RESOLUTION 21-30**

Resolution of the Lincoln Parish Police Jury authorizing and directing the President to execute a contract with Strategic Demographics, LLC to provide reapportionment and redistricting services to the Lincoln Parish Police Jury.

**WHEREFORE**, Pursuant to the United States Constitution and federal law, there is conducted a decennial census of the population of the United States;

**WHEREFORE**, the most recent federal decennial census was conducted in 2020 and the results thereof will be released in 2021;

**WHEREFORE**, Louisiana law mandates that the Lincoln Parish Police Jury consider the impact of the federal decennial census on its election districts to determine whether the relative populations of those election districts are in accordance with the principals of one person one vote set forth in the United States Constitution;

**WHEREFORE**, in order to accomplish this obligation, the Lincoln Parish Police Jury requires the assistance of professionals in demographics, reapportionment and redistricting;

WHEREFORE, Strategic Demographics, LLC, through its principals and subcontractors has extensive experience in demographics, reapportionment and redistricting, including experience following the 2000 and 2010 census;

**WHEREFORE**, Strategic Demographics, LLC has submitted a proposed Contract for Demographic Services, a copy of which is attached hereto;

**NOW, THEREFORE BE IT RESOLVED** that the Lincoln Parish Police Jury authorizes and directs its duly elected President to execute the Contract for Demographic Services with Strategic Demographics, LLC.

**BE IT FURTHER RESOLVED** that the Lincoln Parish Police Jury authorizes and directs the administrative staff to take all actions necessary to carry out the Contract for Demographic Services with Strategic Demographics, LLC;

**BE IT FINALLY RESOLVED** that the Lincoln Parish Police Jury directs the Secretary to forward an executed copy of this Resolution and the attached Contract for Demographics Services to Strategic Demographic, LLC.

WHEREAS, the cost of healthcare is increasingly expensive;

WHEREAS, the assessment will result in an increase of the federal matching funds to be used to pay healthcare costs;

WHEREAS, those local hospitals that will pay the assessments are in support of the Program; and

#### BY REPRESENTATIVE MCMAHEN AND SENATORS JOHNS AND FRED MILLS

AN ACT to enact Subpart D-1 of Part I of Chapter 5–E of Title 40 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 40:1248.1 through 1248.12, relative to financing by the state Medicaid program of health services in certain parishes; to create and provide for a local healthcare provider participation program; to designate the parishes in which the program may be operated; to authorize local hospital assessment payments to be made to those parishes; to authorize the establishment of special provider participation funds by those parishes; to provide requirements for the uses of monies in such special funds; to require public hearings concerning local hospital assessment payments and uses of monies derived from such payments; to authorize rural institutional provider and governmental institutional provider payment methodologies contingent upon federal approval; to provide for administrative rulemaking by the Louisiana Department of Health; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. Subpart D-1 of Part I of Chapter 5–E of Title 40 of the Louisiana Revised Statutes of 1950, comprised of R.S. 40:1248.1 through 1248.12, is hereby enacted to read as follows:

#### SUBPART D-1. LOCAL HEALTHCARE PROVIDER PARTICIPATION PROGRAM

# § 1248.1. Definitions

As used in this Subpart, the following terms have the meaning ascribed to them in this Section:

- (1) "Department" means the Louisiana Department of Health.
- (2) "Governmental institutional provider" means either of the following:
- (a) A nonstate governmental hospital, licensed in accordance with the Hospital Licensing Law, R.S. 40:2100 et seq., other than a rural hospital as defined in R.S. 40:1189.3.
- (b) A hospital included in the definition of public, nonrural community hospital as defined in the Louisiana Medicaid State Plan.
- (3) "Institutional provider" means a nongovernmental hospital licensed in accordance with the Hospital Licensing Law, R.S. 40:2100 et seq.
- (4) "Paying hospital" means an institutional provider required by the provisions of this Subpart to make a local hospital assessment payment.
- (5) "Program" means the local healthcare provider participation program authorized by this Subpart.
- (6) "Rural institutional provider" means a hospital, other than one defined in R.S. 40:1189.3, that is licensed by the department, has no more than sixty hospital beds on November 1, 2020, and meets any of the following criteria:
- (a) Is located in a municipality with a population of not less than seven thousand persons and not more than seven thousand five hundred persons according to the most recent federal decennial census and in a parish with a population of not less than thirty thousand persons and not more than thirty-five thousand persons according to the most recent federal decennial census.
- (b) Is located in a municipality with a population of not less than ten thousand persons and not more than ten thousand five hundred persons according to the most recent federal decennial census and in a parish with a population of not less than eighty thousand persons and not more than ninety thousand persons according to the most recent federal decennial census.
- (c) Is located in a municipality with a population of not less than three thousand persons and not more than three thousand five hundred persons according to the most recent federal decennial census and in a parish with a population of not less than thirty thousand persons and not more than thirty-five thousand persons according to the most recent federal decennial census.

#### § 1248.2. Purpose

The purpose of this Subpart is to generate revenue by collecting from certain institutional providers a local hospital assessment payment to be used to provide the nonfederal share of a Medicaid payment program directly benefitting the residents of a parish.

#### § 1248.3. Applicability

The provisions of this Subpart shall apply exclusively to the following parishes:

- (1) Any parish with a population of not less than forty thousand persons and not more than forty-two thousand persons according to the most recent federal decennial census.
- (2) Any parish with a population of not less than forty-six thousand persons and not more than forty-seven thousand persons according to the most recent federal decennial census.
- (3) Any parish in which a rural institutional provider is located.

§ 1248.4. Parish healthcare provider participation program A. The legislature hereby creates a local healthcare provider participation program through which a parish may deposit in a local provider participation fund established by the parish all of the following monies:

- (1) Any local hospital assessment payment from an institutional provider located in the parish.
- (2) Such other sums as the parish deems appropriate.
- B. Monies in the provider participation fund may be used by the parish to fund certain intergovernmental transfers and indigent care programs as provided by this Subpart.
- C. A parish may adopt an ordinance authorizing it to participate in the program, subject to the limitations provided in this Subpart.
- D. Any parishes authorized by R.S. 40:1248.3 to establish a local provider participation fund may, upon agreement of the governing authorities of each

parish, establish a single fund for the benefit of those parishes and a local hospital assessment applicable to the institutional providers in those parishes.

# § 1248.5. Powers and duties of parishes; limitations; inspection of provider records

- A. The governing body of a parish may require a local hospital assessment payment authorized by this Subpart from an institutional provider in the parish. The requirement for payment shall be implemented in the manner provided for in this Section.
- B. A parish may authorize the collection of a local hospital assessment payment authorized by this Subpart only with an affirmative vote of a majority of the members of the governing body of the parish made at a regular or special meeting held no less than thirty days following publication of a notice in the official journal of the parish of intention to authorize the collection of such payment.
- C. (1) A parish that collects a local hospital assessment payment authorized by this Subpart shall require each institutional provider to submit to the parish a copy of any financial and utilization data required by and reported to the department.
- (2) A parish that collects a local hospital assessment payment authorized by this Subpart may inspect the records of an institutional provider to the extent necessary to ensure compliance with the requirements of Paragraph (1) of this Subsection.

#### § 1248.6. Public hearings

- A. Any parish that collects a local hospital assessment payment authorized by this Subpart shall hold an annual public hearing on the amounts of any local hospital assessment payments that the parish intends to require during the year and how the revenue derived from those payments is to be spent.
- B. Not later than the tenth day before the date of the hearing required by Subsection A of this Section, the parish governing authority shall publish notice of the hearing in the official journal of the parish. A representative of a paying hospital shall be entitled to appear at the time and place designated in the public notice and to be heard regarding any matter related to the local hospital assessment payments authorized by this Subpart.

# § 1248.7. Local provider participation fund; authorized uses

- A. Each parish that collects a local hospital assessment payment authorized by this Subpart or in which a rural institutional provider is located shall create a local provider participation fund. All income received by a parish pursuant to the provisions of this Subpart, including the revenue from local hospital assessment payments remaining after discounts and fees for assessing and collecting the payments are deducted, shall be deposited in the local provider participation fund of the parish. Monies in the fund may be withdrawn only in accordance with and for purposes specified in the provisions of this Section.
- B. The local provider participation fund of a parish shall consist of the following monies:
- (1) All revenue received by the parish attributable to local hospital assessment payments authorized by this Subpart, including any penalties and interest attributable to delinquent payments.
- (2) Monies received from the department as a refund of an intergovernmental transfer from the parish to the state for the purpose of providing the nonfederal share of Medicaid base rate payments, provided that the intergovernmental transfer does not receive a federal matching payment.
- (3) Sums which the parish elects to deposit.
- (4) The earnings of the fund.
- C. Monies in the local provider participation fund may be used only for one or more of the following purposes:
- (1) To fund intergovernmental transfers from a parish to the state to provide the nonfederal share of a program of Medicaid payments for the benefit of rural institutional providers or other hospitals in the parish authorized under the Medicaid state plan.
- (2) To pay the administrative expenses of a parish associated exclusively with activities authorized by this Subpart in an amount not to exceed five percent of the local hospital assessment payment.
- (3) To refund a portion of a local hospital assessment payment collected in error from a paying hospital.
- (4) To refund to paying hospitals the proportionate share of money received by a parish from the department that is not used to fund the nonfederal share of Medicaid payment program payments described in Paragraph (1) of this Subsection.

D. Money in the local provider participation fund shall not be commingled with other parish funds.

§ 1248.8. Local hospital assessment payments; basis; calculation A. Except as provided in Subsection E of this Section, a parish that collects a local hospital assessment payment authorized by this Subpart may require an annual local hospital assessment payment to be assessed quarterly on the net patient revenue of each institutional provider located in the parish. In the first year in which the local hospital assessment payment is required, the local hospital assessment payment shall be assessed on the net patient revenue of an institutional

assessment payment shall be assessed on the net patient revenue of an institutional provider as determined by the most recently filed Medicaid cost report. The parish shall update the amount of the local hospital assessment payment on an annual basis.

B. The amount of a local hospital assessment payment authorized by this Subpart shall be uniformly proportionate with the amount of net patient revenue generated by each paying hospital in the parish. In accordance with 42 U.S.C. 1396b(w), a local hospital assessment payment authorized by this Subpart shall not hold harmless any institutional provider.

C. A parish that collects a local hospital assessment payment authorized by this Subpart shall set the amount of the local hospital assessment payment. The amount of the local hospital assessment payment required of each paying hospital may not exceed an amount that, when added to the amount of the local hospital assessment payments required from all other paying hospitals in the parish, and the amount of any assessment, local hospital assessment payment, or tax imposed by the state, equals an amount of revenue that exceeds six percent of the aggregate net patient revenue of all paying hospitals in the parish.

D. Subject to the maximum payment amount prescribed in Subsection C of this Section, a parish that collects a local hospital assessment payment authorized by this Subpart shall set local hospital assessment payments in amounts that in the aggregate will generate sufficient revenue to cover the administrative expenses of the parish for activities provided for in this Subpart and to fund the nonfederal share of a Medicaid base rate payment; except that the amount of revenue from local hospital assessment payments used for administrative expenses of the parish for activities provided for in this Subpart in a year may not exceed five percent of the total revenue generated from the local hospital assessment payment or twenty thousand dollars, whichever is greater.

E. A paying hospital may not add a local hospital assessment payment required by this Section as a surcharge to a patient.

§ 1248.9. Local hospital assessment payments; collection

The sheriff of a parish shall collect the local hospital assessment payment authorized by this Subpart. The sheriff shall charge and deduct from local hospital assessment payments collected for the parish a fee for collecting those payments in an amount determined by the parish. The fee shall not exceed the usual and customary charges imposed by the sheriff.

§ 1248.10. Eligibility of funds for federal match; conformance with requirements of federal Medicaid agency

To the extent that any provision of this Subpart or procedure established in accordance with this Subpart causes a local hospital assessment payment authorized by this Subpart to be ineligible for federal matching funds, the parish may provide by rule for an alternative provision or procedure that conforms to the requirements of the Centers for Medicare and Medicaid Services.

§ 1248.11. Rural institutional providers; enhanced reimbursement A. Upon request from a parish in which a rural institutional provider is located, the department shall attempt in good faith to execute a cooperative endeavor agreement for the use of local provider participation fund proceeds. Notwithstanding any law to the contrary, by September 1, 2020, or as soon thereafter as such a cooperative endeavor agreement is effective, the department shall file a Medicaid state plan amendment with the Centers for Medicare and Medicaid Services, referred to hereafter in this Section as "CMS", amending the Medicaid state plan provisions governing hospital reimbursement to provide that a rural institutional provider, as defined in R.S. 40:1248.1, shall be reimbursed at a rate which equals or approximates one hundred ten percent, or, if a reduction is required by CMS, the maximum amount acceptable to CMS, but in no case less than one hundred percent, of the appropriate reasonable cost of providing hospital inpatient and outpatient services, including but not limited to services provided in a rural health clinic licensed as part of a rural hospital. The new rural hospital payment methodology shall utilize prospective rates approximating costs at the time of service for inpatient acute care and psychiatric services. To ensure that rural hospital outpatient services, including those reimbursed on a cost basis and those reimbursed on a fee schedule, are reimbursed in the aggregate at one hundred ten percent of the reasonable costs or such lesser amounts as approved by CMS, but in no case less than one hundred percent of their reasonable costs, the department shall pay an interim rate for cost-based outpatient services at one hundred ten percent of reasonable cost during the year and for fee-based services paid on a claim-by-claim basis, and the department shall make quarterly estimates of Medicaid base rate payments required to bring reimbursement to the hospital for such services up to one hundred percent of reasonable costs and immediately remit such payments to the hospital, and at final settlement pay such amounts as are necessary to ensure that all outpatient services in the aggregate, both cost-based and fee schedule, are paid at one hundred ten percent of reasonable costs.

B. The rural institutional provider payment methodology provided for in this Subpart shall be implemented on January 1, 2021, or as soon thereafter as is practicable after such methodology is authorized by federal law.

# << LA R.S. 40:1248.12 >>

§ 1248.12. Governmental institutional providers; enhanced reimbursement A. Upon request from a parish in which a governmental institutional provider is located, the department shall attempt in good faith to execute a cooperative endeavor agreement acceptable to the department. Notwithstanding any law to the contrary, by September 1, 2020, or as soon thereafter as such a cooperative endeavor agreement is effective, the department shall file a Medicaid state plan amendment with the Centers for Medicare and Medicaid Services, referred to hereafter in this Section as "CMS", amending the Medicaid state plan provisions governing hospital reimbursement to provide that a governmental institutional provider, as defined in R.S. 40:1248.1, shall be reimbursed at a rate which equals or approximates one hundred ten percent, or, if a reduction is required by CMS, the maximum amount acceptable to CMS, but in no case less than one hundred percent, of the appropriate reasonable cost of providing hospital inpatient and outpatient services, including but not limited to services provided in a rural health clinic licensed as part of a governmental institutional provider. The new governmental institutional provider payment methodology shall prospective rates approximating costs at the time of service for inpatient acute care and psychiatric services. To ensure that governmental institutional provider outpatient services, including those reimbursed on a cost basis and those reimbursed on a fee schedule, are reimbursed in the aggregate at one hundred ten percent of the reasonable costs or such lesser amounts as approved by CMS, but in no case less than one hundred percent of their reasonable costs, the department shall pay an interim rate for cost-based outpatient services at one hundred ten percent of reasonable cost during the year and for fee-based services paid on a claim-by-claim basis, and the department shall make quarterly estimates of Medicaid base rate payments required to bring reimbursement to the governmental institutional provider for such services up to one hundred percent of reasonable costs and immediately remit such payments to the governmental institutional provider, and at final settlement pay such amounts as are necessary to ensure that all outpatient services in the aggregate, both cost-based and fee schedule, are paid at one hundred ten percent of reasonable costs.

B. The governmental institutional provider payment methodology provided for in this Subpart shall be implemented on January 1, 2021, or as soon thereafter as is practicable after the methodology is authorized by federal law.

On an expedited basis, the Louisiana Department of Health shall take all steps necessary and available to obtain approval from the Centers for Medicare and Medicaid Services for the state plan amendments provided for in R.S. 40:1248.11 and R.S. 40:1248.12, as enacted by Section 1 of this Act, and, immediately upon notification of such approval, promulgate administrative rules to implement the state plan amendment.

# CITIZEN PARTICIPATION PLAN

The Lincoln Parish Police Jury has adopted the following Citizen Participation Plan to meet the citizen participation requirements of Section 508 of the Housing and Community Development Act of 1974, as amended. The Lincoln Parish Police Jury is committed through adoption of this plan to full and total involvement of all residents of the community in the composition, implementation and assessment of its 2021 Community Development Block Grant Program and Community Development Block Grant Corona Virus Love Louisiana Outdoors Program. Attempts will be made to reach all citizens, with particular emphasis on participation by persons of low and moderate income, residents of slum and blighted areas and of areas in which funds are proposed to be used. A copy of this plan will be made available to the public upon request.

As part of the citizen participation requirements and to maximize citizen interaction, the Lincoln Parish Police Jury shall:

- 1) Provide citizens with reasonable and timely access to local meetings, information and records relating to the state's proposed method of distribution, as required by the Secretary, and relating to the actual use of funds under Title I of the Housing and Community Development Act of 1974, as amended;
- 2) Provide for public hearings to obtain views and respond to proposals and questions at all stages of the community development program. These hearings will consist of the development of needs and proposed activities and review of program performance. These hearings will be held after adequate notice, a minimum of five calendar days, at times and locations convenient to potential or actual beneficiaries with accommodations for persons with disabilities;
- 3) Provide for and encourage citizen participation with particular emphasis on participation by persons of low and moderate income who are residents of slum and blighted areas and of areas in which funds are proposed to be used;
- 4) Provide for technical assistance to groups representative of persons of low and moderate income that request such assistance in developing proposals;
- 5) Where applicable, identify how the needs of non-English speaking residents will be met in the case of public hearings; and
- 6) Provide for a formal written procedure which will accommodate a timely written response, within fifteen days where practicable, to written complaints and grievances.

Written minutes of the hearings and an attendance roster will be maintained by the Lincoln Parish Police Jury.

# **PUBLIC HEARINGS**

Notices informing citizens of any public hearings will be posted on the door of the official meeting place of the Lincoln Parish Police Jury a minimum of five calendar days prior to the hearing. In addition, notices will also be posted in (Town office buildings/town hall) and the hearing will be publicized through local community organizations, i.e., churches, clubs, etc., and/or dissemination of leaflets in the target area. Hearings will be held at times and locations convenient to potential or actual beneficiaries with accommodations for individuals with disabilities and non-English speaking persons.

Whenever possible these hearings will be held within or near the target areas, at times affording participation by the most affected residents.

## I. APPLICATION

# First Notice/Public Hearing

The public hearing to address 2022/2023 Community Development Block Grant Program and Community Development Block Grant Corona Virus Love Louisiana Outdoors Program application submittal will be held approximately seven calendar days prior to the deadline for submission of the application for the current funding cycle. The Citizen Participation Plan will be available at the hearing. The public notice for this hearing will state that the following will be discussed:

- a) The amount of funds available for proposed community development;
- b) The range of activities that may be undertaken, including the estimated amount proposed to be used for activities that will benefit persons of low and moderate income;
- c) The plans of the Lincoln Parish Police Jury for minimizing displacement of persons as a result of activities assisted with such funds and the benefits to be provided by the Lincoln Parish Police Jury to persons actually displaced as a result of such activities; and
- d) The Lincoln Parish Police Jury prior performance of LCDBG programs funded by the State of Louisiana. In addition, the notice shall state that all citizens, particularly low and moderate income residents of slum and blighted areas, are encouraged to submit their views and proposals regarding community development and housing needs. Those citizens unable to attend this hearing may submit their views and proposals to:

The notice will also state that accommodations will be made for disabled and non-English speaking individuals provided a three day notice is received by the Lincoln Parish Police Jury.

# **Second Notice**

Seven calendar days, at a minimum, prior to the deadline for submittal of the application, a second notice shall appear in the official journal informing the citizens of the following:

- a) Proposed submittal date of the application;
- b) Proposed objectives;
- c) Proposed activities;
- d) Location of proposed activities;
- e) Dollar amount of proposed activities; and
- f) Location and hours available for application review.

In addition, the notice shall state "all citizens, particularly those affected by the proposed project, are encouraged to review the proposed application and submit any written comments on the application to:"

Negative comments received will be forwarded to the state's Office of Community Development, Division of Administration or the application will be withdrawn if necessary.

## II. AMENDMENTS

Program amendments, which substantially alter the LCDBG project from that approved in the original application, shall not be submitted to the state without holding one public hearing in accordance with the procedures outlined within this Citizen Participation Plan. Minutes of the hearing will be submitted with the request for the amendment. All interested citizens, particularly the low and moderate income, elderly, handicapped, and residents of the project area, shall be made aware and have the opportunity to comment on proposed amendments and/or submit alternative measures.

# III. GRANTEE PERFORMANCE

The Lincoln Parish Police Jury will hold one performance hearing to solicit the public's opinion of the effectiveness of the LCDBG Program. The manner of notification will be the same as previously described for all public hearings. Notification will be made in the official journal approximately seven calendar days prior to the anticipated submittal of close-out documents to the state, and will indicate the date, time, and place of the performance hearing, and invite comments and opinions on the LCDBG activities implemented under the 2022/2023 Community Development Block Grant Program and Community Development Block Grant Corona Virus Love Louisiana Outdoors Program being closed out. The notice will also state that accommodations will be made for disabled and non-English speaking persons provided a day notice is received by the Lincoln Parish Police Jury.

This notice shall invite all interested parties, particularly those low to moderate income residents in the target area to attend.

The hearing will be held no sooner than five calendar days from the publication date of said notice.

## **CONSIDERATION OF OBJECTION TO APPLICATION**

Persons wishing to object to approval of an application by the state may make such objection known to:

- i. The application description of needs and objectives is plainly inconsistent with available facts and data;
- ii. The activities to be undertaken are plainly inappropriate to meeting the needs and objectives identified by the applicant; and
- iii. The application does not comply with the requirements set forth in the state's Annual Action Plan or other applicable laws.

Such objections should include both an identification of the requirements not met and, in the case of objections relative to (1) above, the complainant must supply the data upon which he/she relied upon to support his/her objection.

## **BILINGUAL**

Whenever a significant number of persons and/or residents of blighted neighborhoods communicate with a primary language other than English attend public hearings, the Lincoln Parish Police Jury will provide an interpreter for dissemination of information to them providing the Lincoln Parish Police Jury is given sufficient notification of 5 day(s).

#### TECHNICAL ASSISTANCE

Technical assistance may be provided directly by the Lincoln Parish Police Jury to any citizen, particularly to low and moderate income persons, residents of blighted neighborhoods and minorities, who request assistance in the development of proposals and statement of views concerning the LCDBG Program. The local officials, administrator and engineer will conduct informational meetings with the residents of the low to moderate income areas if a written request is received by the Lincoln Parish Police Jury with at least a one week notification. The person who conducts the technical assistance meetings will disseminate information on the program and answer all pertinent questions.

#### TIMELY ACCESS AND ADEQUATE INFORMATION

The Lincoln Parish Police Jury shall provide timely disclosure of records, information and documents related to the 2022/2023 Community Development Block Grant Program and Community Development Block Grant Corona Virus Love Louisiana Outdoors Program activities. Documents will be made available for copying upon request at the Lincoln Parish Police Jury. Such documents may include the following:

- 1) All meetings and promotional materials.
- 2) Records of hearings and meetings.
- 3) All key documents, including prior applications, letters, grant agreements, citizen participation plans, and proposed applications.
- 4) Copies of the regulations (final statements) concerning the program.
- 5) Documents regarding other important requirements, such as Procurement Procedures, Fair Housing, Equal Employment Opportunity, Uniform Act, Labor Provisions and Environmental Procedures.

# CITIZEN COMPLAINT PROCEDURE

## **SECTION 1**

It is the policy of the Lincoln Parish Police Jury to review all complaints received by the Lincoln Parish Police Jury.

# **SECTION 2**

The following procedures will be followed on all complaints received by the Lincoln Parish Police Jury:

1) The complainant shall notify the <u>Parish Administrator</u> of the complaint. The initial complaint may be expressed orally or by written correspondence.

2) The <u>Parish Administrator</u> will notify the President designated representative of the complaint within 5 working days.

3) The President designated representative will investigate the complaint and will report the findings to the <u>Parish Administrator</u> within 5working days.

4) The <u>Parish Administrator</u> will notify the complainant of the findings of the President designated representative in writing or by telephone within 10 working days.

5) If the complainant is aggrieved by the decision, he must forward the complaint in writing (if previously submitted orally) to the <u>Parish Administrator</u> who will forward the complaint and all actions taken by the President designated representative to the appropriate council committee for their review. This will be accomplished within 30 working days of receipt of the written complaint.

6) The reviewing council committee will have 10 working days to review the complaint and forward their decision to the complainant in writing.

7) If the complainant is aggrieved with the decision of the Committee, he must notify the <u>Parish Administrator</u> in writing that he desires to be afforded a hearing by the Lincoln Parish Police Jury. The complainant will be placed on the next regularly scheduled council meeting agenda. The <u>Parish Administrator</u> will notify the complainant in writing of the date of the hearing.

8) The complainant must bring all relevant data, witnesses, etc., to the hearing. The Lincoln Parish Police Jury, at the hearing, will review the complaint and forward within days a certified copy of the minutes of the meeting at which the hearing was conducted and a decision was rendered to the complainant. If a decision is not reached at the hearing, the <a href="President\_will-inform-complainant">President\_will-inform-complainant</a> of an appropriate date to expect a response. Within 15 working days of reaching a decision, the complainant will be notified in writing of the decision.

Complaints concerning the general administration of the LCDBG Program may be submitted in writing directly to the:

## **SECTION 3**

All citizen complaints relative to Fair Housing/Equal Opportunity violations alleging discrimination shall be forwarded for disposition to the:

The complainant will be notified in writing within 10 days that, due to the nature of the complaint, it has been forwarded to the Louisiana Department of Justice. ## **SECTION 4**

The Parish Administrator will maintain a file for the purpose of keeping reports of complaints.

## **SECTION 5**

This policy does not invalidate nor supersede the personnel or other policies of the Lincoln Parish Police Jury which are currently adopted, but is intended to serve as a guide for complaints.

## **SECTION 6**

This policy may be amended by a majority vote at any of the Lincoln Parish Police Jury regularly scheduled meetings.

**WHEREAS**, the Parish desires to enter into an agreement with Frye Magee LLC, to perform all administrative consulting services associates with the Application, which includes assistance with developing the Application, and thereafter performing all administrative consulting duties following a grant award; and,

**WHEREAS**, the Parish desires to enter into an agreement with The Riley Company, to perform all engineering consulting services associates with the Application, which includes assistance with developing the Application, and thereafter performing all engineering consulting services, including basic engineering design, surveying, project representation, construction phase services and any other engineering costs incurred by the Parish, following a grant award.

# NOW, THEREFORE, BE IT RESOLVED BY THE LINCOLN PARISH POLICE JURY:
