The Public Works Committee of the Lincoln Parish Police Jury met in the Police Jury Meeting Room, 100 West Texas Avenue, Ruston, Louisiana, Tuesday, June 10, 2025 at 5:30 p.m. Present were: Greg Williams, Chair, Dan Lord, T.J. Cranford, and Milton Melton

Chair Greg Williams called the meeting to order and Dan Lord delivered the Invocation.

Dan Lord offered a motion, seconded by Milton Melton, to approve the Agenda. The motion carried with the following votes:

Chair Williams called for Public Comments on Agenda Items. There were none.

First item on the Agenda was to consider, and take action if necessary, setting the speed limit on Rodgers Road. BE IT ORDAINED BY THE POLICE JURY OF LINCOLN PARISH, LOUISIANA, IN REGULAR SESSION CONVENED THIS 10th DAY OF JUNE, 2025:

SECTION 1

That the Code of Ordinances of the Parish of Lincoln, State of Louisiana, be amended by adding a section to be number 42-36 to read as follows:

Sec. 42-36 Speed Limits- Rodgers Road

“No motor vehicle, as defined by Louisiana law, shall be operated at a speed in excess of 45 miles per hour on Rodgers Road.”

SECTION 2

That the limit of speed referred to hereinabove shall be duly posted and displayed by means of appropriate highway speed limit signs.

SECTION 3

That all ordinances or parts of ordinances in conflict of this ordinance are hereby repealed.


