The Finance Committee of the Lincoln Parish Police Jury met in the Lincoln Parish Library Events Center, Tuesday, March 9, 2021, at 5:30 p.m. Present were: Skip Russell, Chair, Theresa Wyatt, Matt Pullin, Joe Henderson, and Sharyon Mayfield.

Skip Russell called the meeting to order and delivered the invocation.

Theresa Wyatt offered a motion, seconded by Sharyon Mayfield, to approve the agenda as presented. The motion carried with the following votes:

YEAS: Wyatt, Pullin, Russell, Henderson, and Mayfield

First item on the agenda was to discuss and take action, if necessary, budget amendment for the North Louisiana Exhibition Center roof. Doug Postel, Parish Administrator, noted that due to the hurricane there was significant damage that occurred at the Expo Center. It was also noted that in order to make repairs, an adjustment would need to be made to the Courthouse Capital budget. Mrs. Jeri Webb, Purchasing Officer, noted that the Police Jury would need to pay 10% of \$13,050.00 and FEMA would cover the rest. It was also noted that an additional 7,000 square feet of the damaged roof would need to be replaced which would cost \$45,029.00. Mrs. Webb also noted that the insurance company stated the damages were not a result of the hurricane and it would not cover the cost of repairs. After further discussion and questions, Joe Henderson offered a motion, seconded by Matt Pullin, to recommend approval of a budget amendment of \$46,334.00. This would increase the Courthouse Capital Budget from \$200,000.00 to \$246,334.00. After further questions, the motion carried with the following votes:

Next item on the agenda was to discuss and consider motion to advertise for bids for purchase of two live floor trailers for solid waste. Resolution 21-

A RESOLUTION IN OPPOSITION OF ALL PROPOSED LEGISLATION THAT TRANSFERS THE ADMINISTRATION AND COLLECTION OF LOCAL SALES & USE TAXES TO THE LOUISIANA DEPARTMENT OF REVENUE.

WHEREAS, the Constitution of the State of Louisiana grants local governments the right to levy and collect local sales and use taxes;

WHEREAS, there are several constitutional amendments and other bills introduced in the 2020 Regular Legislative Session that would transfer collection responsibility of local sales and use tax levies to the state Department of Revenue; and

WHEREAS, local taxing authorities possess the best knowledge and experience to properly collect its own taxes and have a proven record of proactive advancements in the areas of enforcement, audit coverage, dispute resolution, reporting technology and successful litigation; and

WHEREAS, the state of Louisiana's budget issues do not offer prospects for the Department of Revenue to have sufficient resources to provide the necessary taxpayer assistance, enforcement programs and training of its employees on the specific application or local sales and use tax ordinances without significant cost contributions from local governments, thereby resulting in the direct and indirect loss of local tax receipts; and

WHEREAS, many local taxing authorities have issued bonded indebtedness guaranteed by the passage locally adopted sales and use tax levies, collection of said levies the direct responsibility of local governments, and which transfer of that responsibility to a state agency may generate legal challenges and jeopardize future bond issues; and

WHEREAS, the central local collector in each parish is directly responsible to the local taxing authorities and their elected officials for the performance of local tax administration, and the Secretary Revenue being an appointee of the Governor of the state, uncertainty exists as to who in the Department of Revenue will be accountable to local taxing authorities for the performance of such critical local tax administration,

NOW THEREFORE, be it resolved that the members of the Lincoln Parish Police Jury, that each member of the legislative delegation for the Parish of Lincoln is urged to vigorously oppose any and all proposed legislation that transfers the administration and collection of local sales and use taxes to the Louisiana Department of Revenue; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent forthwith to said legislators so that they will be made aware of our position on this matter.

R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION (MILLAGE CONTINUATION)

Shall the Parish of Lincoln, State of Louisiana (the "Parish"), be authorized to levy and collect a special tax of four and forty-nine hundredths (4.49) mills on all property subject to taxation in Lincoln Parish (an estimated \$2,158,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2021 and ending with the year 2030, for the purpose of providing funds for equipment, supplies, maintenance, operation, construction and support of a public library and its branch or branches in the Parish?

SECTION 2. <u>Publication of Notice of Election</u>. A Notice of Special Election shall be published in *The Ruston Daily Leader*, a newspaper of general circulation within the Parish, published in Ruston, Louisiana, and being the official journal of the Parish, once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full.

Notwithstanding the foregoing, prior to the publication of the Notice of Election, the President is authorized and directed to make any amendments to the foregoing proposition that may be required to comply with any state or federal regulatory agencies.

SECTION 3. <u>Canvass</u>. This Governing Authority shall meet at its regular meeting place, the Police Jury Meeting Room, Third Floor, 100 West Texas Avenue, Ruston, Louisiana, on **TUESDAY**, **OCTOBER 12, 2021**, at **SEVEN O'CLOCK (7:00) P.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.

SECTION 4. <u>Polling Places</u>. The polling places for the precincts in the Parish are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. <u>Election Commissioners</u>; <u>Voting Machines</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held as provided in Section 3 hereof. All registered voters in the Parish will be entitled to vote at the special election, and voting machines shall be used.

SECTION 6. <u>Authorization of Officers</u>. The Parish Administrator of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the President and/or Parish Administrator of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election.

SECTION 7. <u>Furnishing Election Call to Election Officials</u>. Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines of Lincoln Parish and the Registrar of Voters of Lincoln Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. <u>Application to State Bond Commission</u>. BE IT KNOWN, that on the dates herein after mentioned, before the undersigned authorities, and in the presence of the undersigned legal and competent witnesses, personally came and appeared:

LINCOLN APRISH POLICE JURY (TIN: 72-6000673), a political subdivision of the State of Louisiana, domiciled in Lincoln Parish, Louisiana, appearing herein by and through its duly authorized President <u>Richard I. Durrett</u> (hereinafter sometimes referred to as "POLICE JURY")

and

4 PAWS RESCUE INC. (TIN: ________), a Louisiana Corporation, domiciled in Lincoln Parish, Louisiana, appearing herein by and through its duly authorized President, Sue Martin (hereinafter sometimes referred to as "4 PAWS")

who after being duly sworn did depose and state that:

WHEREAS, LSA-R.S. 3:2771 provides that "no person shall suffer or permit any dog in his possession, or kept by him about his premises, to run at large on any unenclosed land, or trespass upon any enclosed or unenclosed lands of another."

WHEREAS, LSA-R.S. 3:3774 also provides that "each parish shall provide suitable shelters or facilities for dogs seized under the provisions of this Part."

WHEREAS, although the State of Louisiana has mandated that each parish provide suitable shelters or facilities for dogs seized for running at large, it has failed to provide adequate funding to each parish to accomplish said mandate.

WHEREAS, parishes are authorized to contract with third parties for providing shelters or facilities for dogs seized for running at large, and

WHEREAS, Article VI, Section 20 and Article VII, Section 14 of the Constitution of the United State of Louisiana provides that "for a public purpose, the state and its political subdivisions may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual;" and

THEREFORE, in accordance with the provisions of Article VI, Section 20 and VII, Section 14 of the Louisiana Constitution and LSA-R.S. 33:1321 et seq. (Local Services Law) the parties enter into the Cooperative Endeavor Agreement, the terms and conditions of which are more fully set forth hereinafter.

TERM

The term of this Cooperative Endeavor Agreement shall be for a period of one (1) year, beginning January 1, 2021 and ending December 31, 2021.

CONSIDERATION

For and in consideration of the services to be provided by 4 PAWS, POLICE JURY agrees to pay the sum of Two Thousand (\$2,000.00) per calendar month to 4 PAWS. POLICE JURY farther represents and acknowledges that the value to the citizens of Lincoln Parish of having 4 PAWS provide animal shelter services is commensurate with the value provided.

OBLIGATIONS OF 4 PAWS

4 PAWS shall be responsible for providing a shelter for dogs and cats seized for running at large in Lincoln Parish and to maintain and operate said shelter.

INDEMNIFICATION AND HOLD HARMLESS

4 PAWS agrees to indemnify and hold POLICE JURY harmless from any and all liability of whatever nature and kind arising out of or in any way connected with the use of the property by 4 PAWS or of the general public utilizing the animal shelter contemplated herein, except for such liability resulting from the negligence of POLICE JURY, its agents or employees.

ASSIGNMENT OR TRANSFER OF RIGHTS

4 PAWS shall have no right to assign or in any way transfer its rights under this agreement without obtaining written permission to do so from POLICE JURY.

RESOLUTION 21-

To create the Lincoln Parish Broadband Commission to study the current impediments to rural access to broadband service, to devise solutions to achieve parishwide access to broadband high-speed internet service, and to seek funding sources for such access.

- WHEREAS, in the modern economy, rural broadband is a lifeline to quality of life and economic opportunity; and
- WHEREAS, while broadband high-speed internet service is abundantly available in Louisiana cities, it is woefully absent in the rural areas of the state; and
- WHEREAS, according to the federal government, eighty percent of the twenty-four million American households who lack reliable, affordable, high-speed internet are in rural areas; and
- WHEREAS, the federal government, though various agencies, is currently making investments in broadband infrastructures to help transform rural America, providing innovation and technology to increase economic competitiveness and opportunities; and
- WHEREAS, the federal government currently provides loans and grants to increase high-speed internet access in rural areas; and
- WHEREAS, the Lincoln Parish Police Jury supports Federal and State efforts to expand rural broadband service; and
- WHEREAS, a commission to study and seek solutions concerning rural access to broadband service would be the best way to obtain funding for achieving parishwide access to high-speed internet broadband service.
- THEREFORE BE IT RESOLVED, that the Lincoln Parish Police Jury hereby creates the Lincoln Parish Broadband Commission to study the current impediments to rural access to broadband service in Lincoln Parish, to devise solutions to achieve parishwide access to high-speed internet broadband service, and to seek funding sources for such access.

BE IT FURTHER RESOLVED that the task force shall be comprised of the following members:

- 1. The Lincoln Parish Sheriff or his/her designee
- 2. The Lincoln Parish School Board Superintendent or his/her designee
- 3. One representative from rural private or charter schools
- 4. The President of Grambling State University or his/her designee
- 5. The President of Louisiana Tech University or his/her designee
- 6. One representative of rural healthcare providers
- 7. One representative from the Grambling Chamber of Commerce
- 8. The Mayor of the City of Ruston or his/her designee
- 9. One representative of rural Lincoln Parish municipality mayors
- 10. One representative from the agriculture industry
- 11. One representative from the forestry industry
- 12. One representative from rural utility providers
- 13. One representative from minority business owners
- 14. One representative from faith-based organizations

BE IT FURTHER RESOLVED that task force members shall serve without compensation or reimbursement of expense.
